Rapid Housing Initiative Program

Round 1

- \$500M for Cities stream (15 municipalities)
- \$500M for Projects stream
- More than 4,700 units across Canada

Round 3

- \$500M for Cities stream (41 municipalities)
- \$1B for Projects stream
- Goal of 4,500 units across Canada

Round 2

- \$500M for Cities stream (30 municipalities)
- \$1B for Projects stream
- Expected more than 5,400 units across Canada

Round 3 Approach

- Work with Calgary's non-profit housing community to deliver new housing to Calgarians.
- Calgary's Cities stream funding allocation: \$15.7M
- Minimum unit target: 57 units
- Proposing City funding support under both streams
