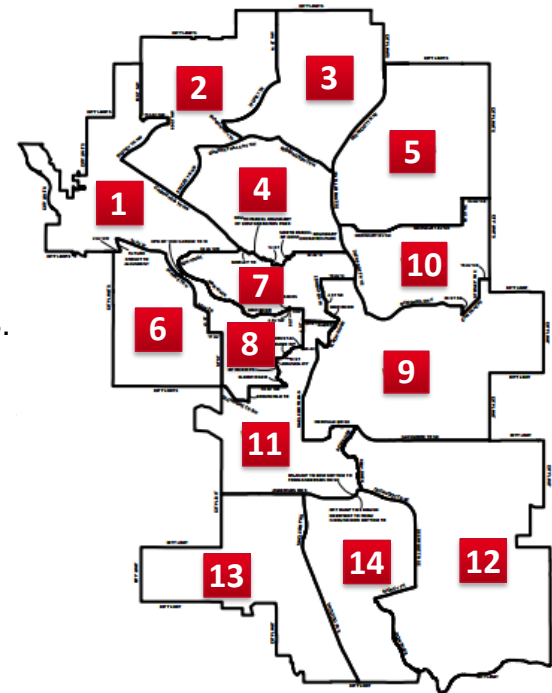

Respondent Profile

Methodology

- ❖ Telephone survey conducted with a randomly selected sample of 2,500 Calgarians aged 18 years and older between August 15th and September 12th, 2018.
 - Both landline (60%) and cell phone (40%) sample were used.
 - The average interview length was 32 minutes.
- ❖ Final data were weighted to ensure the overall sample's quadrant, ward, and age/gender composition reflects that of the actual Calgary population aged 18 or older according to 2016 Municipal and Federal Census data.
- ❖ The margin of error (MOE) for the total sample of 2,500 is ± 2.0 percentage points, 19 times out of 20.
 - A total of 182 interviews were conducted with residents of Ward 8 (MOE ± 7.3).
- ❖ Research Note on significant differences.
 - Throughout, City Wide results are compared to results from Ward 8.
 - \uparrow indicates a number is significantly higher than City Wide.
 - \downarrow indicates a number is significantly lower than City Wide.
- ❖ Where possible, 2018 results for Ward 8 are compared to those from 2017.
 - Only significant differences are shown.





Summary of Key Findings



Key Findings: Quality of Life

Ward 8 residents rate quality of life similar to City Wide residents, and there is a stronger sense that Calgary is on the right track compared to one year ago.

- ❖ Over eight-in-ten (87%) Ward 8 residents say the quality of life in Calgary today is ‘good,’ statistically consistent with 86% City Wide.
- ❖ One-half (51%) of Ward 8 residents say the quality of life in Calgary has stayed the same over the past three years (on par with 49% City Wide), while 26% say it has improved (on par with 22% City Wide), and 23% say it has worsened (on par with 29% City Wide).
- ❖ Ward 8 residents note a marked top box improvement in perceptions about inclusivity from The City of Calgary and are more positive about Calgary’s long-term direction.
 - One-in-five (22%) of Ward 8 residents *completely* agree The City of Calgary municipal government fosters a city that is inclusive and accepting of all 12 points higher than 10% in 2017
 - Agreement that The City of Calgary is on the right track to be a better city 10 years from now (85%) is on par with City Wide (84%).
 - The percentage of Ward 8 residents who *strongly* agree with the statement has increased by 14 points (36% vs 22% in 2017).
- ❖ Perceived safety is notably lower than City Wide.
 - Roughly seven-in-ten (72%) Ward 8 residents say they would feel safe walking alone in their neighbourhood after dark – a significant 10 percentage points lower than City Wide (82%).

Key Findings: Issue Agenda and Level and Quality of Services and Programs

The Ward 8 issue agenda places higher emphasis than City Wide on transit, homelessness, poverty, & affordable housing, and growth and planning.

The top issues in Ward 8 are "*infrastructure, traffic and roads*" (40%, on par with 40% City Wide), "*transit*" (23%, significantly higher than 16% City Wide) and "*crime, safety and policing*" (17%, on par with 14% City Wide).

- ❖ Ward 8 residents are more likely than City Wide to mention "*homelessness, poverty, & affordable housing*" (12% vs. 5% City Wide) and "*growth & planning*" (10% vs. 4% City Wide)
- ❖ Mentions of "*transit*" have increased by 10 points from 2017 (23% vs. 13% in 2017) and mentions of the "*economy*" have decreased by 11 points from 2017 (1% vs. 12% in 2017).

Overall satisfaction with the level and quality of City services is the same as City Wide results.

- ❖ Nearly eight-in-ten (77%) Ward 8 residents say they are satisfied with the overall level and quality of services and programs provided by The City – identical to 77% City Wide.

Key Findings: City Programs and Services

Ward 8 residents differ from City Wide residents results and also show shifts from 2017 with respect to the importance, satisfaction and desired investment in several services.

- ❖ Ward 8 residents are more likely to rate several services as *very important* compared to 2017, especially:
 - Road maintenance including pothole repairs: 74% rate as *very important* (21 points higher than 53% in 2017).
 - Snow removal: 80% rate as *very important* (12 points higher than 68% in 2017).
 - Transportation planning: 83% rate as *very important* (10 points higher than 73% in 2017).
- ❖ Ward 8 residents stand out from City Wide by placing more importance on two city services.
 - Downtown revitalization: 87% rate as *very/somewhat* important (7 points higher than 80% City Wide).
 - Calgary's pathway system: 98% rate as *very/somewhat* important (6 points higher than 92% City Wide).
- ❖ Satisfaction has decreased in Ward 8 with three services compared to 2017.
 - Snow removal: 67% are satisfied (15 points lower than 82% in 2017).
 - Calgary Transit including bus and CTrain service: 77% are satisfied (11 points lower than 88% in 2017).
 - Property tax assessment: 74% are satisfied (10 points lower than 84% in 2017).
- ❖ Ward 8 residents are more likely to be *very satisfied* with several services, especially:
 - Bylaw services for things such as noise complaints, fire pits and weeds: 43% are *very satisfied* (12 points higher than 31% City Wide).
 - Calgary's parks, playgrounds and other open spaces: 63% are *very satisfied* (10 points higher than 53% City Wide).
 - Calgary's pathway system: 60% are *very satisfied* (11 points higher than 49% City Wide).

Key Findings: City Programs and Services (continued)

- ❖ Ward 8 residents are more likely than City Wide to want to see *more* investment in the following services:
 - Downtown revitalization: 44% want *more* investment (13 points higher than 31% City Wide).
 - On-street bikeways: 32% want *more* investment (11 points higher than 21% City Wide).
- ❖ Ward 8 residents are more likely than 2017 to want to see *more* investment in the following services:
 - Road maintenance including pothole repairs: 60% want *more* investment (18 points higher than 42% in 2017).
 - Snow removal: 58% want *more* investment (22 points higher than 36% in 2017).
 - Social services for individuals such as seniors or youth: 60% want *more* investment (12 points higher than 48% in 2017).

Key Findings: Taxation and Customer Service

Ward 8 residents' views on taxation are consistent with City Wide.

- ❖ Two-thirds (65%) of Ward 8 residents give The City a 'good value' rating for the value of their property tax dollars (on par with 59% City Wide).
- ❖ Just less than six-in-ten (58%) of Ward 8 residents support tax increases to maintain or expand services (on par with 52% City Wide), while 37% support cutting services to maintain or reduce taxes (on par with 43% City Wide).

City contact and customer service metrics are generally consistent with City Wide results.

- ❖ Ward 8 residents are aligned with City Wide results for contacting The City in the past 12 months (68%, on par with 65% City Wide) and for satisfaction with the level of overall quality and satisfaction provided (82%, on par with 78% City Wide).

Key Findings: Communications, City Reputation and Performance

Overall perceptions of City information and communications are consistent with City Wide results.

- ❖ Satisfaction with the overall quality of City information and communications is comparable to City Wide (81%, on par with 80% City Wide).

Measures of The City's reputation are on par with City Wide results.

- ❖ Ward 8 results are on par with City Wide results for favourability (72% vs. 68% City Wide), trust (67% vs. 60% City Wide) and being advocates (37% vs. 34% City Wide).

Assessments of the performance of Council and Administration are consistent with City Wide results.

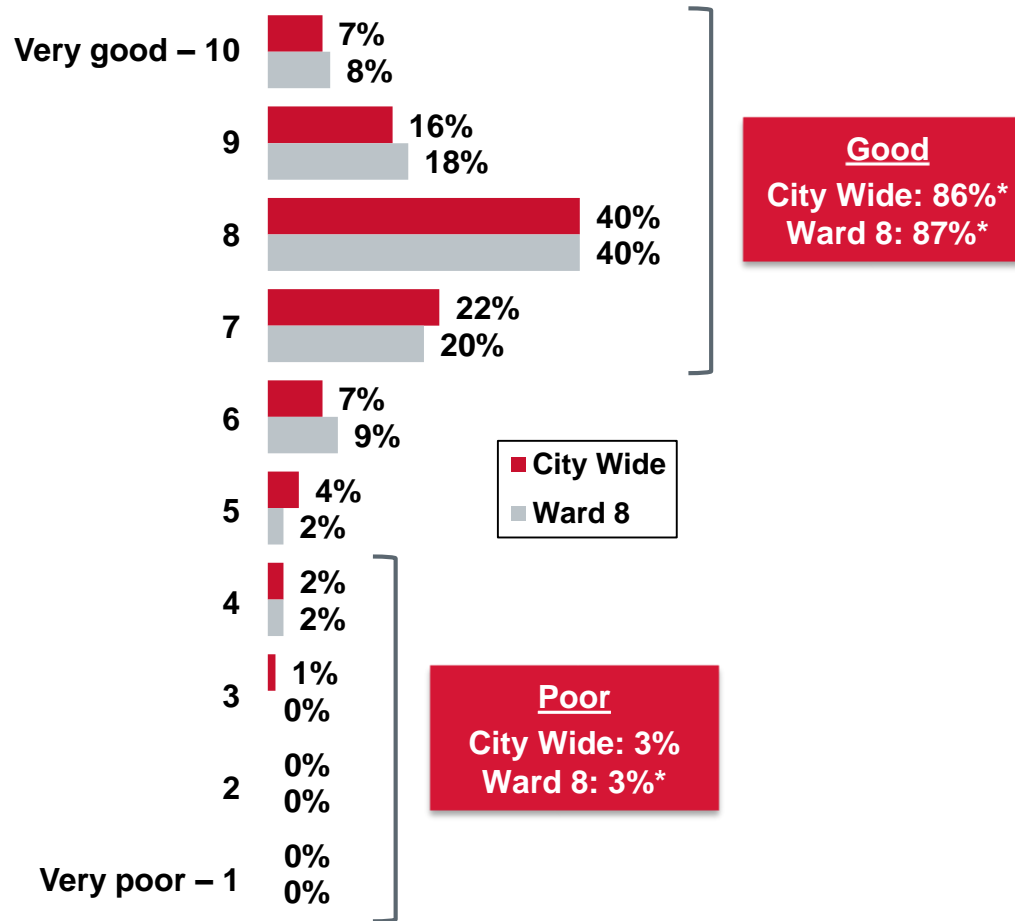
- ❖ Eight-in-ten (85%) Ward 8 residents are satisfied with the way The City of Calgary – including Council and Administration (on par with 79% City Wide) are running their City.

Overall Quality of Life in Calgary

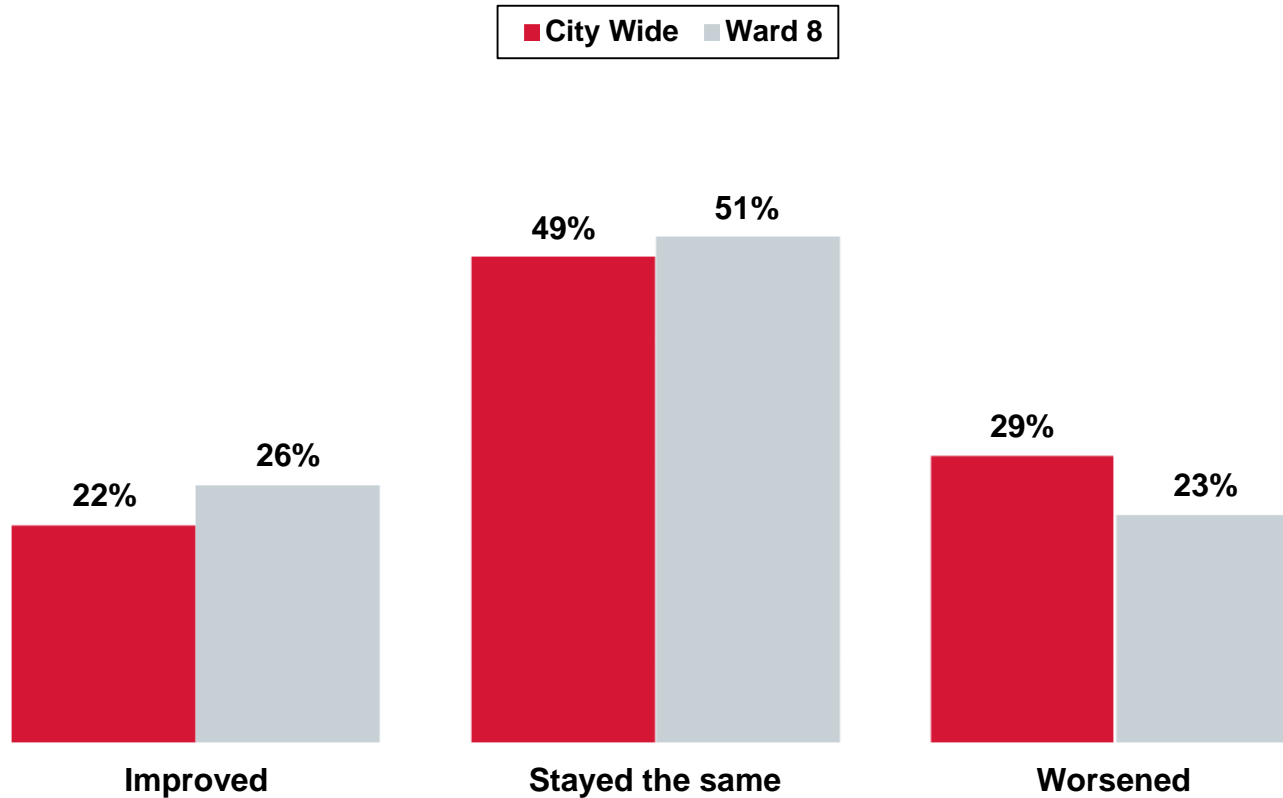


On a scale of “1” to “10” where “1” represents “very poor” and “10” represents “very good,” how would you rate the overall quality of life in the city of Calgary today?

And, do you feel that the quality of life in the city of Calgary in the past three years has ...?

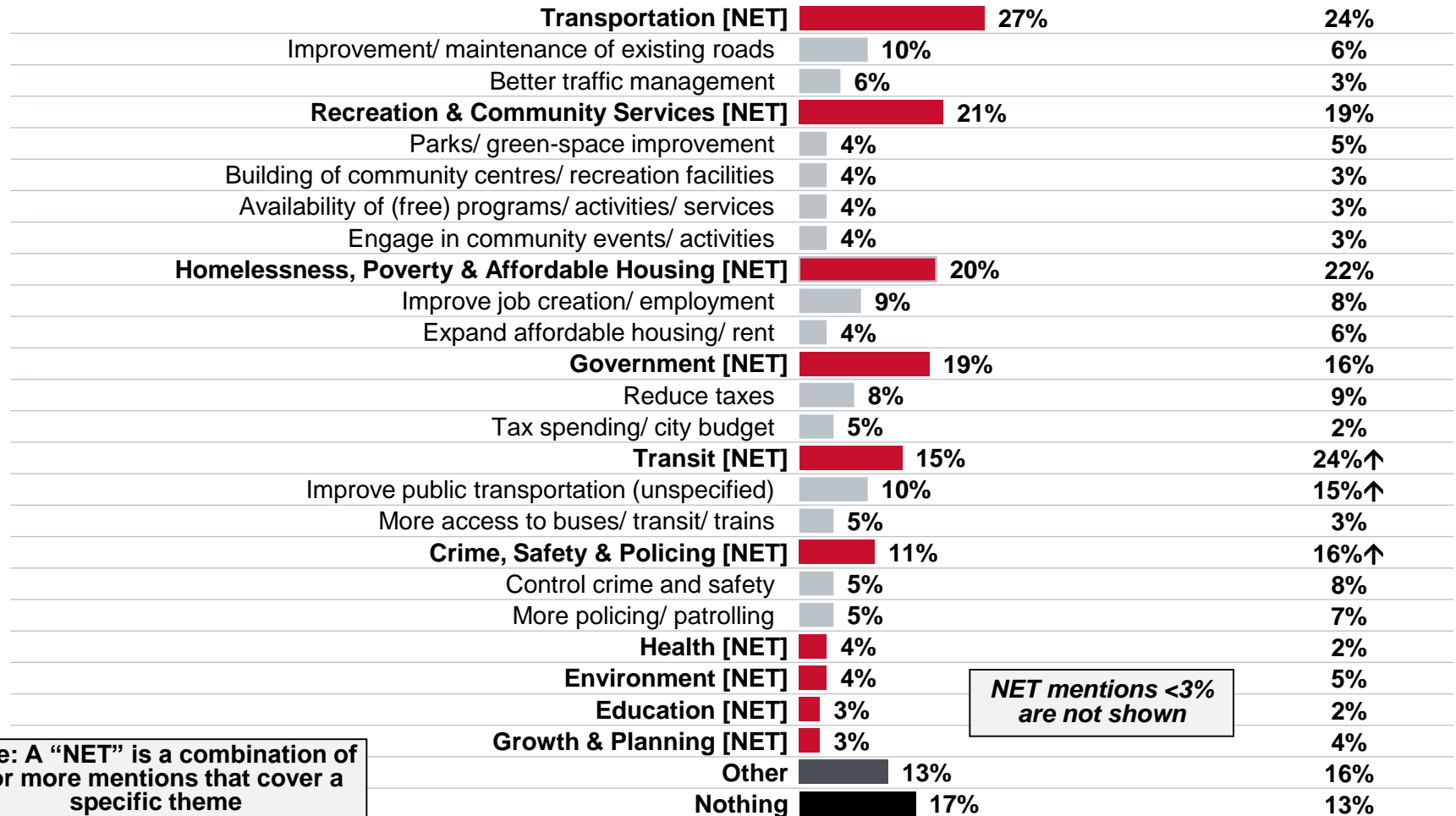

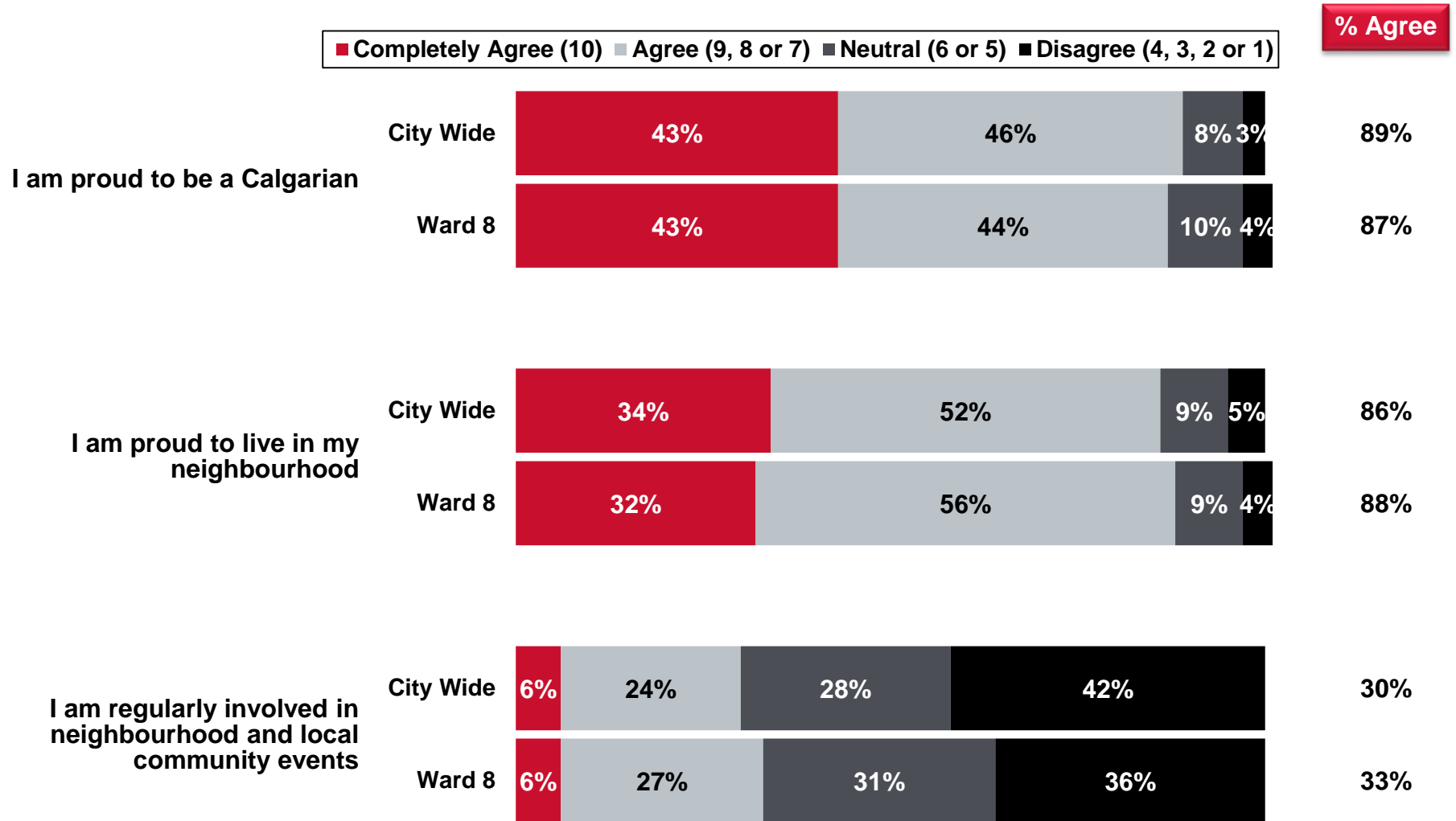

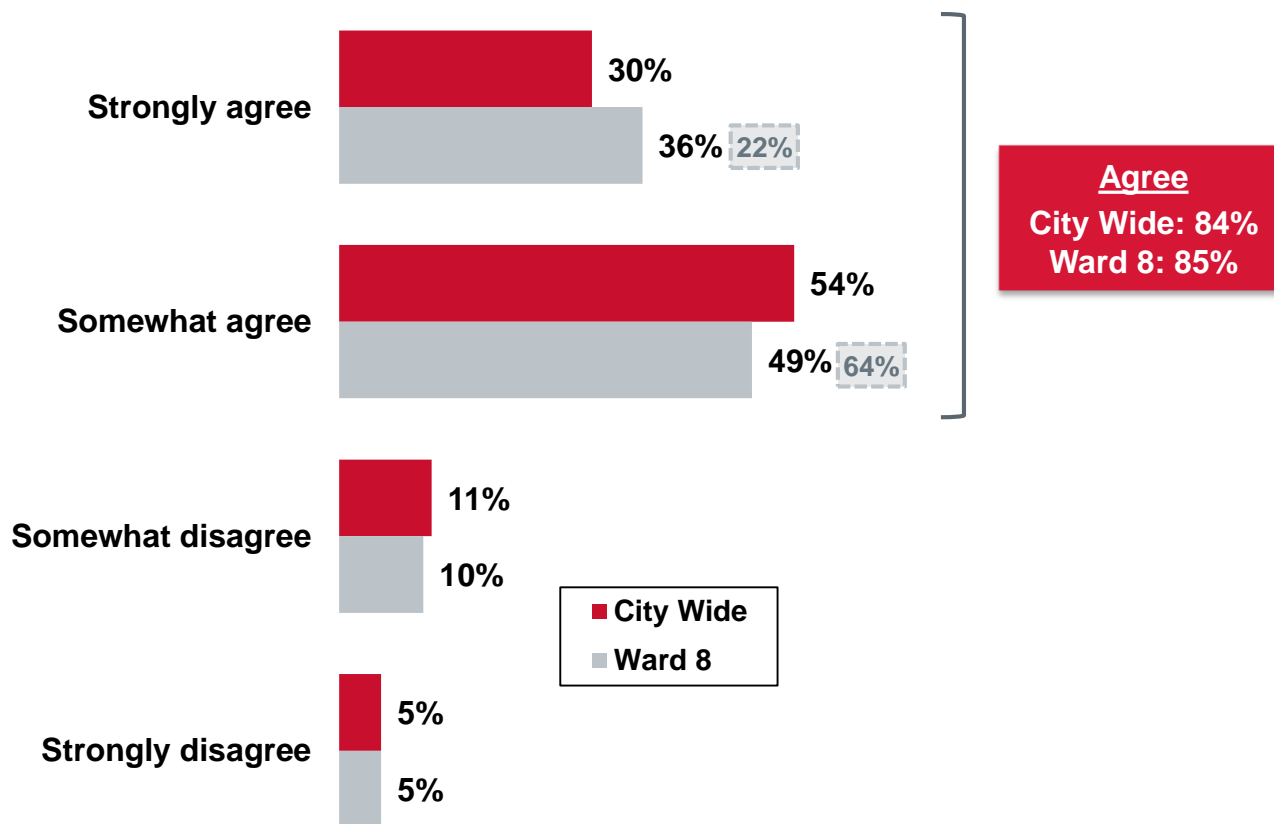

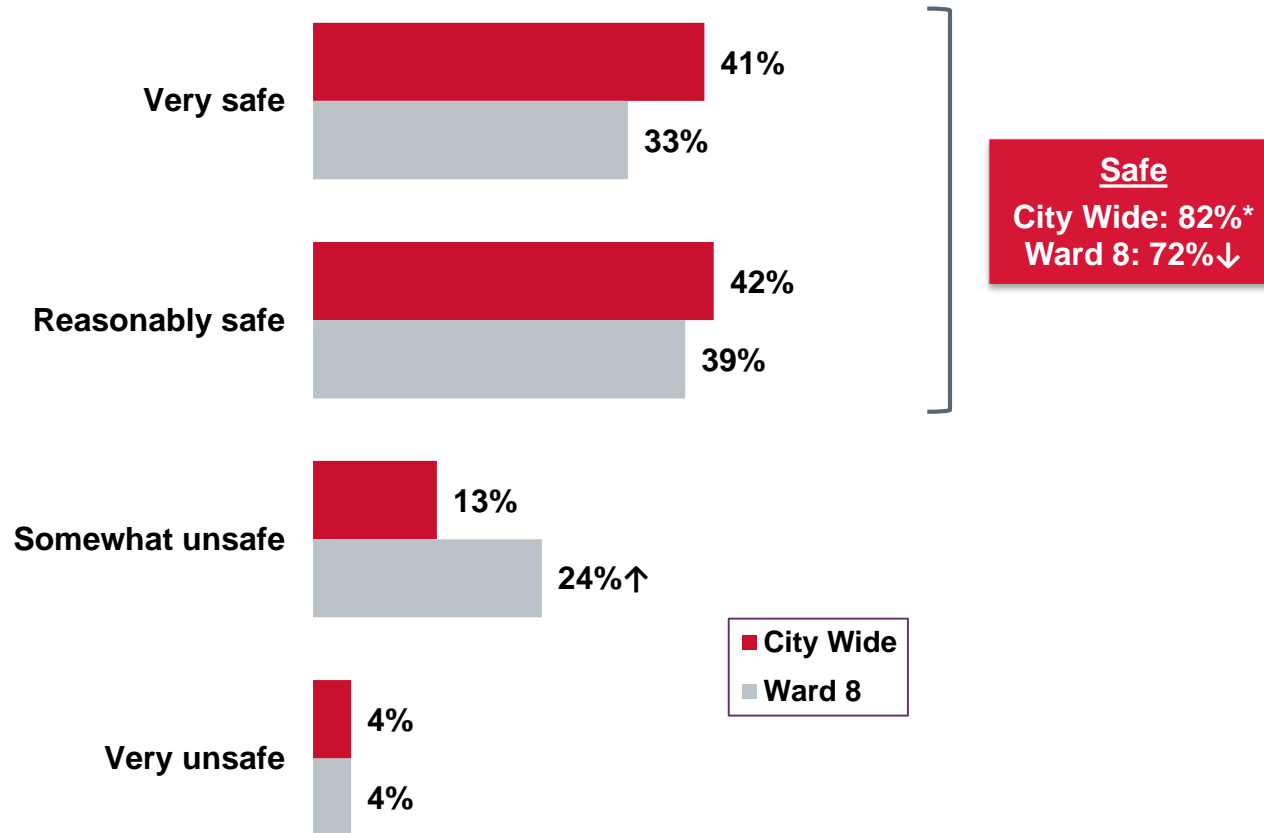

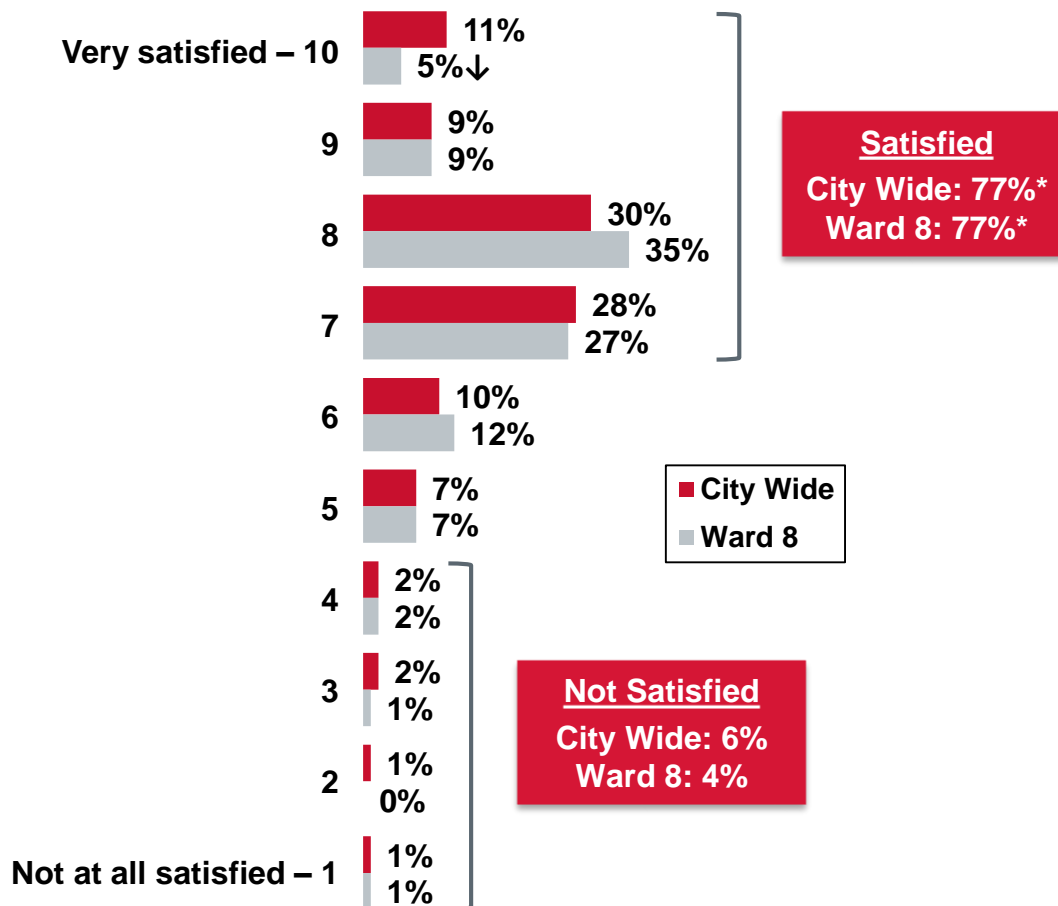

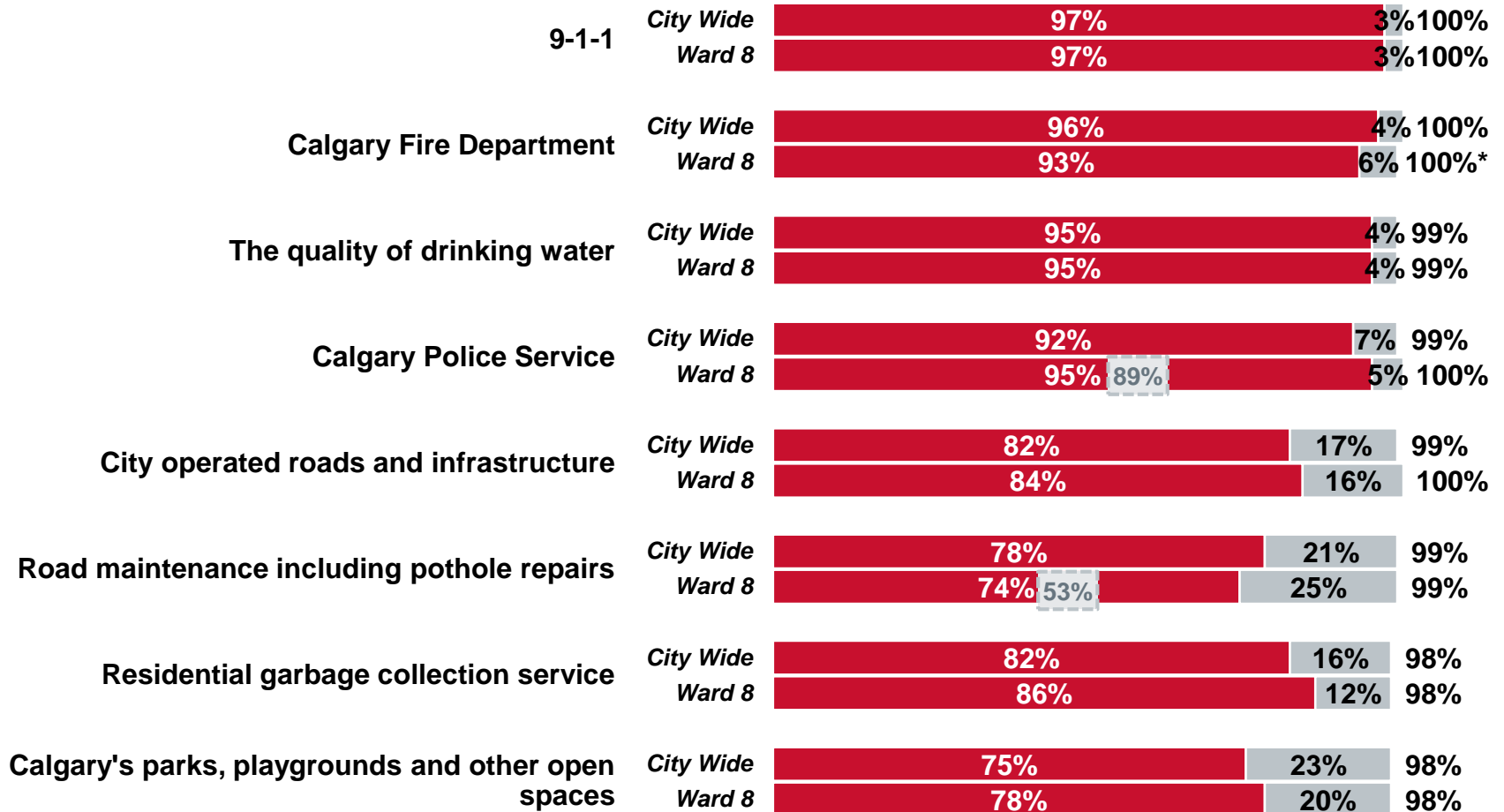

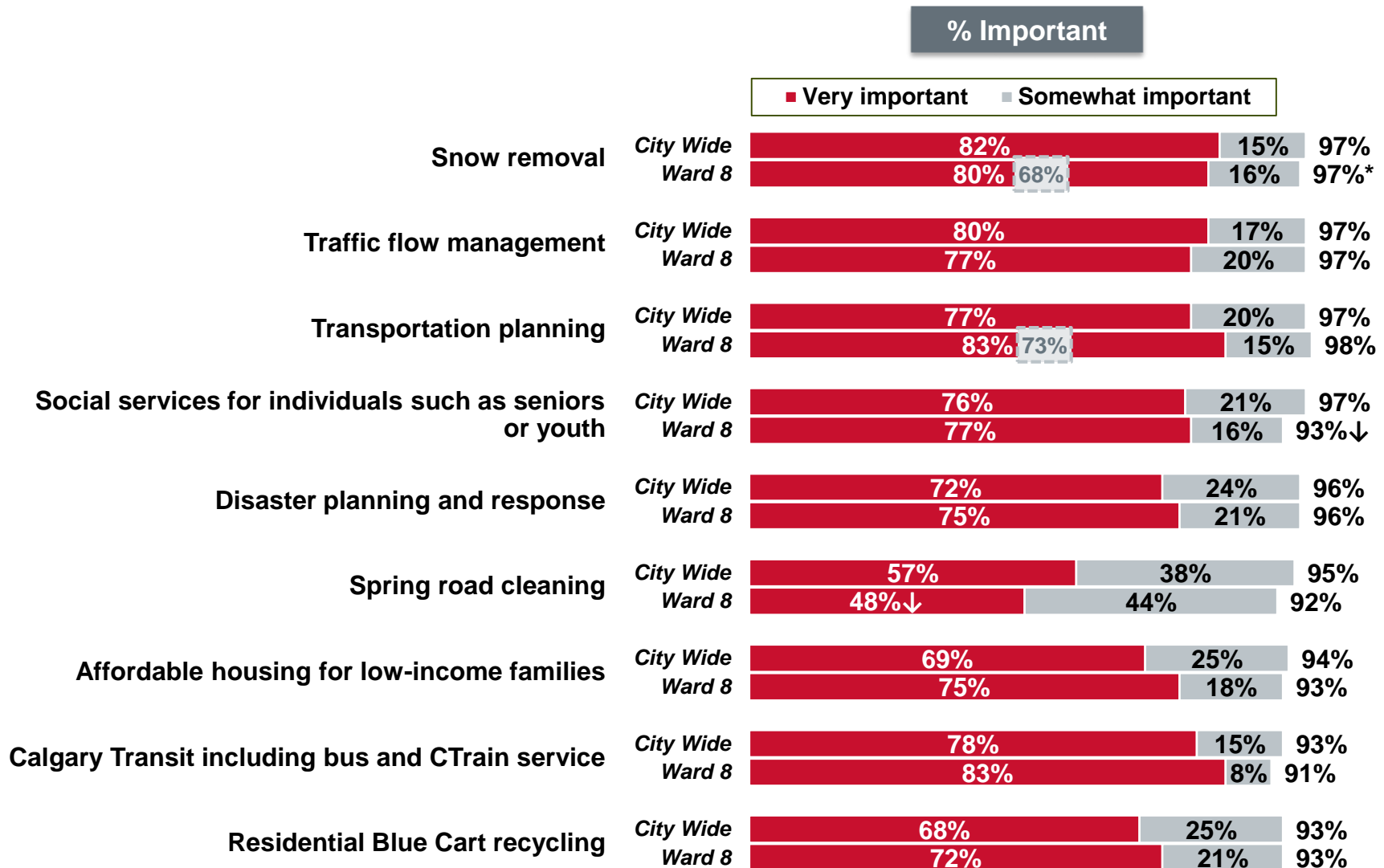

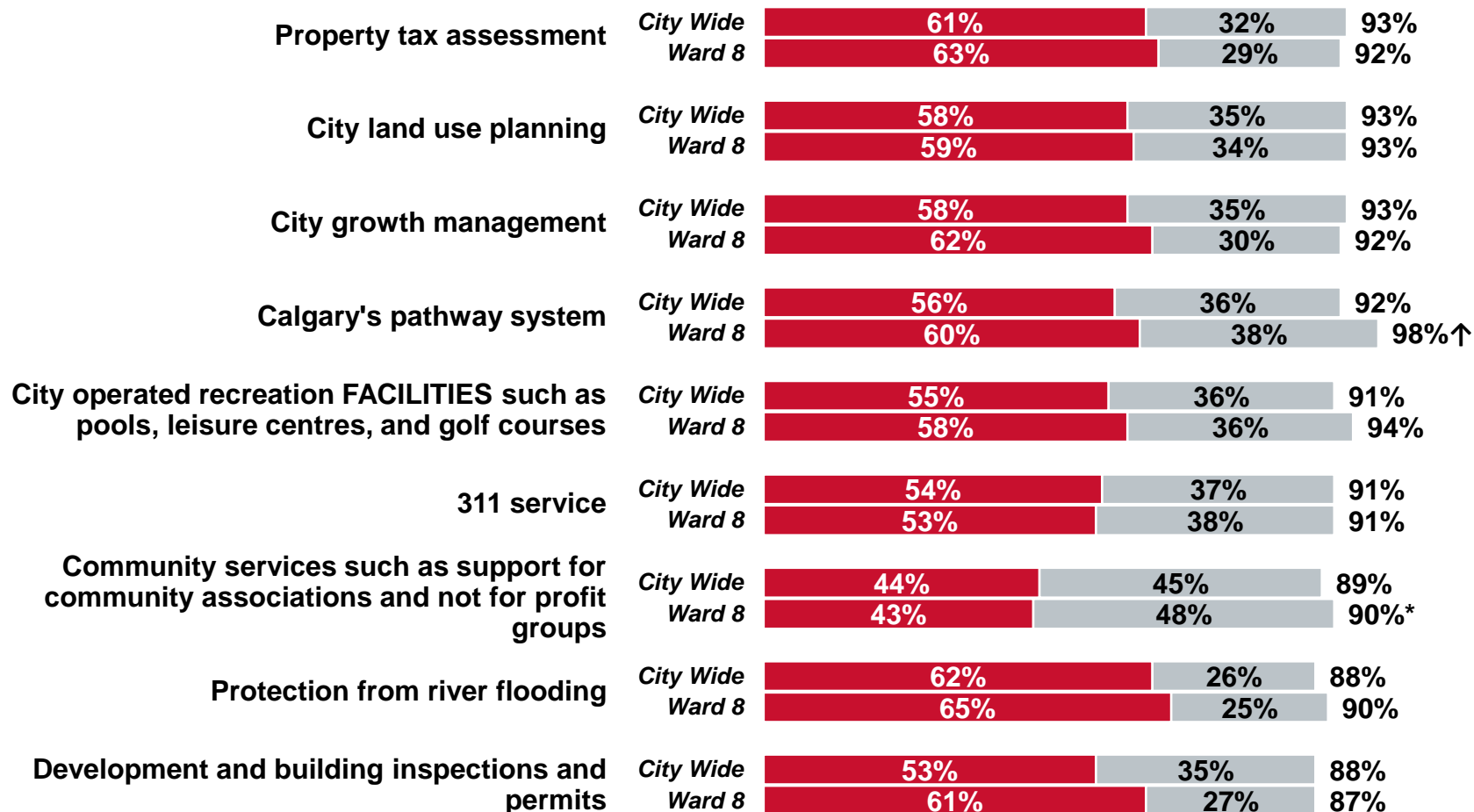

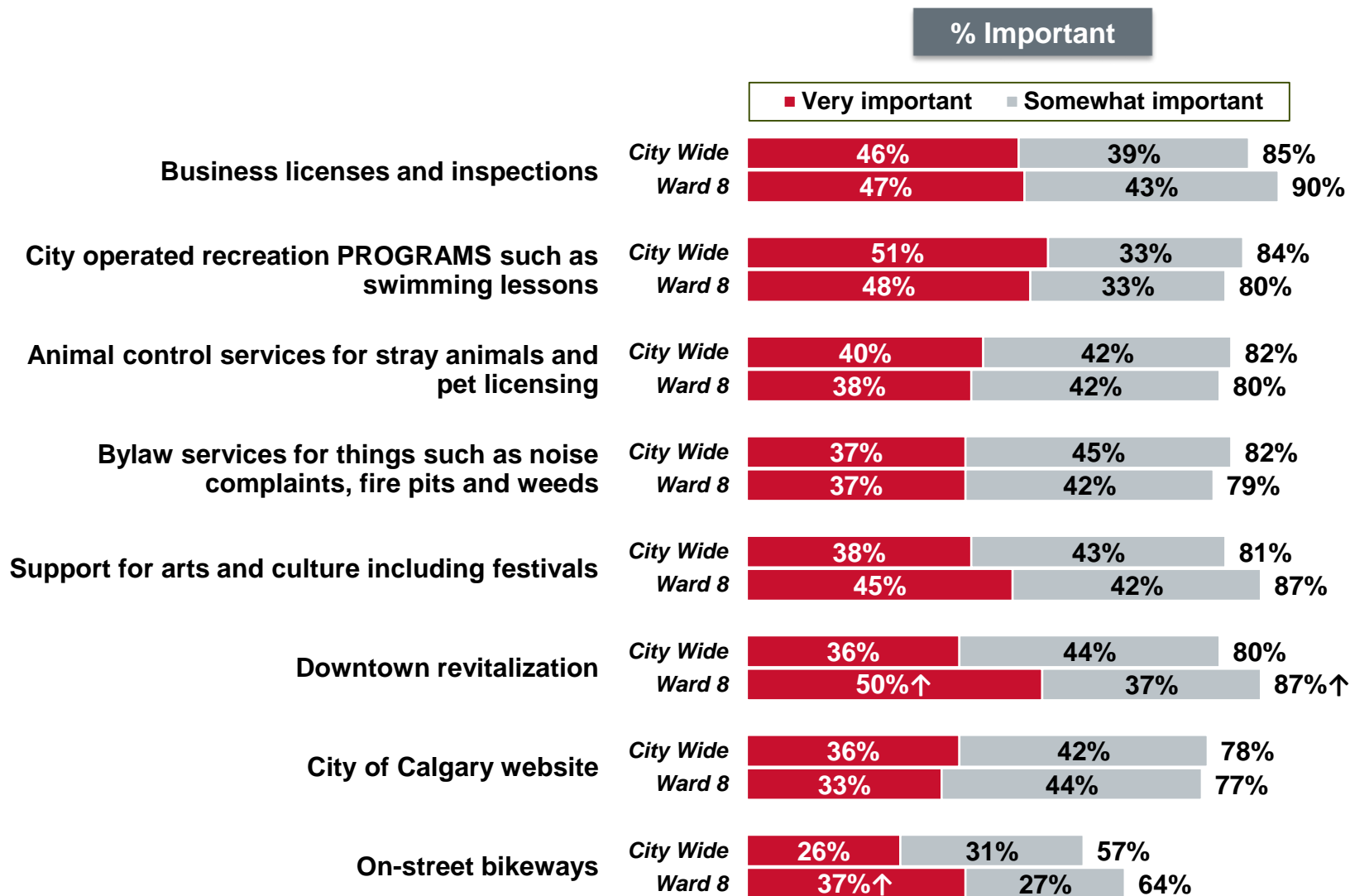

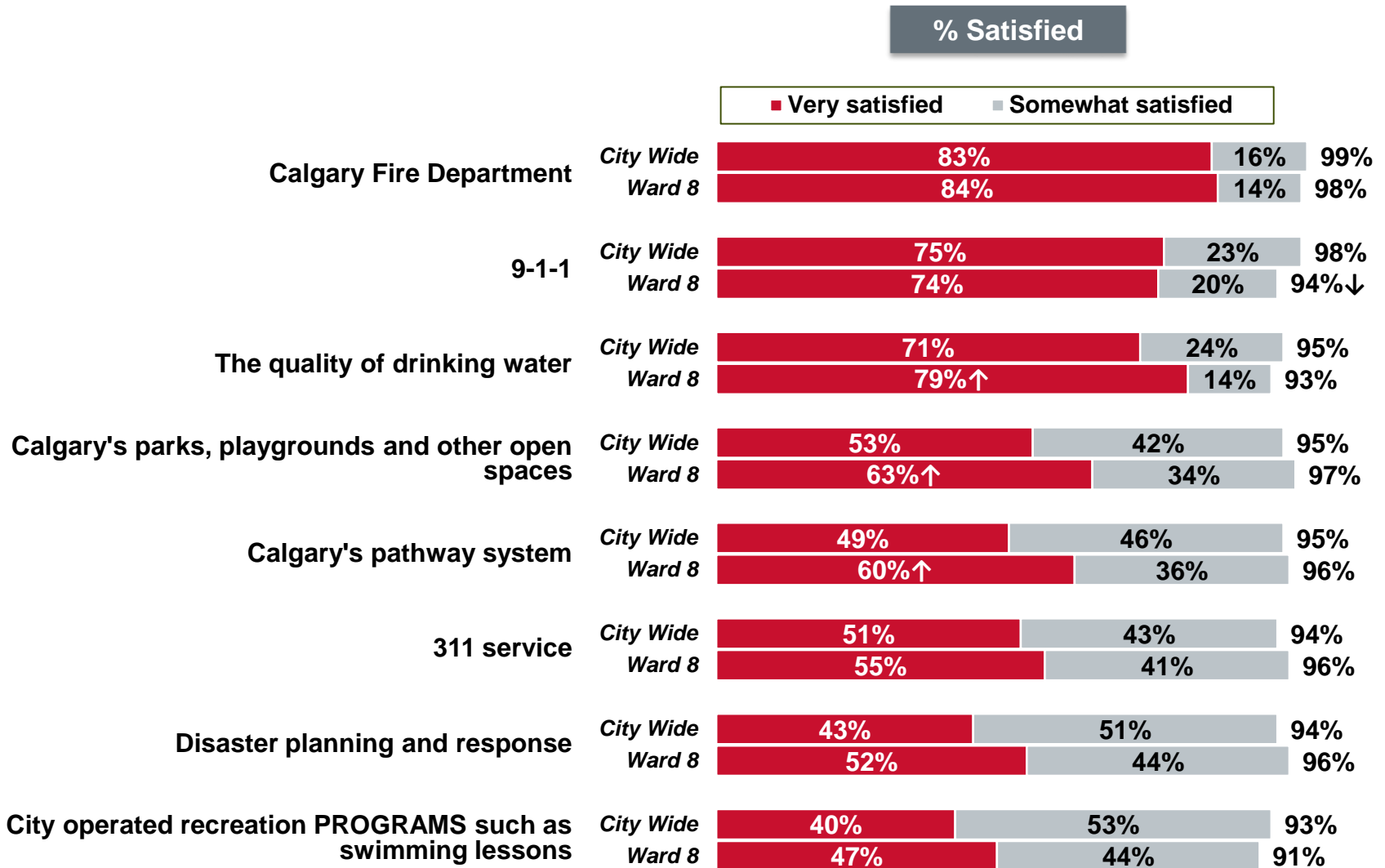

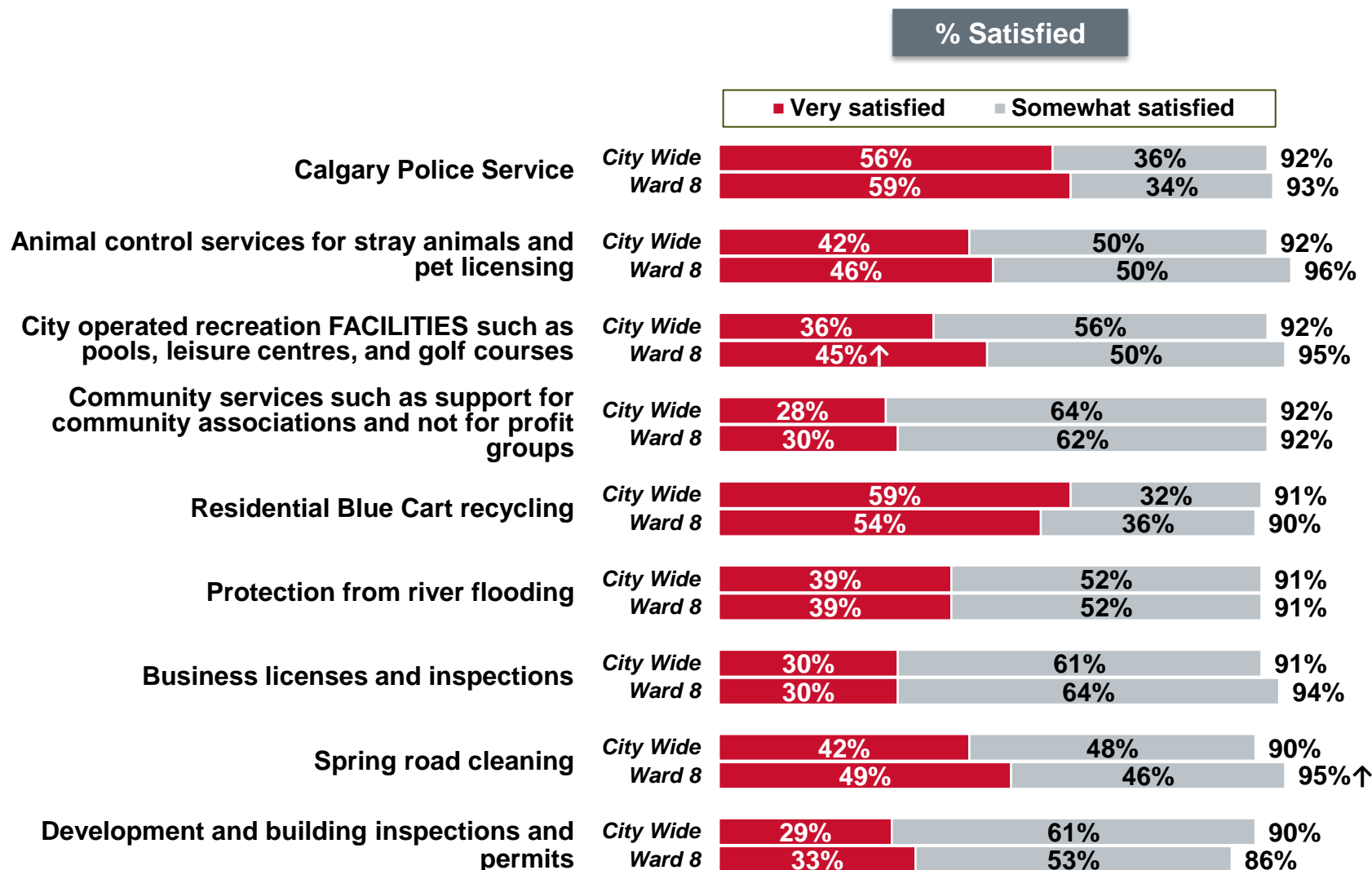

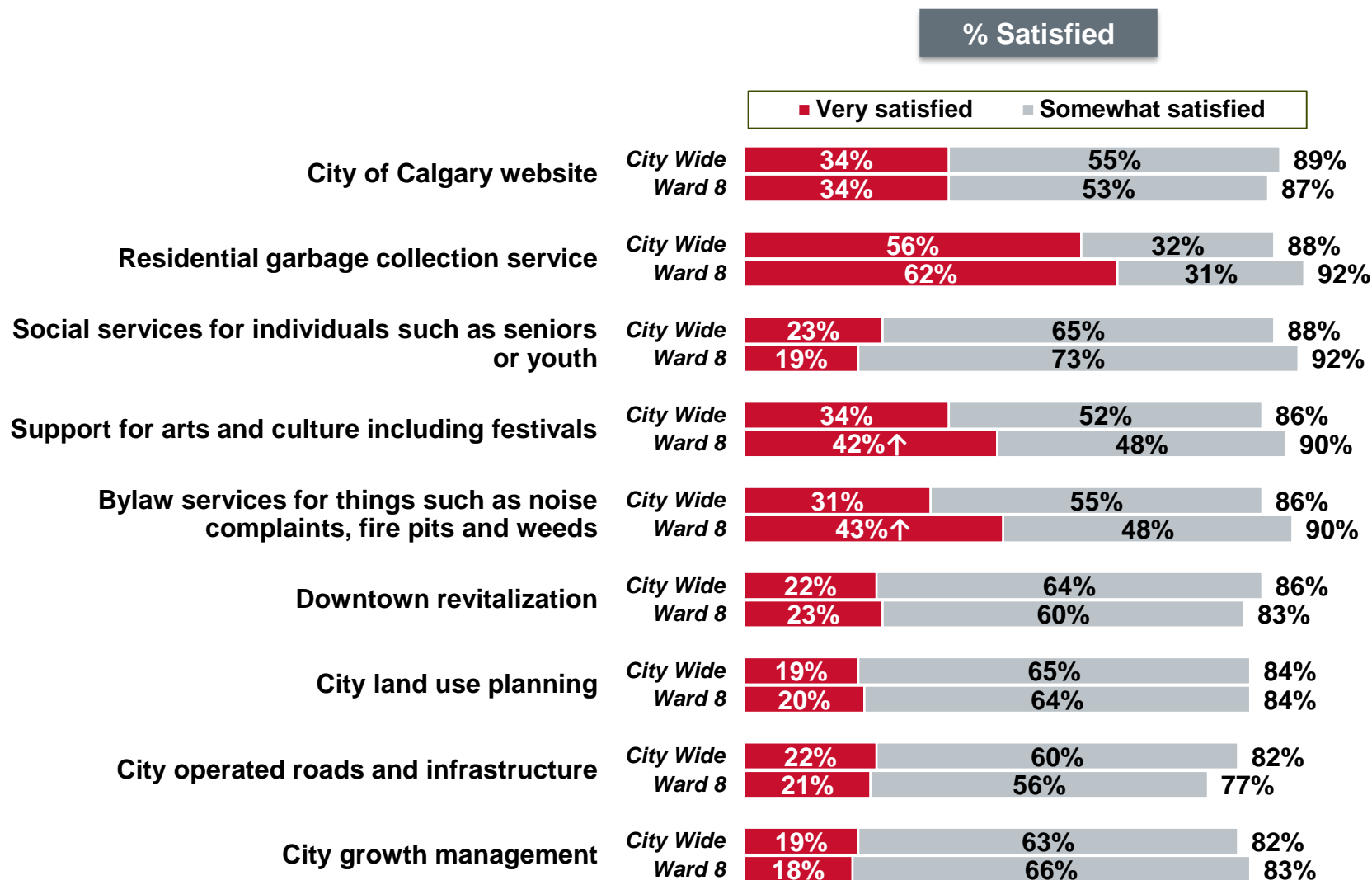

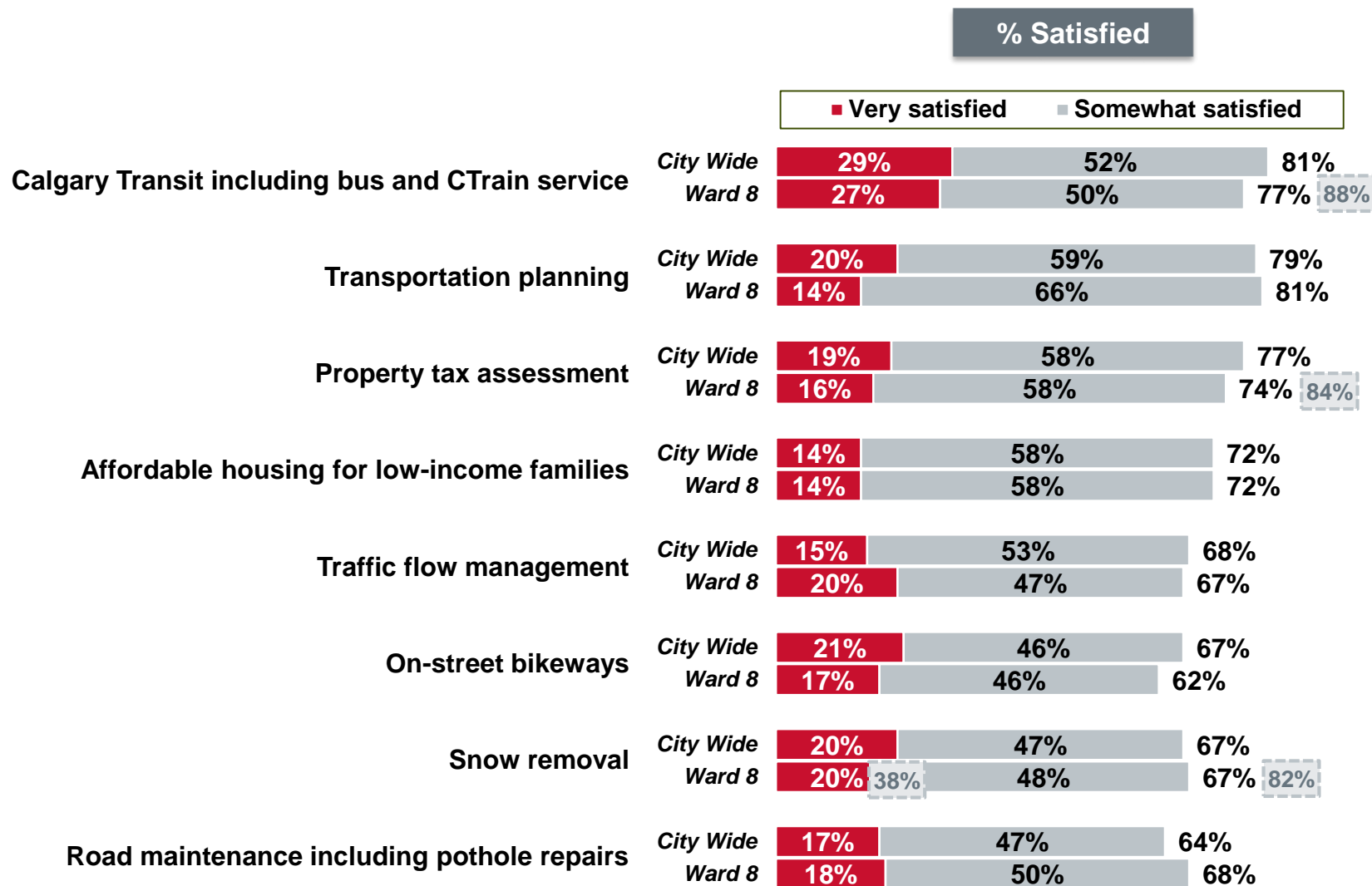

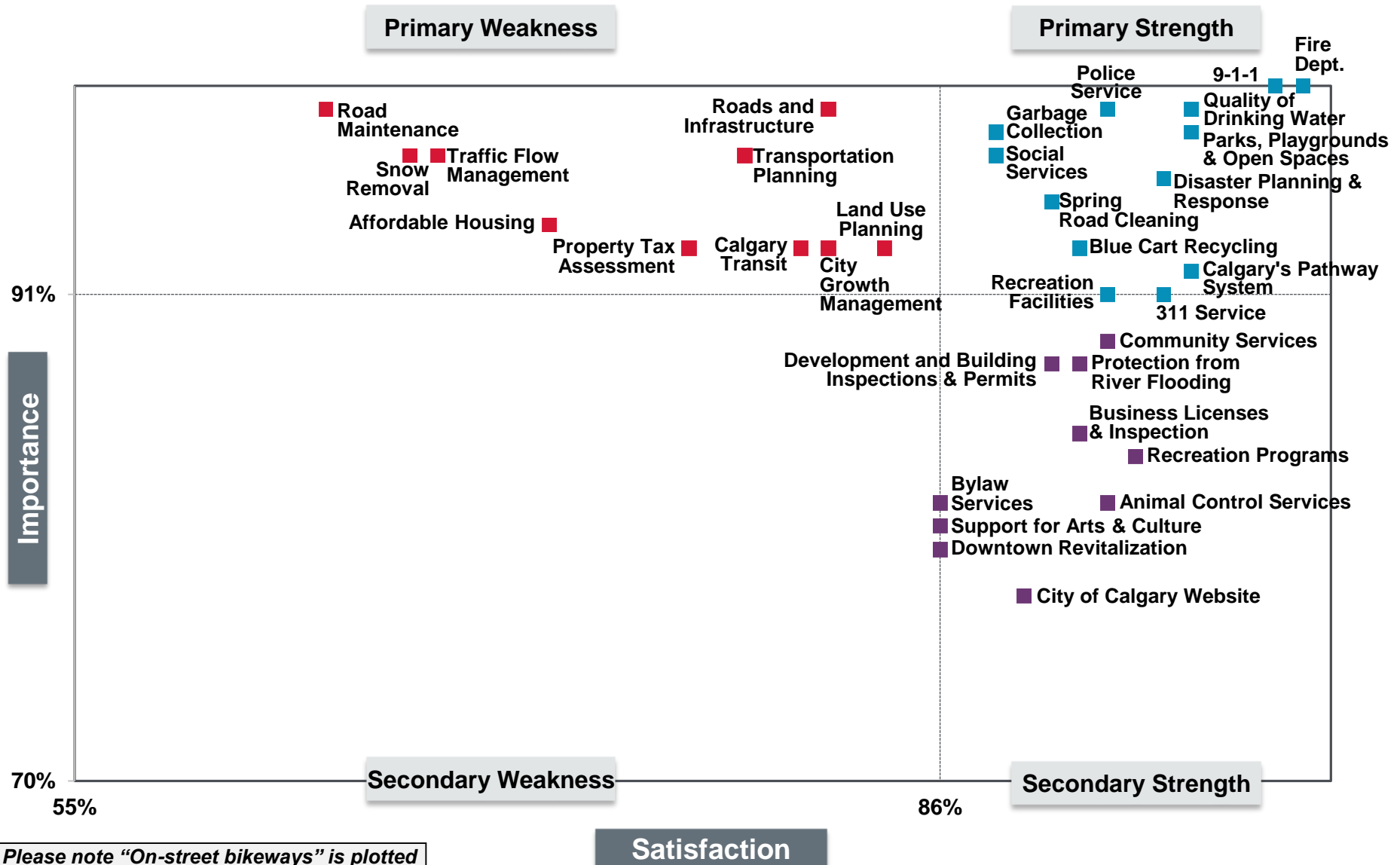

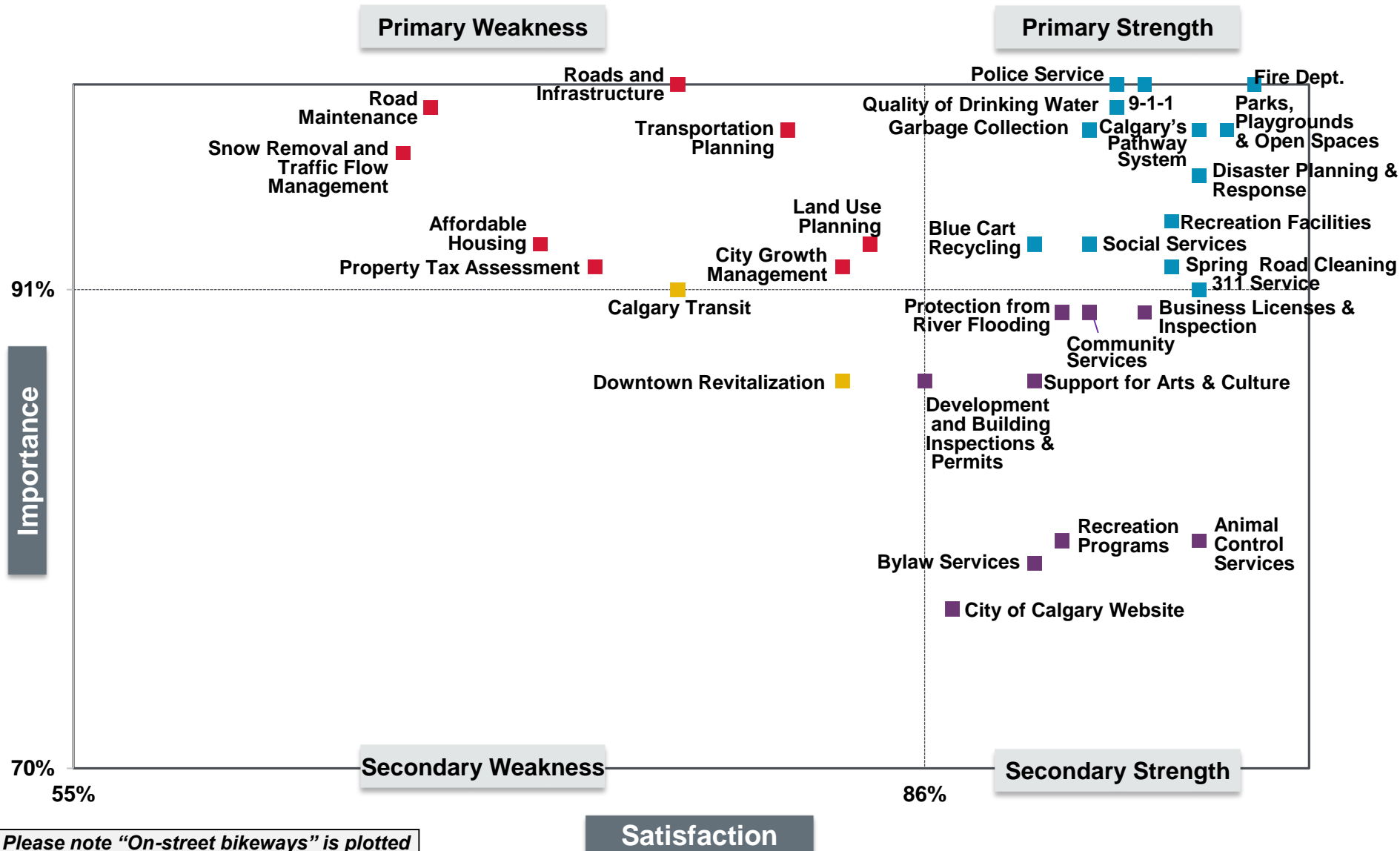

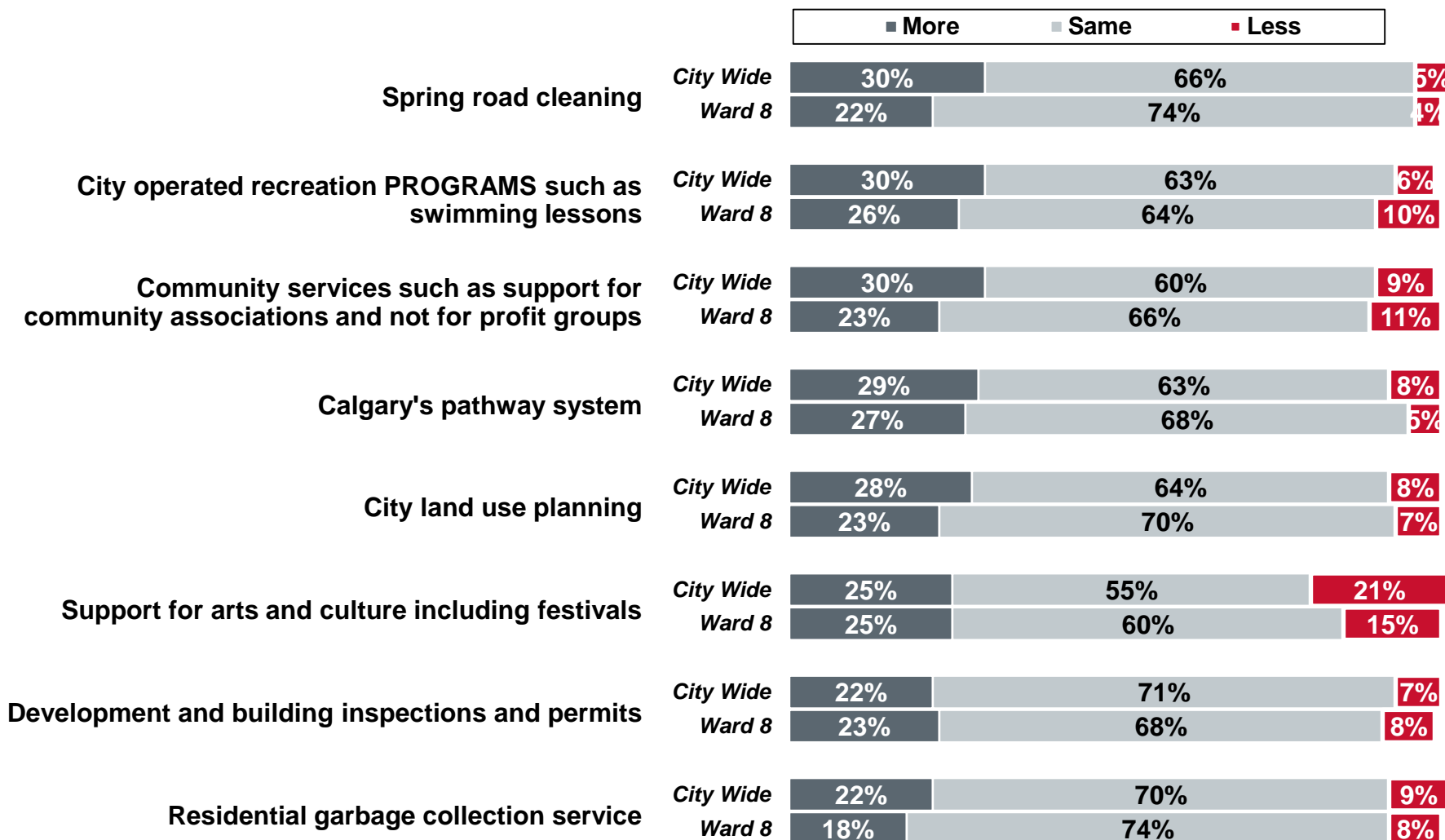

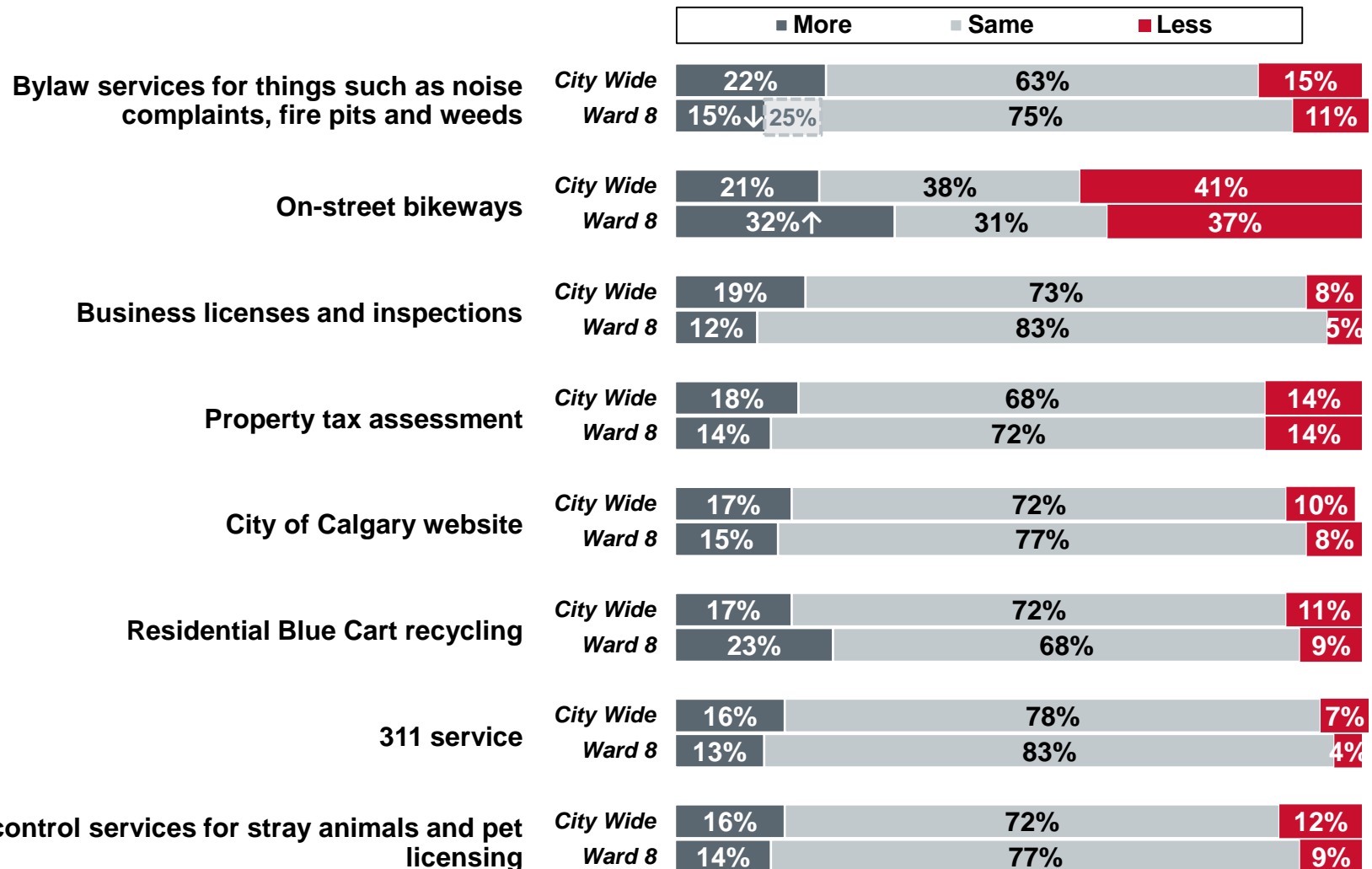

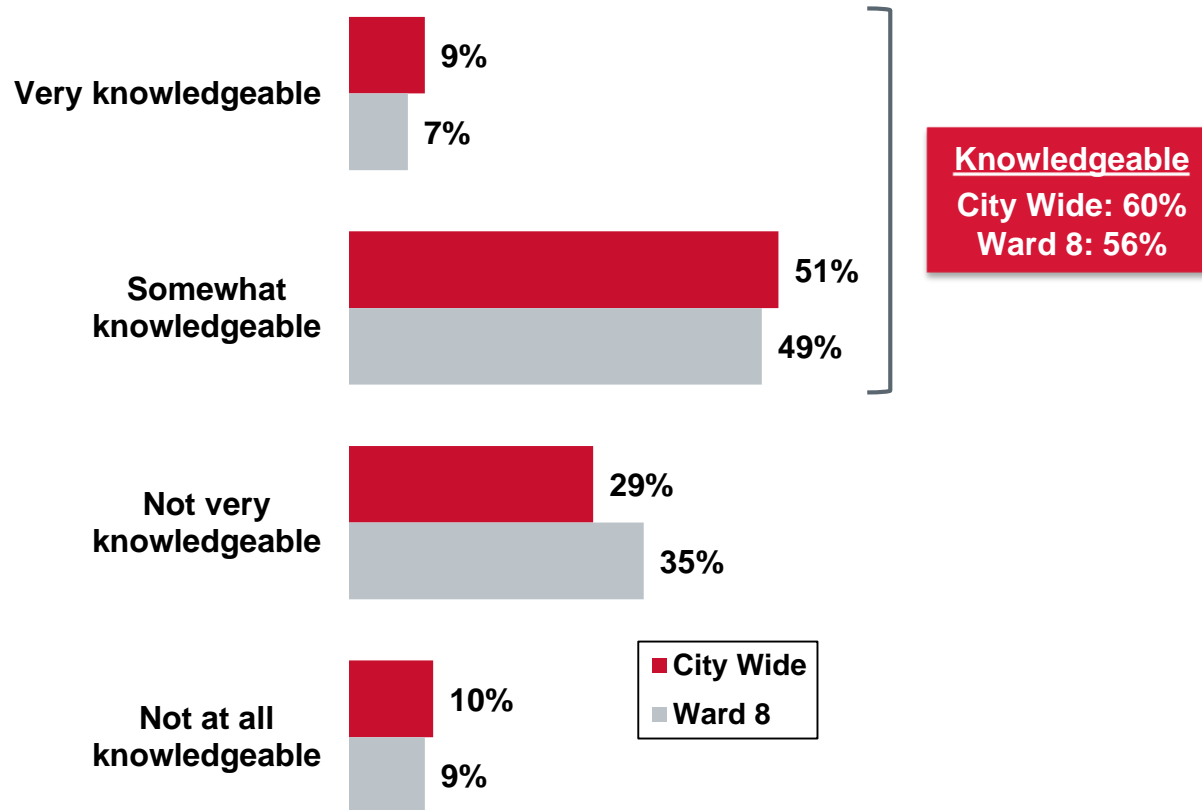

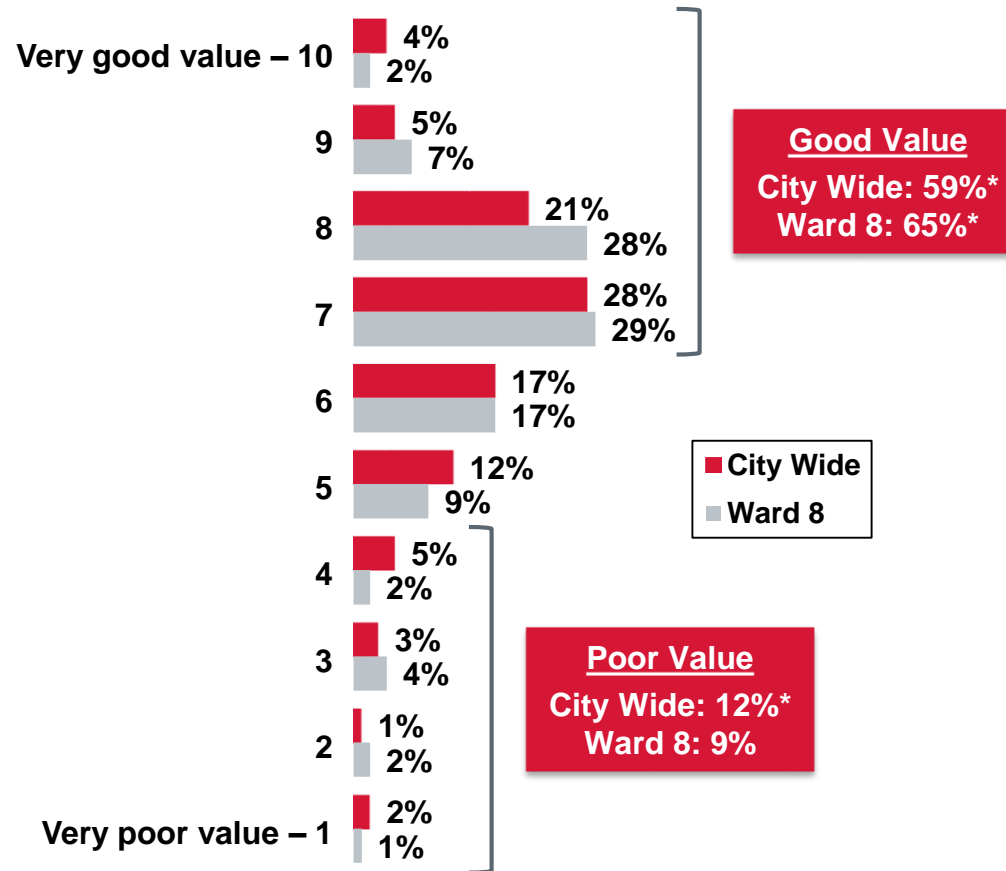
Knowledge Levels of Tax Dollar Spending

Perceived Value of Property Taxes

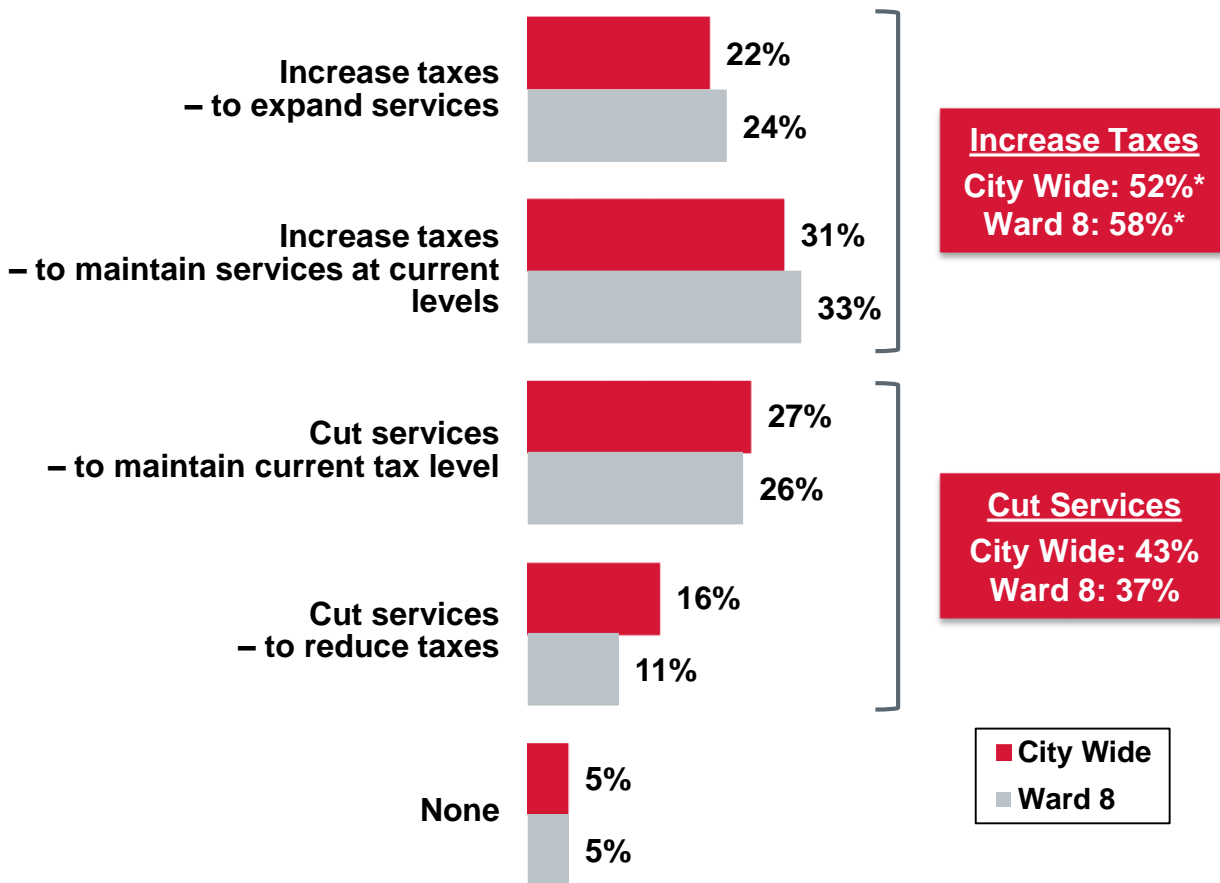

Balancing Taxation and Service Delivery Levels

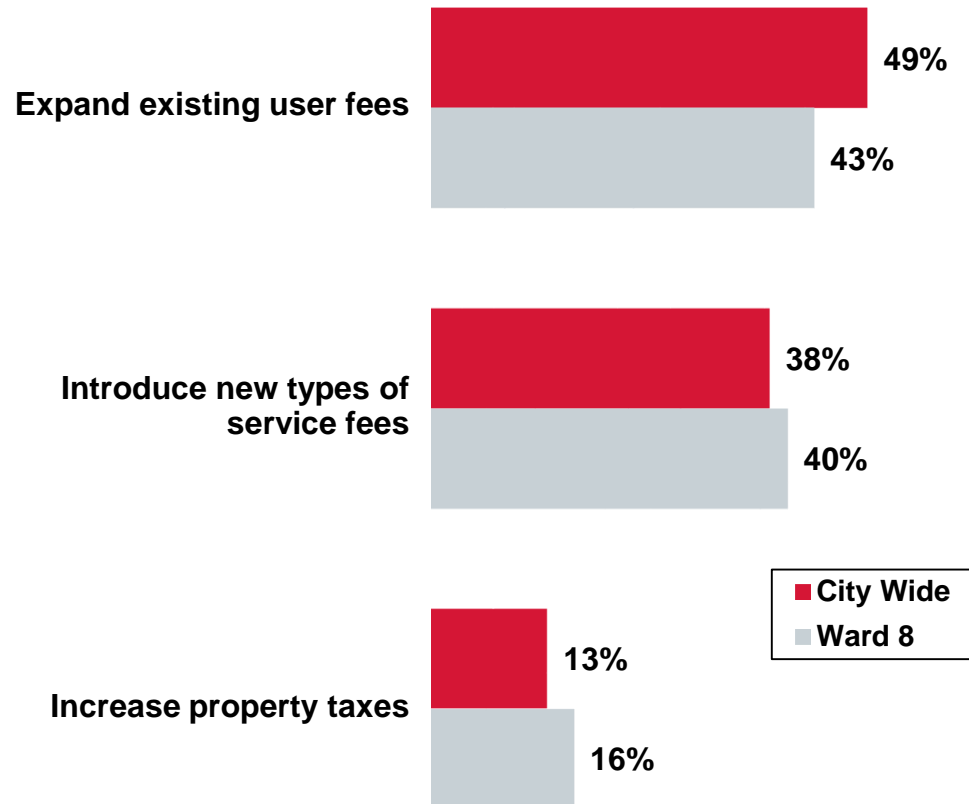

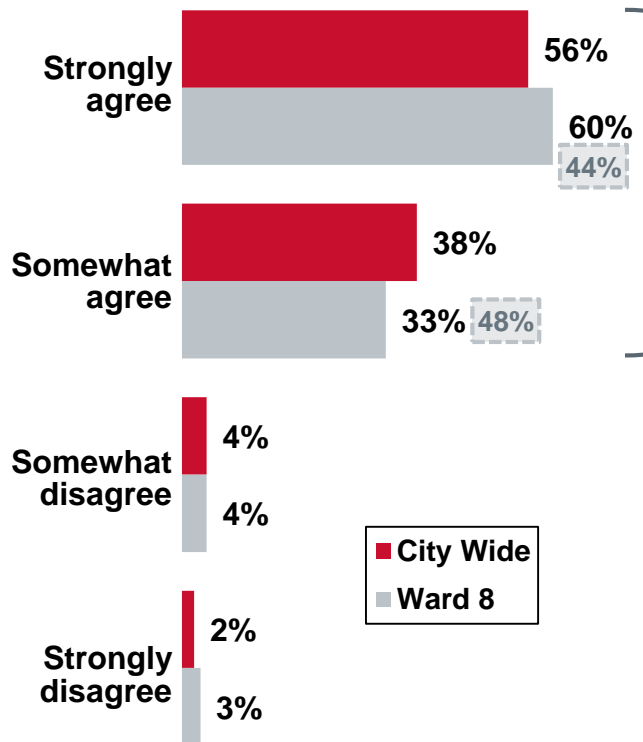


Should The City need to increase the amount of revenue it collects from citizens for new or emerging services, would you prefer The City to ...?

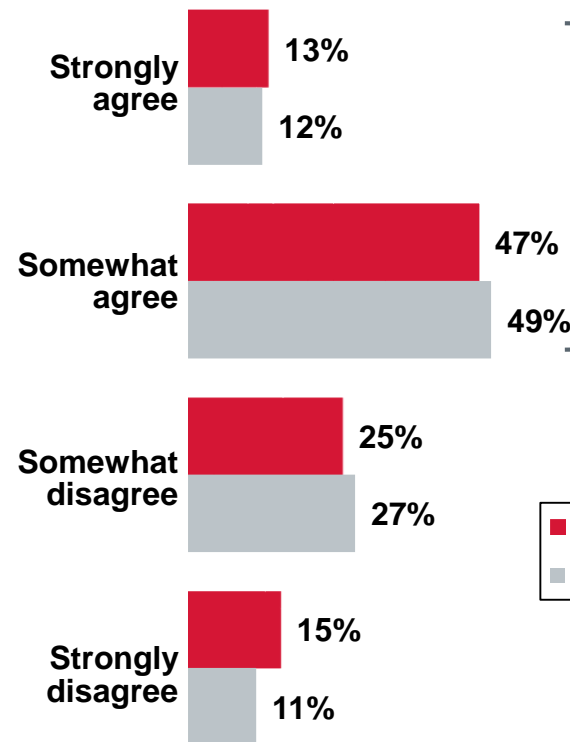

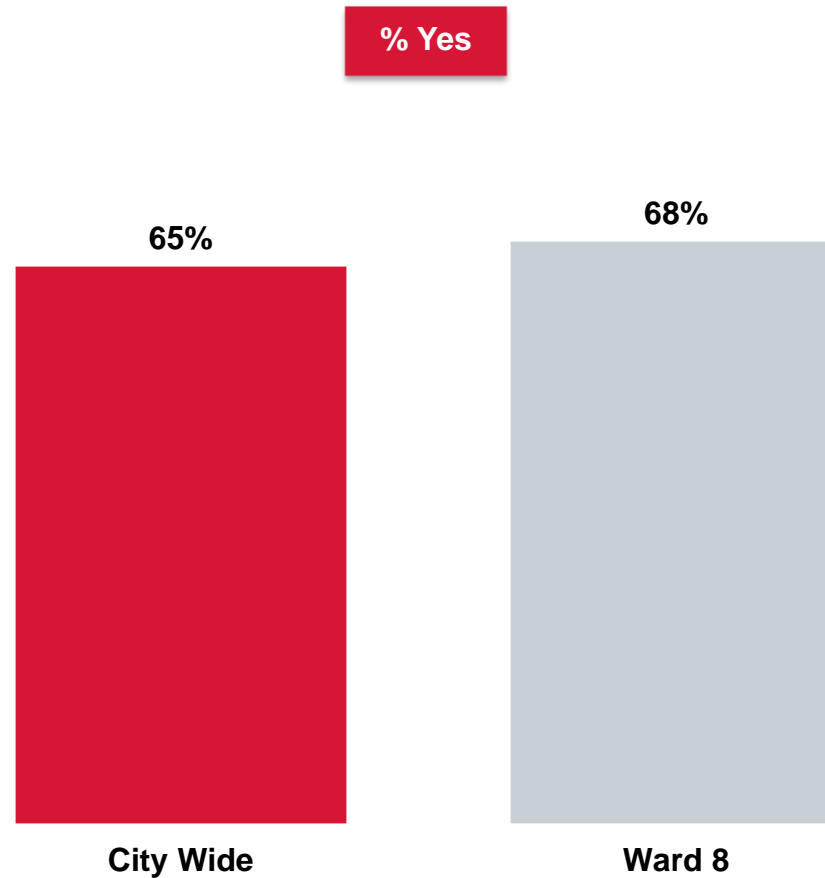

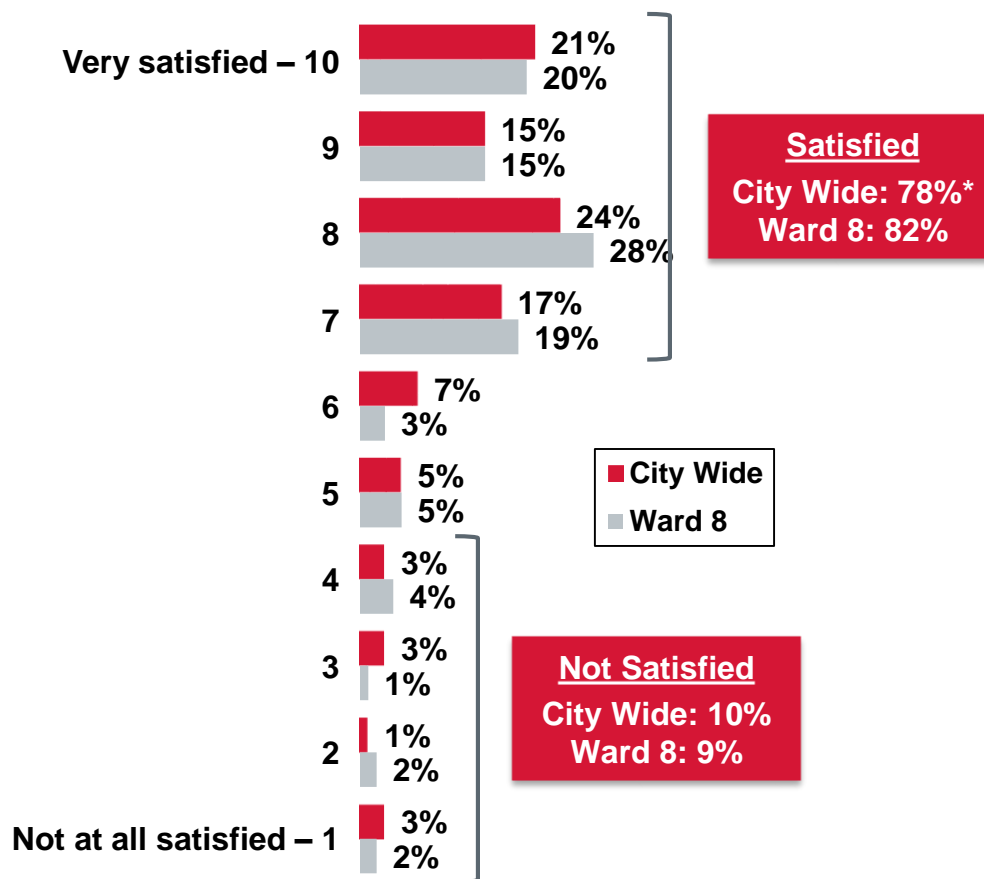
Past 12 Months Contact with The City of Calgary

Satisfaction with the Overall Level and Quality of Customer Service



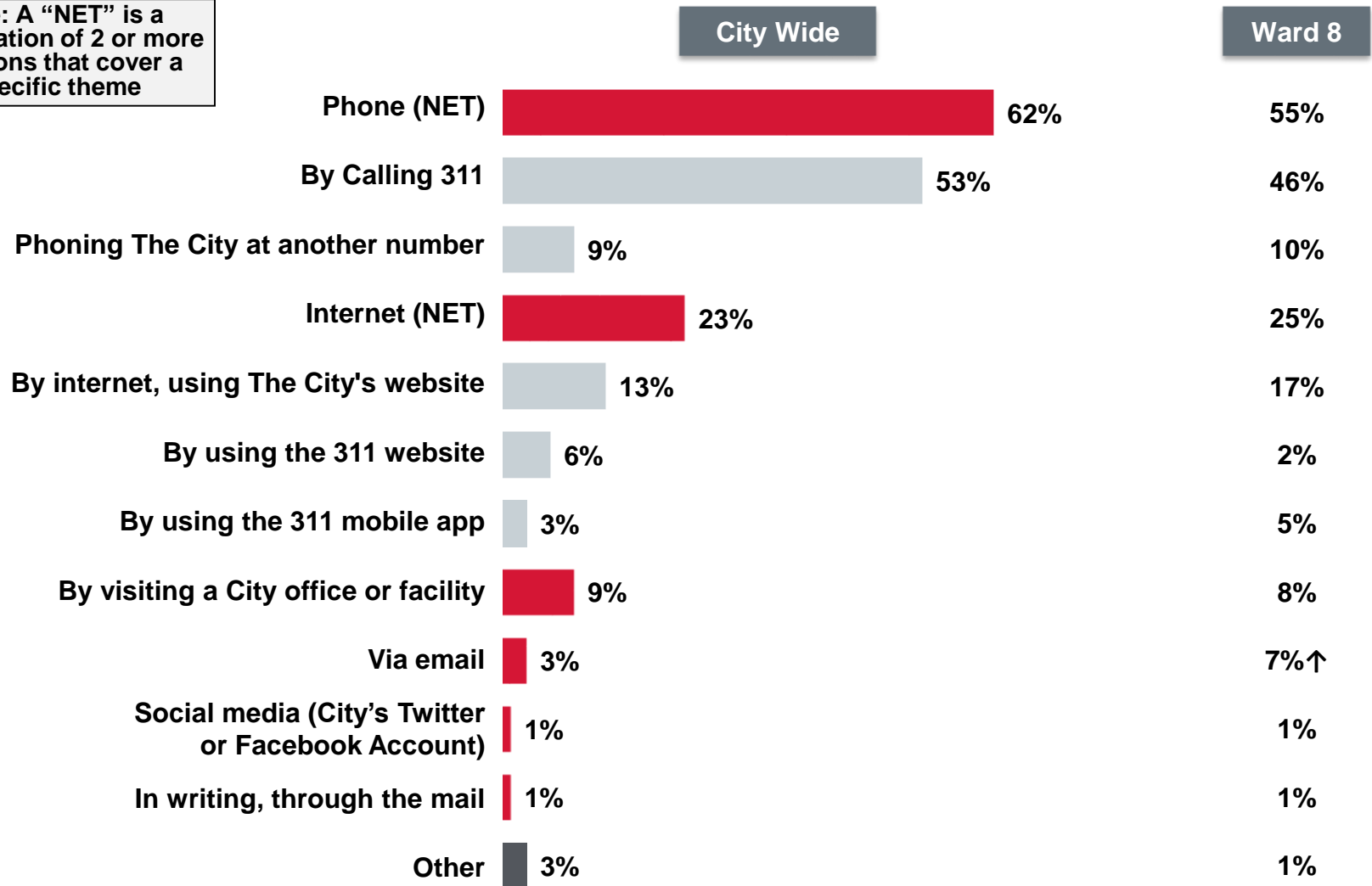

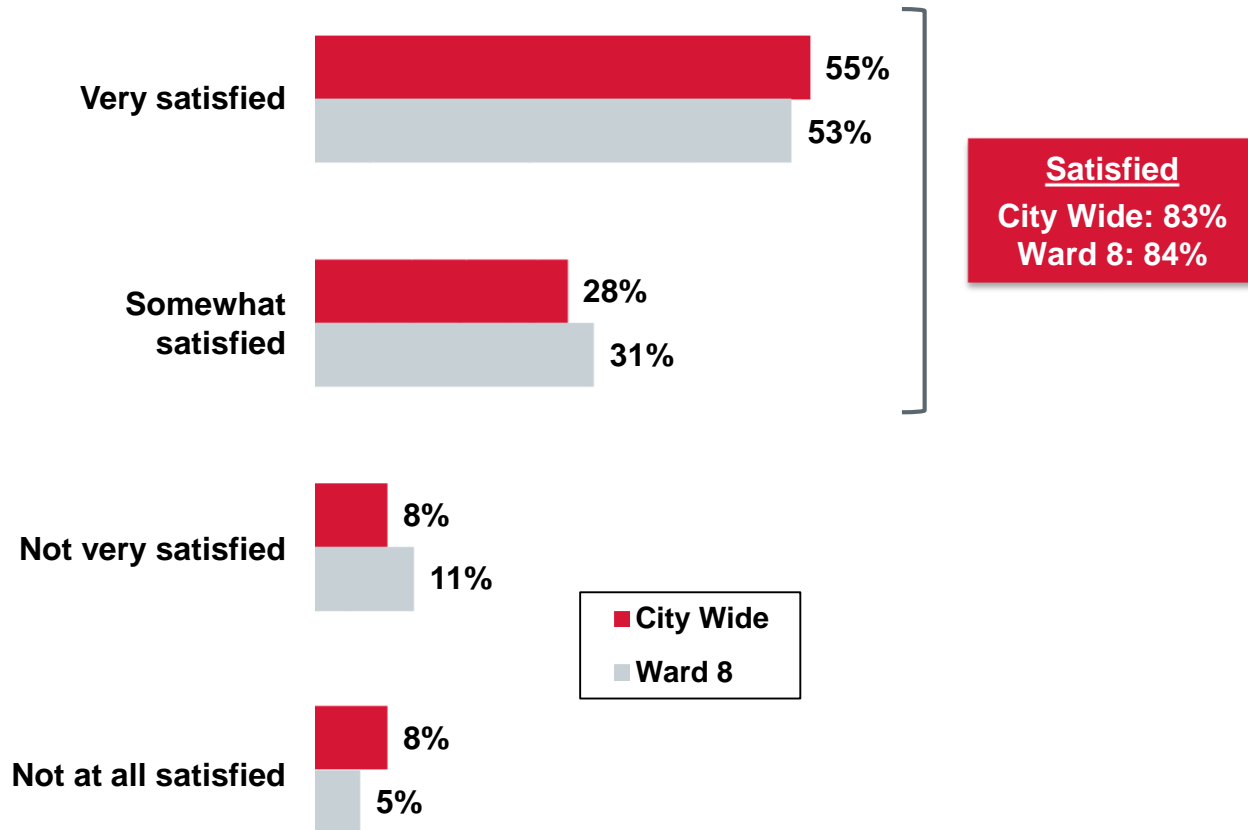

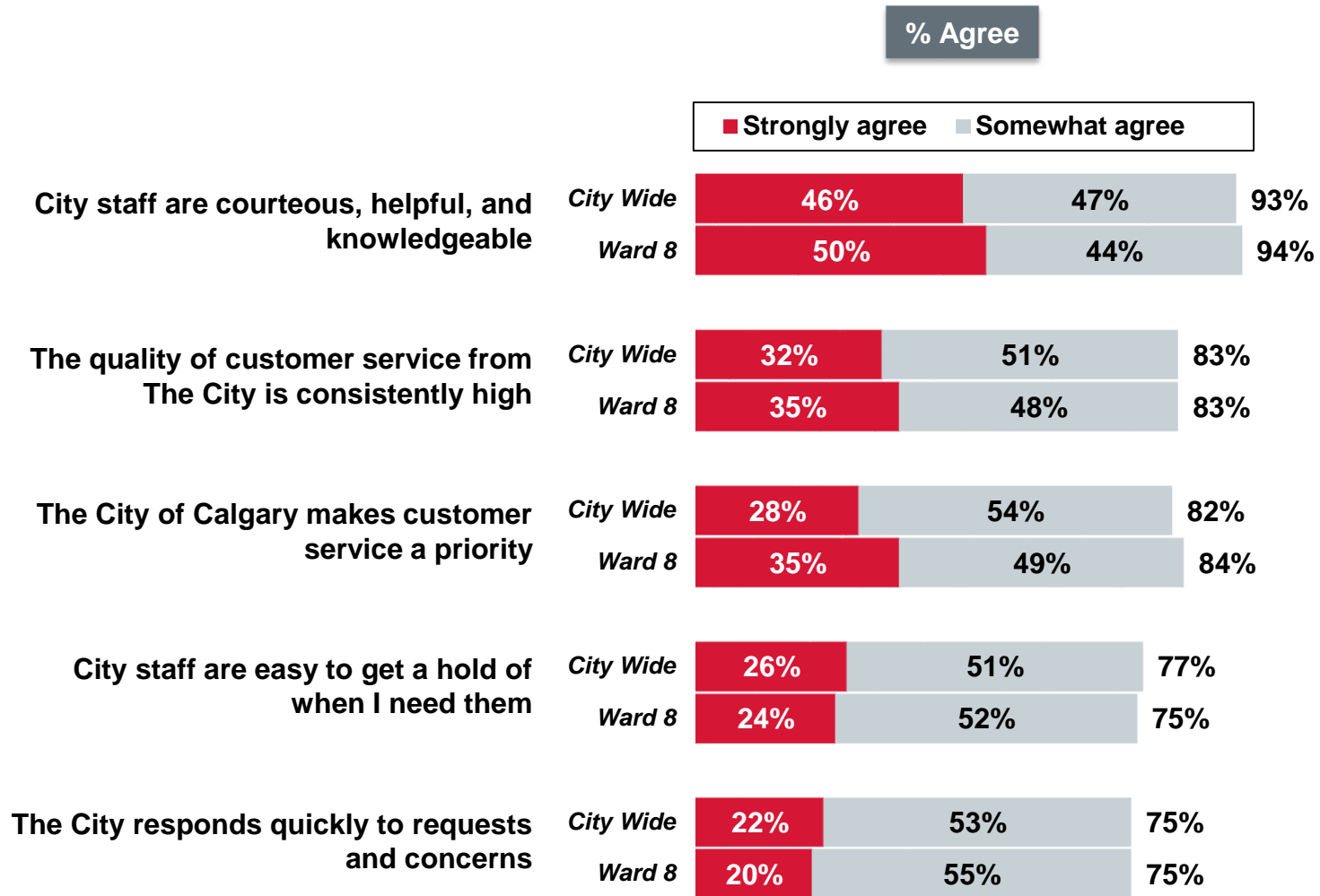
Satisfaction with Most Recent City Contact

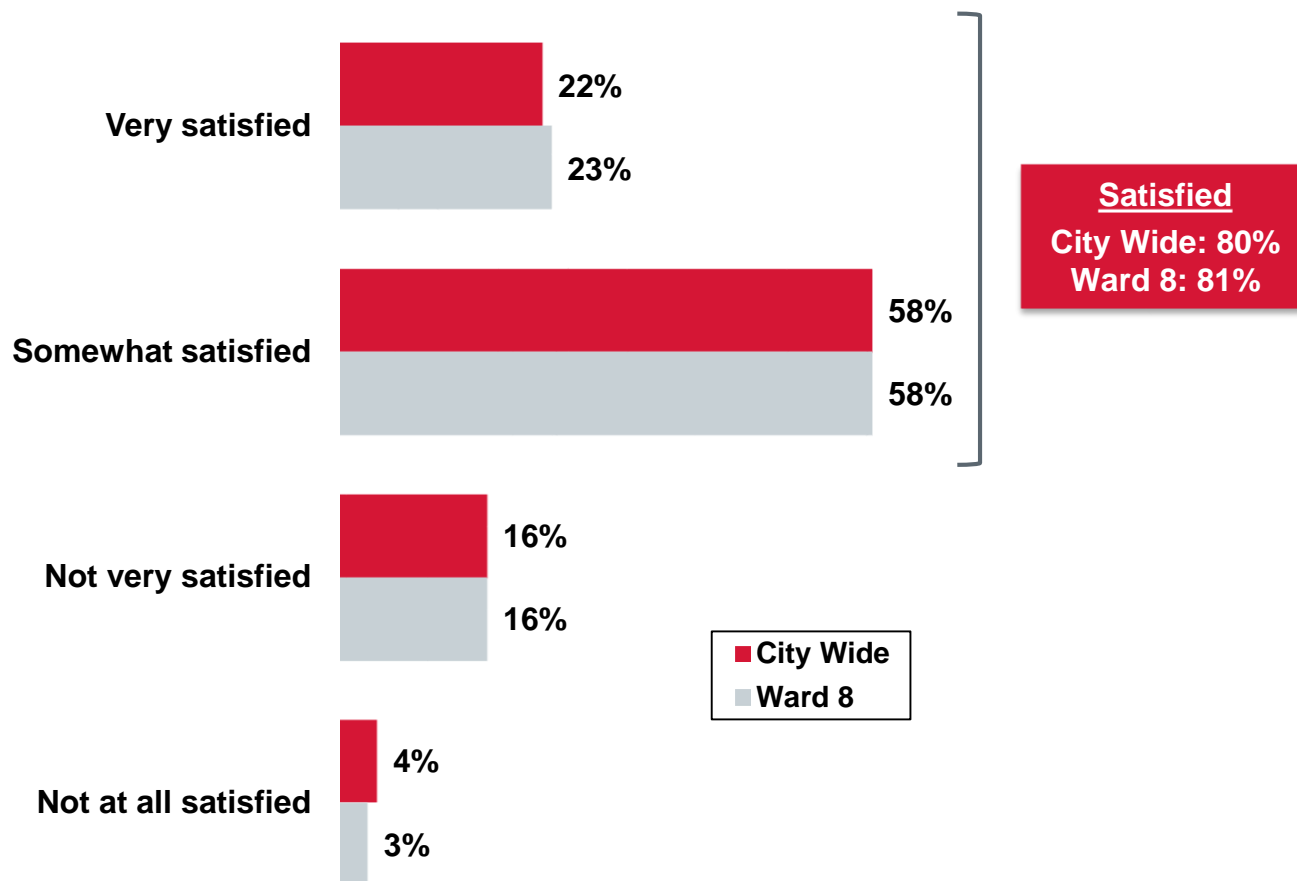

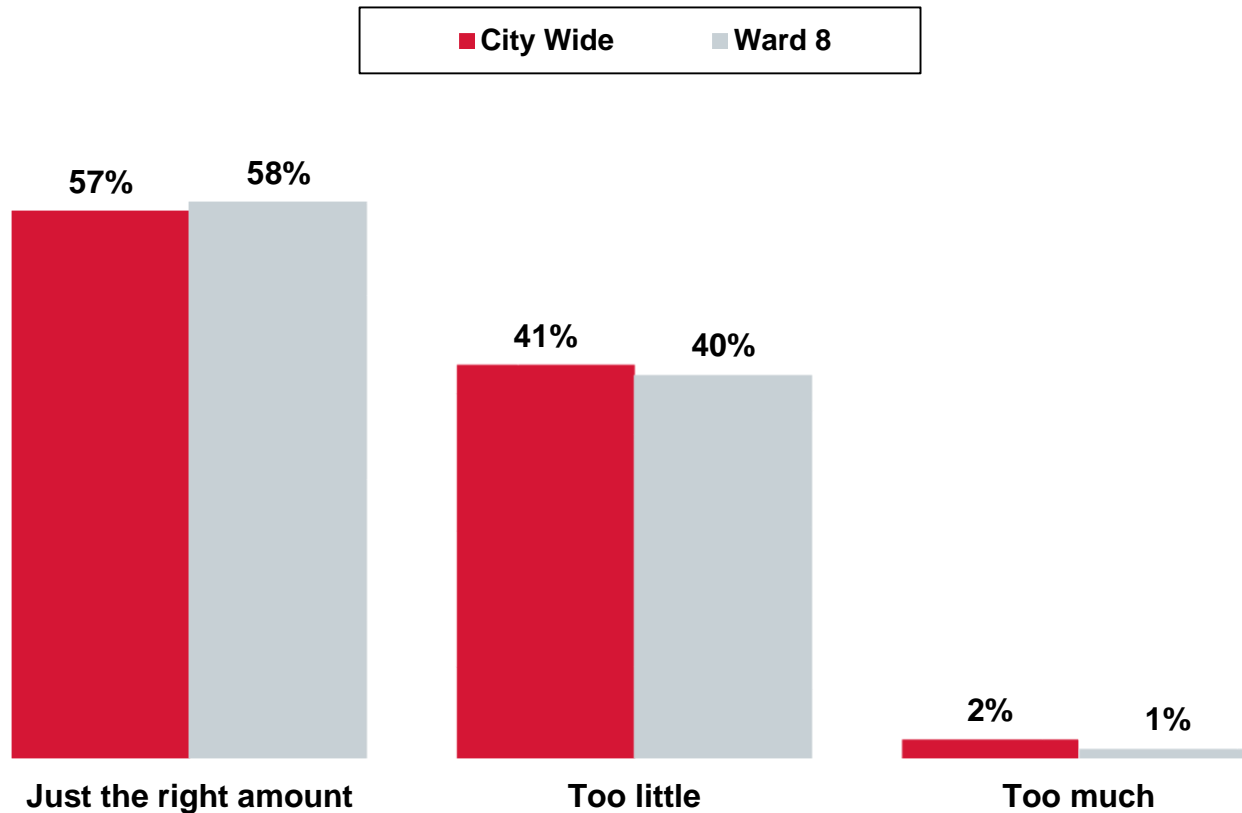
Satisfaction with the Overall Quality of City Information and Communications

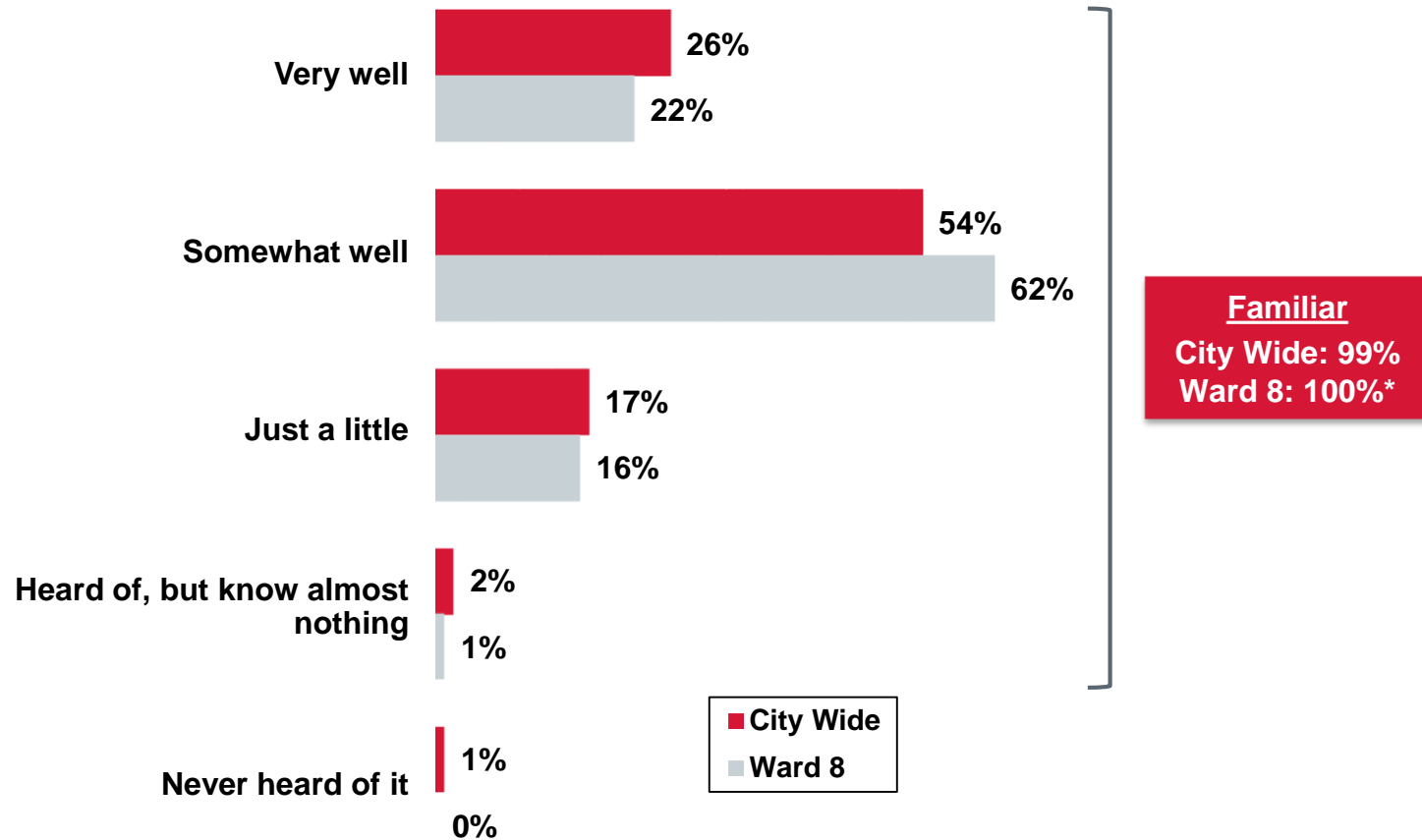




A Model of Reputation

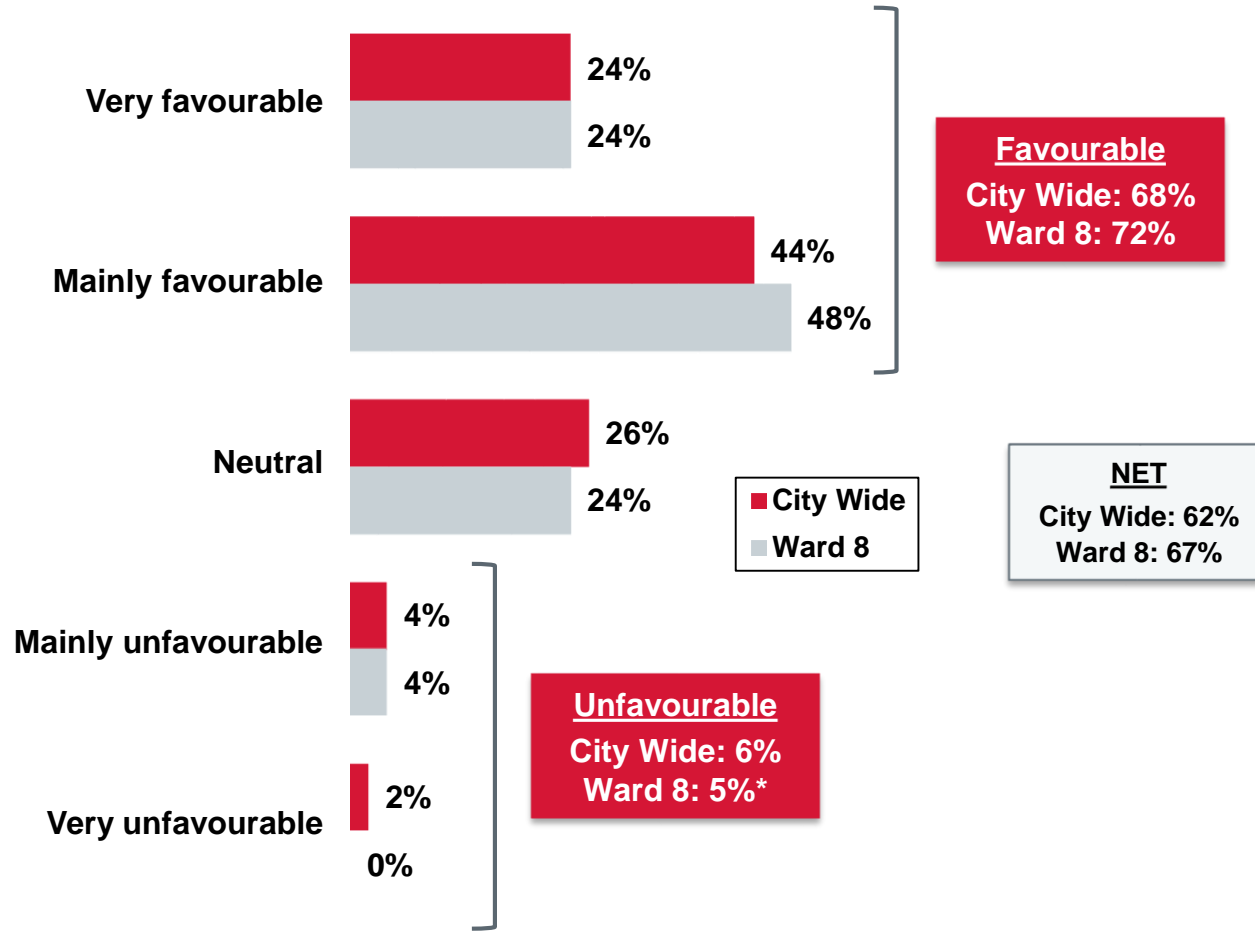

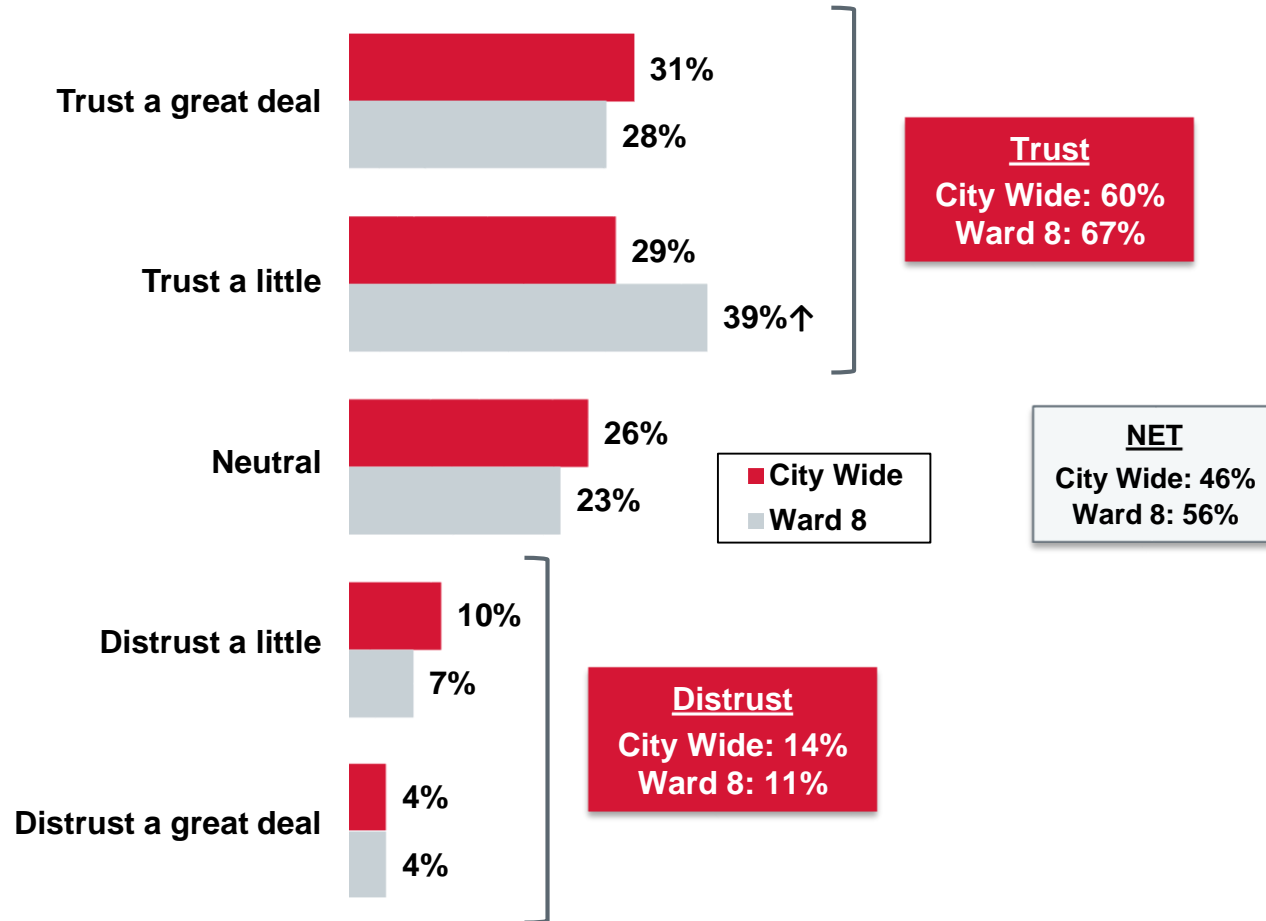

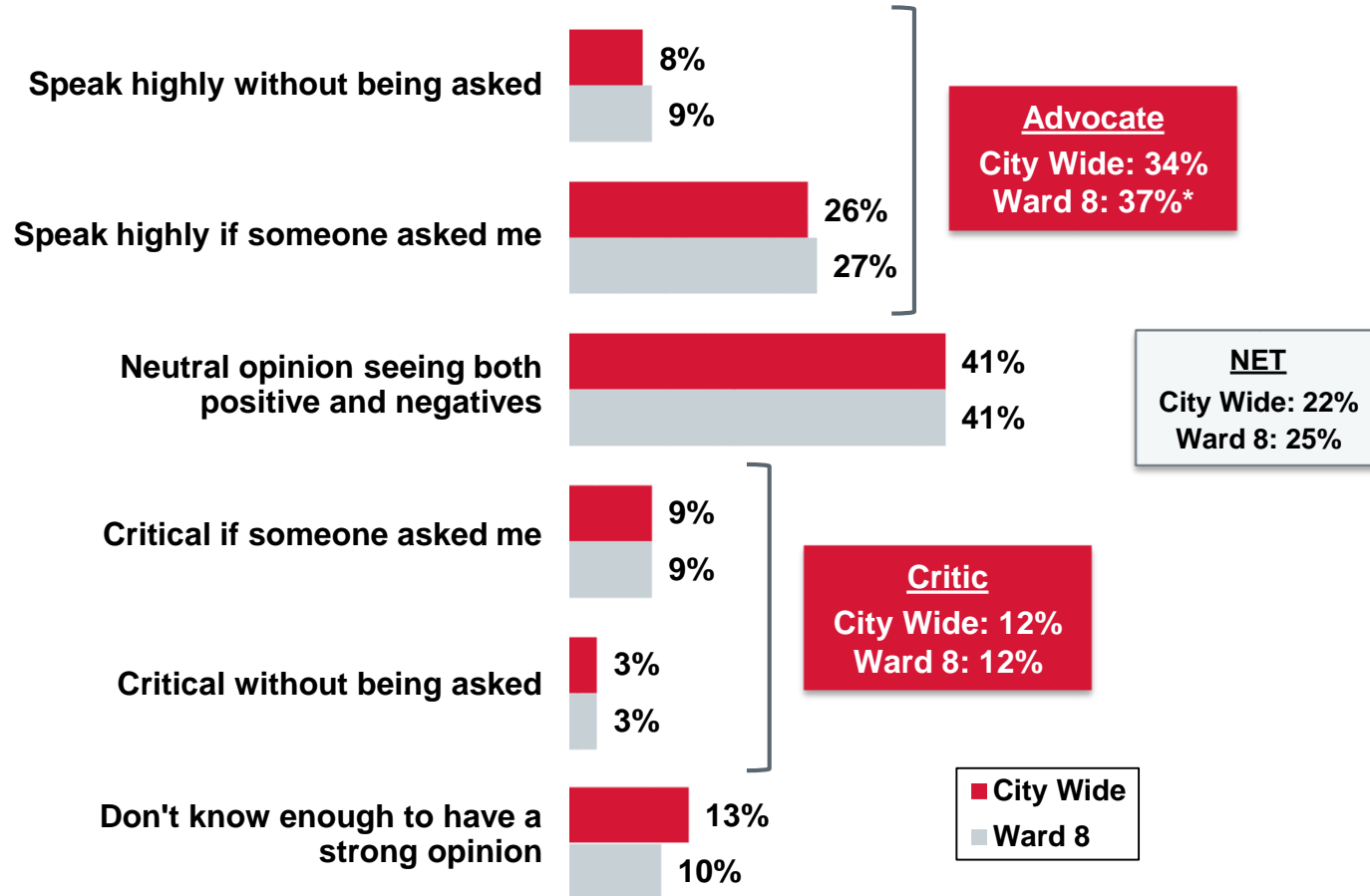


Taking into account all of the things which you think are important, how favourable or unfavourable is your overall opinion or impression of The City of Calgary?

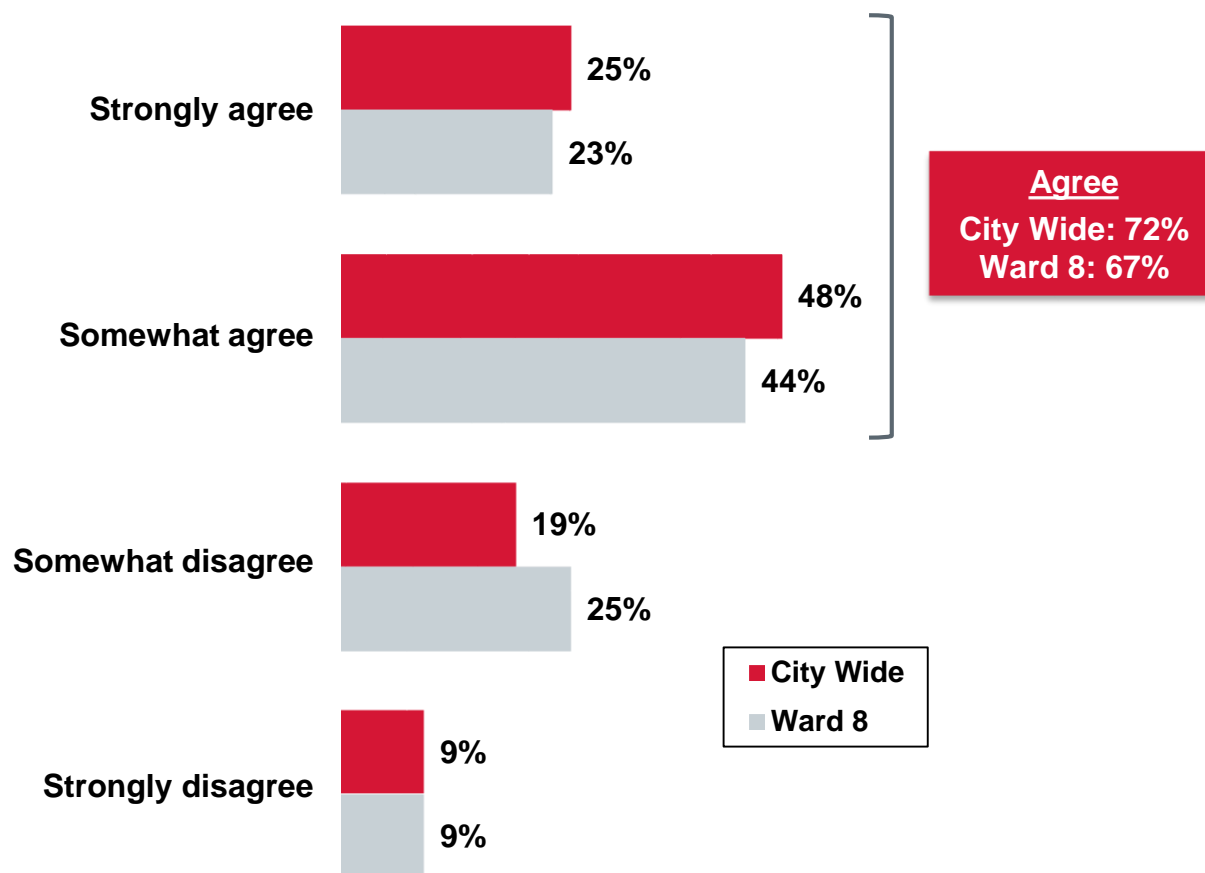


Which one of the following statements best reflects your overall opinion and perceptions of The City of Calgary?

I understand the roles and responsibilities of City Council compared to those of City Administration

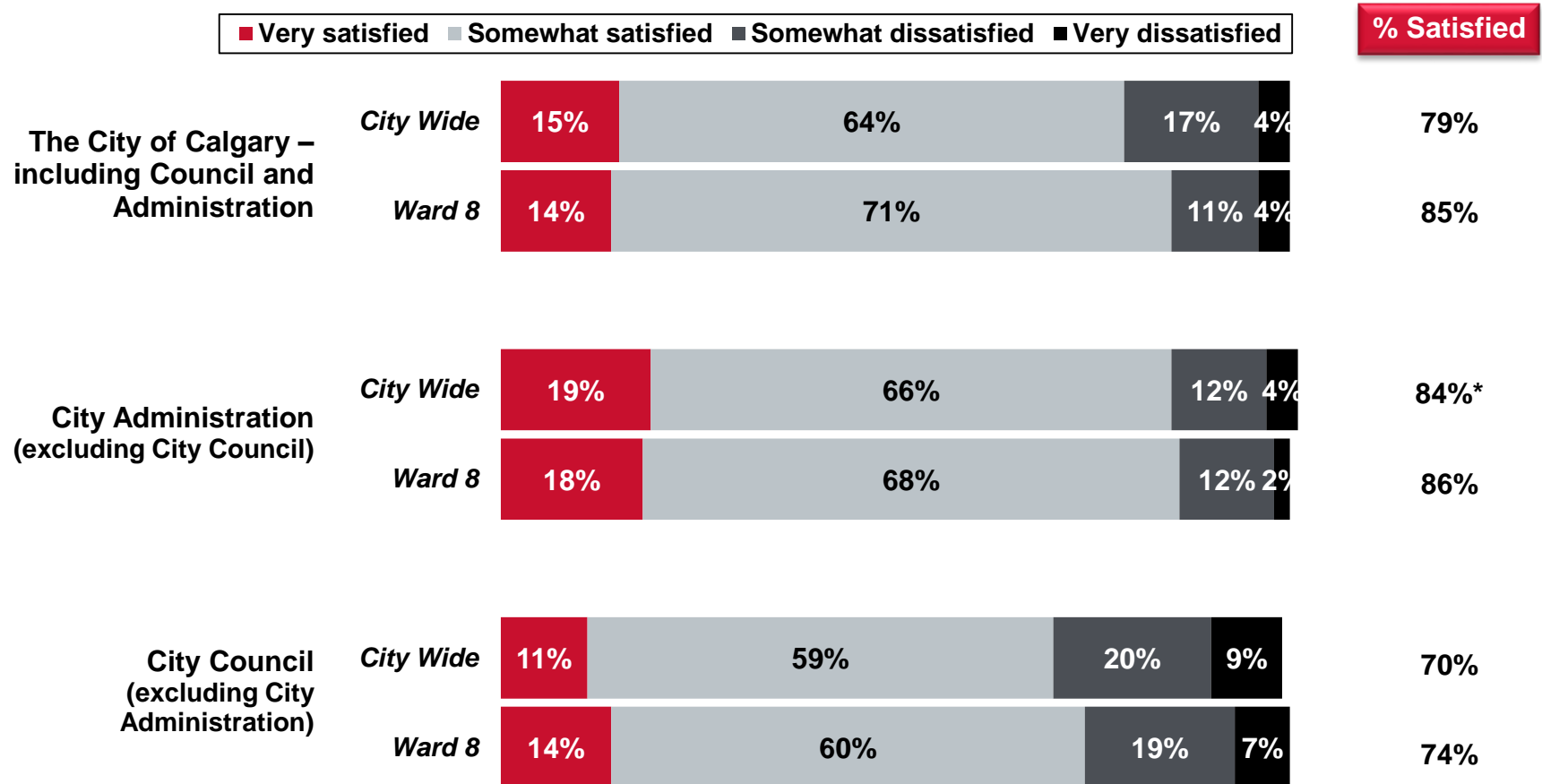

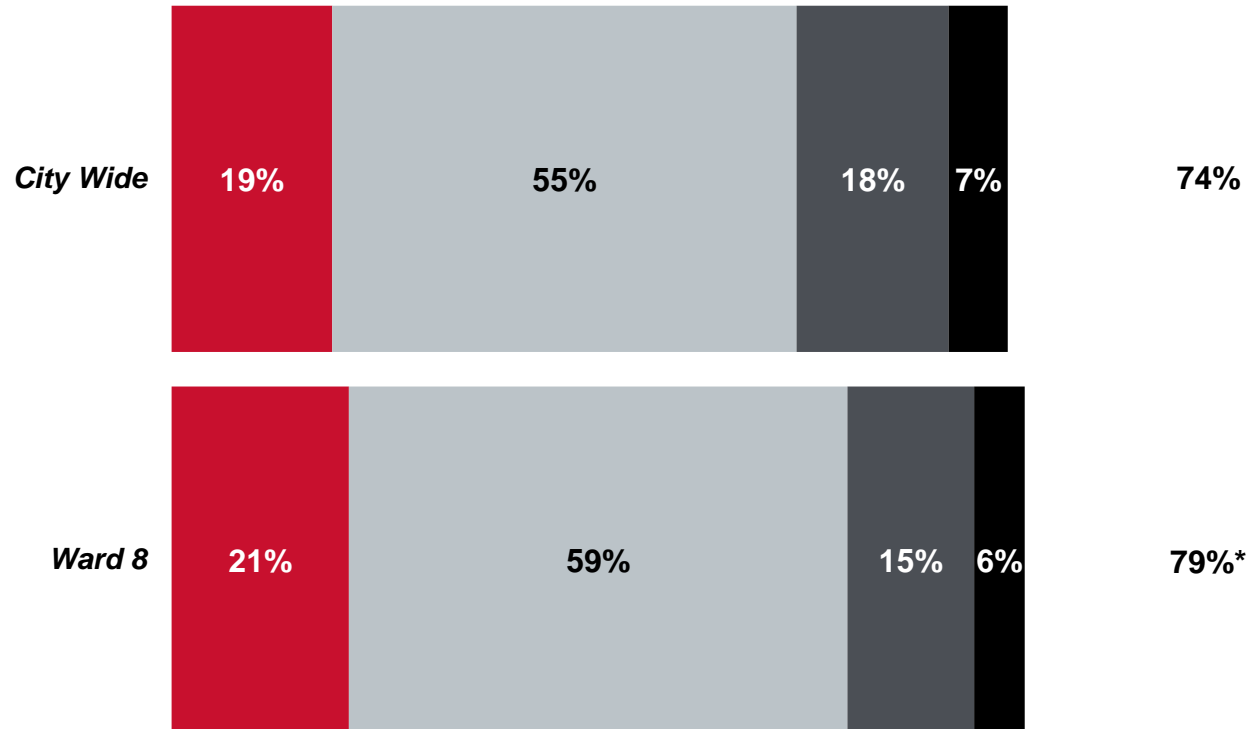

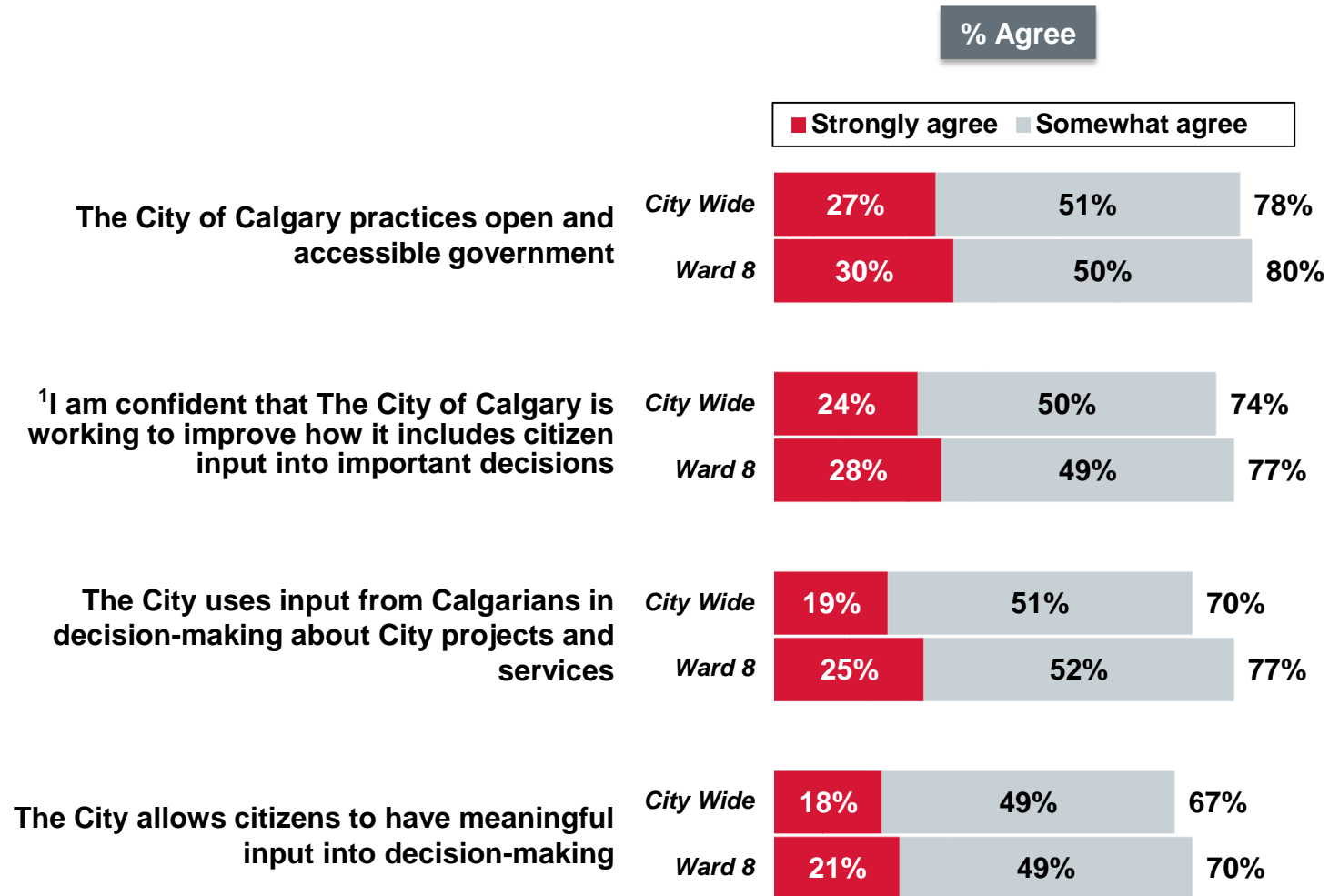
