


Telephone survey conducted with a randomly-selected sample of 2,501 Calgarians aged 18 years and older between August 15th and September 2nd, 2022.


- Both cell phone (60%) and landline (40%) sample were used.
- The average interview length was 32 minutes.



Final data were weighted to ensure the overall sample's quadrant, ward, and age/gender composition reflects that of the actual Calgary population aged 18 or older according to 2019 Municipal and 2021 Federal Census data.



The margin of error (MOE) for the total sample of 2,501 is ± 2.0 percentage points, 19 times out of 20. The margin of error for the Disability in Household sub-group of 516 is ± 4.3 percentage points, 19 times out of 20, and the margin of error for the No Disability in Household sub-group of 1,960 is ± 2.2 percentage points, 19 times out of 20. The margin of error of each question will vary slightly depending on the total number of respondents who answered the question.



Not all questions asked within the Fall Survey of Calgarians are represented within this report. Results are compared between Calgarians who either have a disability or live in the same household as someone with a disability and Calgarians who live in a household without a disability present. Statistically significant differences are noted throughout the report:

- \uparrow indicates number is significantly higher than the other group.
- \downarrow indicates number is significantly lower than the other group.
- Some results in this report are subject to rounding adjustments.

Significant differences are an indication that a difference is not due to chance. A mathematical formula is used to calculate each difference independently. Whether or not a difference is considered significant depends on a few factors including the total sample size and the variability of responses. Larger sample sizes mean that smaller differences are significant. Additionally, variability of responses means that the more alike the responses are the more significant a change will be.



Equity-Deserving Communities

Calgary’s Equity-Deserving Communities (EDCs) are defined as groups of people who generally have less access to opportunities, resources, and systems of power because of their actual or perceived identity or identities. EDCs often experience social and financial disadvantages because of systems of oppression, which takes many forms including, but not limited to, racism, sexism, and ableism. The City would like to better understand the perspective of equity-deserving communities through the lens of the annual Spring and Fall Surveys of Calgarians. The data in this report are from the most recent (2022) Fall Survey of Calgarians, focusing on demographics of interest, specifically those that differentiate equity-deserving communities. Both seasonal surveys are conducted in English to manage time and cost restraints. The City acknowledges the ability to speak English may be a barrier for potential participants. Inclusion in all EDC groups is based on self-reported demographic data captured within the general population survey.

This is one report in an overall set of eight reports on Equity-Deserving Communities. Each report focuses on a different EDC. The EDCs, and the demographic variables used to categorize EDCs, are as follows, with the EDC category noted in bold text:

Gender:

- Male
- **Female**

Note: self-reported (i.e., not inferred by the interviewer); the number of respondents who identified with another category is too small to report separately

Age:

- 18 to 64 years
- **65 years or older**

Note: self reported.

2SLGBTQIA+:

- **2SLGBTQIA+**

Note: self-reported as a member of the 2SLGBTQIA+ community.

Household Income:

- **< \$60,000**
- \$60,000+

Note: self-reported pre-tax annual household income

Disability:

- **Yes**

Note: self-reported. “Yes” includes respondents with a disability as well as respondents who have a family member with a disability; respondents were not asked to identify the specific disability/disabilities

Racialized People:

Note: self-reported racialized status.

Born in Canada:

Note: self reported. foreign-born respondents were not asked for their specific country of origin

Key Findings





Key Findings: Disability in Household

Calgarians who have a disability, or live in the same household as someone with a disability, are less likely than those from households without a disability present to indicate Calgary has a good quality of life.

- Calgarians who have a disability, or live in the same household as someone with a disability, are less likely than households without a disability present to rate the overall quality of life in Calgary as 'good' (74% vs. 82%) and are more likely to rate it as 'poor' (7% vs. 4%).

Calgarians from households with a disability present are less likely than those from households without a disability present to view The City as inclusive.

- In comparison to households without a disability present, households with at least one person with a disability are less likely to agree The City fosters a city that is inclusive and accepting of all (64% vs. 72%) and are almost twice as likely to disagree (15% vs. 8%).
- Calgarians who have a disability or live in the same household as someone with a disability are also much less likely than households without a disability present to agree The City delivers programs and services that remove barriers to participation for Calgarians who need it most (48% vs. 53%).

Both Calgarians from households with a disability present and those from households without a disability present view citizen input opportunities at The City about equally.

- Calgarian households with at least one person who has a disability agree that The City allows citizens to have meaningful input into decision-making at about the same rate as households without a disability present (57% vs. 59%).
- Similarly, Calgarian households with a disability present and those without a disability present are both confident that The City is working to improve how it includes citizen input into important decisions at about the same rate (63% vs. 67%).

Both Calgarians who have a disability, or live in the same household as someone with a disability and Calgarians from a household without a disability present trust The City at about the same rate.

- Slightly under half of all Calgarians (49%) indicate they trust The City, (48% Disability in household vs. 49% No disability in household).



Key Findings: Disability in Household

When compared to households without a disability present, Calgarians who either have a disability or live in the same household as someone with a disability are less likely to be satisfied with Administration.

- There is no significant difference in satisfaction between Calgary households containing at least one person with a disability and Calgary households without a disability present with The City of Calgary, including Council and Administration as a whole (68% vs. 71%) or with City Council (60% vs. 63%).
- However, Calgarians who have a disability, or live in the same household as someone with a disability, are less likely than households without a disability to be satisfied with Administration (74% vs. 79%) and are significantly more likely to be dissatisfied (26% vs. 21%).

Both Calgarians from households with a disability present and those from households without a disability present have similar views on the environment.

- Calgary households that contain at least one person with a disability and those without a disability present indicate about equal satisfaction with The City's performance to protect the environment (77% vs. 79%).
- Although there is no significant difference in agreement that we need to act now to address climate change between households containing at least one person with a disability (66%) and households without a disability present (64%), those from households with a disability are more likely to 'completely agree' (36% vs. 30%).

Calgarians from households with a disability present and those from households without a disability present agree The City is doing a good job on each of the Council focus areas reported on at about the same rate.

- About four-in-five (81%) Calgary households agree The City is doing a good job working to build meaningful relationships with Indigenous partners, regardless of whether there is at least one person with a disability living in the household (81%) or if there is no disability present (81%).
- Calgarians who have a disability or live in the same household as someone with a disability, and households without a disability present agree that The City is doing a good job working with local Indigenous communities when discussing downtown revitalization at about the same rate (67% vs. 72%).



Key Findings: Disability in Household

Satisfaction with the overall level and quality of services and programs provided by The City is lower among Calgarians who either have a disability or live in the same household as someone with a disability, when compared to those from households without a disability present.

- Calgarians who have a disability, or live in the same household as someone with a disability, are less likely than households without a disability present to be satisfied with the overall level and quality of services and programs provided by The City (60% vs. 68%) and are more likely to be dissatisfied (13% vs. 9%).
- In general, Calgary households that contain at least one person with a disability are less likely than households without a disability present to be satisfied in a large number of City services, including The Calgary Fire Department (95% vs. 98%), Calgary's pathway system (89% vs. 95%), protection from river flooding (90% vs. 94%), disaster planning and response (90% vs. 94%), residential Blue Cart recycling (90% vs. 94%), City operated recreation facilities (84% vs. 91%), community services (81% vs. 88%), City operated roads and infrastructure (79% vs. 86%), social programs (69% vs. 83%), snow removal (66% vs. 76%), on-street bikeways (60% vs. 67%), and affordable housing (40% vs. 58%).
- There are no services with significantly higher satisfaction ratings among Calgarians from households with a disability present when compared to those from households without a disability present.

Calgarians who have a disability, or live in the same household as someone with a disability are more likely to want The City to 'invest more' in a number of services when compared to Calgarians who live in a household without a disability present.

- In comparison with Calgarians without a disability present, Calgarians who live in a household with a disability present are more likely to want to invest more in a number of services, including affordable housing (80% vs. 73%), social programs (75% vs. 68%), 911 (65% vs. 58%), snow removal (62% vs. 53%), City operated roads and infrastructure (54% vs. 46%), the Calgary Fire Department (57% vs. 41%), 311 (43% vs. 29%), and residential garbage collection (28% vs. 20%).
- Calgarians from households with a disability present are also more likely to indicate a desire to 'invest less' in support for arts and culture (19% vs. 12%) and development and building inspections and permits (11% vs. 6%).






Overall Quality of Life: Disability in Household

Calgarians who have a disability, or live in the same household as someone with a disability, are less likely than households without a disability present to rate the overall quality of life in Calgary as 'good' (74% vs. 82%) and are more likely to rate it as 'poor' (7% vs. 4%).








Perceptions of Inclusion: Disability in Household

In comparison to households without a disability present, households with at least one person with a disability are less likely to agree The City fosters a city that is inclusive and accepting of all (64% vs. 72%) and are almost twice as likely to disagree (15% vs. 8%).



Perceptions of Removing Barriers: Disability in Household

Calgarians who have a disability or live in the same household as someone with a disability are less likely than households without a disability present to agree The City delivers programs and services that remove barriers to participation for Calgarians who need it most (48% vs. 53%).






Perceptions of Citizen Input – Opportunities: Disability in Household






Perceptions of Use of Citizen Input: Disability in Household

More than half of Calgarian households, regardless of if they contain a person with a disability or not, agree The City uses input from Calgarians in decision-making about City projects and services (59% disability in household vs. 63% no disability in household).







Perceptions About City Performance: Disability in Household

There is no significant difference in satisfaction with The City of Calgary, including Council and Administration as a whole, between Calgary households containing at least one person with a disability (68%) and Calgary households without a disability present (71%).

Satisfaction with The City of Calgary, including Council and City Administration as a whole.




Taking everything into account, how satisfied or dissatisfied are you with the way The City of Calgary - including Council and City Administration as a whole - is going about running our City? Are you ...?

Perceptions About City Performance: Disability in Household (cont.)

Thinking about Calgary's City Council, EXCLUDING City Administration, how satisfied or dissatisfied are you with the way City Council is going about running our City?




However, Calgarians who have a disability, or live in the same household as someone with a disability, are less likely than households without a disability to be satisfied with Administration (74% vs. 79%) and are significantly more likely to be dissatisfied (26% vs. 21%).






Perceptions About Environment: Disability in Household

About three-quarters (78%) of Calgarians indicate satisfaction with The City’s performance to protect the environment, with no significant difference between Calgary households that contain at least one person with a disability and those without a disability present (77% vs. 79%).




We Need to Act Now to Address Climate Change: Disability in Household

Although there is no significant difference in agreement that we need to act now to address climate change between households containing at least one person with a disability (66%) and households without a disability present (64%), those from households with a disability are more likely to ‘completely agree’ (36% vs. 30%).







Indigenous Relations: Disability in Household







Celebrating Culture, History, and Diversity: Disability in Household

Agreement that The City is working to ensure Calgary is seen as a city that celebrates culture, heritage, and diversity is consistent across Calgarian households with just under nine-in-ten (89%) agreeing, regardless of if at least one person with a disability lives in the household (88%) or if there is no disability present (89%).






Satisfaction with the Overall Level and Quality of City Services and Programs: Disability in HH

Satisfaction with City Programs and Services: Disability in Household

In general, Calgary households that contain at least one person with a disability are less likely than households without a disability present to be satisfied in many City services, including The Calgary Fire Department (95% vs. 98%) and Calgary’s pathway system (89% vs. 95%), among numerous others.

Calgary households with at least one person with a disability are less likely than households that do not have a person with a disability to be satisfied with community services (81% vs. 88%), City operated roads and infrastructure (79% vs. 86%) and social programs for individuals such as seniors or youth (69% vs. 83%).

Satisfaction with City Programs and Services: Disability in Household

Calgary households with at least one person with a disability are less likely than households without a disability present to be satisfied with snow removal (66% vs. 76%), on-street bikeways (60% vs. 67%), and affordable housing for low-income families (40% vs. 58%).
