


Telephone survey conducted with a randomly-selected sample of 2,501 Calgarians aged 18 years and older between August 15th and September 2nd, 2022.

- Both cell phone (60%) and landline (40%) sample were used.
- The average interview length was 32 minutes.



Final data were weighted to ensure the overall sample's quadrant, ward, and age/gender composition reflects that of the actual Calgary population aged 18 or older according to 2019 Municipal and 2021 Federal Census data.



The margin of error (MOE) for the total sample of 2,501 is ± 2.0 percentage points, 19 times out of 20. The margin of error for the Female sub-group of 1,238 is ± 2.8 percentage points, 19 times out of 20, and the margin of error for the Male sub-group of 1,247 is ± 2.8 percentage points, 19 times out of 20. The margin of error of each question will vary slightly depending on the total number of respondents who answered the question.



Not all questions asked within the Fall Survey of Calgarians are represented within this report. Results are compared between Female Calgarians and Male Calgarians. Statistically significant differences are noted throughout the report:

- \uparrow indicates number is significantly higher than the other group.
- \downarrow indicates number is significantly lower than the other group.
- Some results in this report are subject to rounding adjustments.

Significant differences are an indication that a difference is not due to chance. A mathematical formula is used to calculate each difference independently. Whether or not a difference is considered significant depends on a few factors including the total sample size and the variability of responses. Larger sample sizes mean that smaller differences are significant. Additionally, variability of responses means that the more alike the responses are the more significant a change will be.



Calgary’s Equity-Deserving Communities (EDCs) are defined as groups of people who generally have less access to opportunities, resources, and systems of power because of their actual or perceived identity or identities. EDCs often experience social and financial disadvantages because of systems of oppression, which takes many forms including, but not limited to, racism, sexism, and ableism. The City would like to better understand the perspective of equity-deserving communities through the lens of the annual Spring and Fall Surveys of Calgarians. The data in this report are from the most recent (2022) Fall Survey of Calgarians, focusing on demographics of interest, specifically those that differentiate equity-deserving communities. Both seasonal surveys are conducted in English to manage time and cost restraints. The City acknowledges the ability to speak English may be a barrier for potential participants. Inclusion in all EDC groups is based on self-reported demographic data captured within the general population survey.

This is one report in an overall set of eight reports on Equity-Deserving Communities. Each report focuses on a different EDC. The EDCs, and the demographic variables used to categorize EDCs, are as follows, with the EDC category noted in bold text:

Gender:

- Male
- **Female**

Note: self-reported (i.e., not inferred by the interviewer); the number of respondents who identified with another category is too small to report separately

Age:

- 18 to 64 years
- **65 years or older**

Note: self reported.

2SLGBTQIA+:

- **2SLGBTQIA+**
- Non-2SLGBTQIA+

Note: self-reported as a member of the 2SLGBTQIA+ community.

Household Income:

- **< \$60,000**
- \$60,000+

Note: self-reported pre-tax annual household income

Disability:

- **Yes**
- No

Note: self-reported. “Yes” includes respondents with a disability as well as respondents who have a family member with a disability; respondents were not asked to identify the specific disability/disabilities

Racialized People:

- **Yes**
- No

Note: self-reported racialized status.

Born in Canada:

- Born in Canada
- **Born outside Canada**

Note: self reported. foreign-born respondents were not asked for their specific country of origin

Indigenous:

- **Indigenous**

Note: self-reported. Includes First Nations, Métis, Inuit, or an Indigenous self-description.



Key Findings





Quality of life ratings are consistent between Females and Males, although Females are more optimistic about Calgary's future.

- About four-in-five Calgarians (80%) rate the overall quality of life in Calgary today as 'good' with no significant difference between Females (79%) and Males (82%).
- However, Female Calgarians are more likely than Male Calgarians to agree Calgary is on the right track to be a better city 10 years from now (78% vs. 74%).

Both Female and Male Calgarians view Calgary about equally as inclusive.

- There is no significant difference between Females and Males in the agreement that The City fosters a city that is inclusive and accepting of all (69% vs. 72%) or that The City delivers programs and services that remove barriers to participation for Calgarians who need it most (52% vs. 53%).

Females and Males perceive current citizen input opportunities similarly, however, Females believe The City is working to make these opportunities better in the future.

- There is no significant difference between the proportions of Female and Male Calgarians who agree The City allows citizens to have meaningful input into decision-making (59% vs. 58%).
- Similarly, about three-fifths of Calgarians (62%), regardless of gender, agree The City uses input from Calgarians in decision-making about City projects and services (63% Females vs. 61% Males).
- However, Female Calgarians are significantly more likely than Male Calgarians to agree they are confident The City is working to improve how it includes citizen input into important decisions (69% vs. 63%).

Both Female and Male Calgarians trust The City at about the same rate.

- Slightly under half of all Calgarians (49%) indicate they trust The City, (49% Females vs. 48% Males).



When compared to Males, Female Calgarians have a more positive view of The City.

- Females are more likely than Males to report satisfaction with The City, including Council and Administration (74% vs. 66%) and are less likely to report dissatisfaction (26% vs. 34%).
- When compared to Males, Female Calgarians are also more likely to be satisfied with Council (66% vs. 58%) and with Administration (80% vs. 75%).

Females are more likely than Males to see climate change as an issue but are about equally as satisfied with The City's environmental performance.

- A majority of Calgarians (78%), regardless of gender, are satisfied with The City's performance to protect the environment (79% Females vs. 78% Males).
- Females are more likely than Males to agree we need to act now to address climate change (68% vs. 60%).
- Although Females and Males agree The City has programs and services aimed at helping Calgarians reduce their environmental impact at about the same rate (53% vs. 50%), Females are less likely to disagree (14% vs. 18%).

Males and Females agree The City is doing a good job on each of the Council focus areas reported on at about the same rate.

- Although Females and Males agree overall (strongly + somewhat) at about the same rate (81% of all Calgarians), Females are more likely to 'strongly agree' The City is doing a good job working to build meaningful relationships with Indigenous partners when compared to Males (30% vs. 23%).
- A majority of Calgarians (89%), regardless of gender, agree The City is doing a good job working to ensure Calgary is seen as a city that celebrates culture, heritage, and diversity (90% Females vs. 88% Males). Females are significantly more likely than Males to 'strongly agree' (40% vs. 35%).

Overall satisfaction with City programs and services is about equal between genders, although differences exist at the service level.

- There is no significant difference in the number of Female Calgarians who are satisfied with the overall level and quality of services and programs (67%) and the number of Male Calgarians who are satisfied (66%).
- Females are less likely than Males to be satisfied with two emergency services: the Calgary Fire Department (97% vs. 99%) and 911 (78% vs. 86%).
- Females are more likely than Males to be satisfied with a number of services, including, including Calgary's pathway system (95% vs. 91%), protection from river flooding (95% vs. 92%), residential garbage collection (92% vs. 88%), support for arts and culture (90% vs. 84%), development and building inspections and permits (85% vs. 80%), the City of Calgary website (84% vs. 79%), traffic flow management (79% vs. 71%), property tax assessment (76% vs. 70%), and downtown revitalization (70% vs. 64%).

In comparison with Male Calgarians, Females are less likely to want to 'invest less' in a number of services, and are more likely to want to 'invest more' in others.

- Females are less likely than Male Calgarians to indicate a desire to 'invest more' in small number of transportation related services, including road maintenance (51% vs. 58%), City operated roads and infrastructure (42% vs. 52%), and traffic flow management (42% vs. 50%).
- Conversely, Female Calgarians are more likely than Male Calgarians to report The City should 'invest more' in affordable housing (81% vs. 67%), social programs (78% vs. 62%), 911 (65% vs. 53%), the Calgary Police Service (56% vs. 49%), downtown revitalization (51% vs. 44%), the Calgary Fire Department (49% vs. 39%), City operated recreation programs (48% vs. 35%), community services (47% vs. 36%), and animal control services (20% vs. 14%).
- Females are less likely than Males to want The City to 'invest less' in a large number of services, including property assessment (12% vs. 17%), support for arts and culture (11% vs. 17%), animal control services (6% vs. 13%), residential Blue Cart recycling (6% vs. 10%), the City of Calgary website (6% vs. 10%), support for arts and culture (11% vs. 17%), development and building inspections and permits (5% vs. 10%), transportation planning (4% vs. 7%), disaster planning and response (3% vs. 7%), affordable housing (2% vs. 8%), city operated recreation programs (2% vs. 6%), 311 (1% vs. 7%), Calgary Transit (3% vs. 5%), social programs (1% vs. 3%), and snow removal (1% vs. 3%).







Overall Quality of Life: Gender














Perceptions of Citizen Input – Opportunities: Gender




Perceptions of Citizen Input – Improvement: Gender








Trust in The City: Gender



Perceptions About City Performance: Gender

Females are more likely than Males to report satisfaction with The City, including Council and Administration (74% vs. 66%) and are significantly less likely to report dissatisfaction (26% vs. 34%).



Thinking about Calgary's City Council, EXCLUDING City Administration, how satisfied or dissatisfied are you with the way City Council is going about running our City?
















Indigenous Relations: Gender













Satisfaction with the Overall Level and Quality of City Services and Programs: Gender

Overall, Females are satisfied with a higher number of City services than Males, including Calgary’s pathway system (95% vs. 91%), protection from river flooding (95% vs. 92%), residential garbage collection service (92% vs. 88%), and support for arts and culture (90 vs. 84% - next slide).

Females are also more likely than Males to indicate satisfaction with traffic flow management (79% vs. 71%), property tax assessment (76% vs. 70%), downtown revitalization (70% vs. 64%). development and building inspections and permits (85% vs. 80% - prev. slide, and the City website (84% vs. 79% - prev. slide).

Invest More: Gender

Overall, Females are less likely than Males to indicate their preference to invest more in some aspects of transportation, including road maintenance (51% vs. 58%), City operated roads and infrastructure (42% vs. 52%), and traffic flow management (42% vs 50%).
