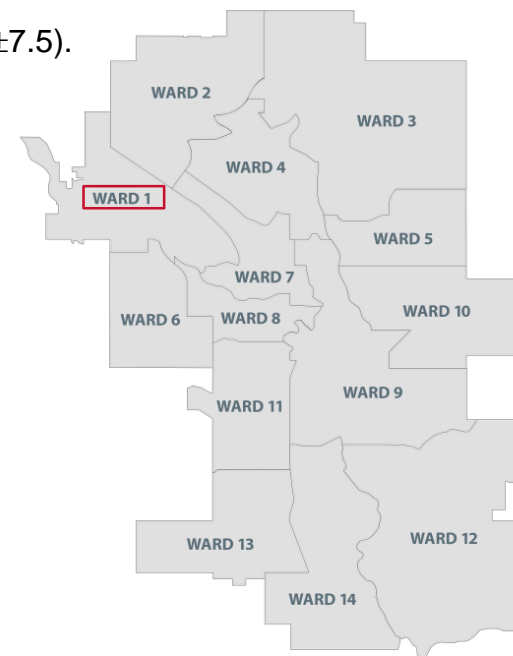

- ❖ Telephone survey conducted with a randomly selected sample of 2,500 Calgarians aged 18 years and older between August 18th and September 6th, 2016.
 - Both landline (70%) and cell phone (30%) sample were used.
 - The average interview length was 31 minutes.
- ❖ Final data were weighted to ensure the overall sample's quadrant, ward and age/gender composition reflects that of the actual Calgary population aged 18 or older according to 2011 Federal Census data.
- ❖ The margin of error (MOE) for the total sample of 2,500 is ± 2.0 percentage points, 19 times out of 20.
 - A total of 183 interviews were conducted with residents of Ward 1 (MOE ± 7.5).
- ❖ Research Note on significant differences:
 - Throughout, City Wide results are compared to results from Ward 1.
 - \uparrow indicates a number is significantly higher than City Wide.
 - \downarrow indicates a number is significantly lower than City Wide.
- ❖ Where possible, 2016 results for Ward 1 are compared to those from 2015.
 - Only significant differences are shown.





Summary of Key Findings



- ❖ The last twelve months have proven to be difficult for our city, with the impacts of a slowed economy being felt more acutely than in 2015. With Calgary's unemployment rate climbing from 6.8% in 2015 to 8.6% in 2016, downtown office vacancy rates at near record levels, and the value of building permits forecasted to be significantly lower than 2015, speculation continues about whether we will see an upswing as we move into 2017.
- ❖ Despite facing challenging times, many Calgarians as a whole remain resilient. A number of surveys, including this one, report that people have a generally optimistic view about the future, and perceptions of their overall quality of life is still quite strong.
- ❖ Our research suggests that Calgarians are looking to government – Federal, Provincial, and Municipal – for leadership and sound investment to strengthen and diversify our economy moving forward. However, Calgarians are also looking to government to be more watchful and aware of how their tax dollars are being spent.
- ❖ This year's Citizen Satisfaction Survey presents a narrative that highlights some **shifts in perceptions that can likely be attributed to the economic downturn**. It is an important editorial note for those reviewing this year's survey.

Key Findings: Quality of Life and Issue Agenda

For Ward 1 residents, perceptions about the quality of life in Calgary are extremely strong, and several metrics are statistically higher than City Wide. That being said, consistent with City Wide, 2016 sees some statistically significant declines.

- ❖ More than nine-in-ten (92%) Ward 1 residents say the quality of life in Calgary today is ‘good,’ 9 percentage points higher than City Wide (83%).
- ❖ Other notable differences are agreement that they are ‘proud to live in their neighbourhood’ (94% Ward 1 vs. 88% City Wide) and they would feel ‘very safe’ walking in their neighbourhood after dark (61% Ward 1 vs. 42% City Wide).
- ❖ As with City Wide, in 2016 more Ward 1 residents say the quality of life in Calgary has ‘worsened’ over the past three years (39% vs. 23% in 2015 vs. 16% in 2014) and fewer say it has ‘improved’ (12% vs. 26% in 2015 vs. 35% in 2014).
 - Further, ratings of an ‘improved’ quality of life are statistically lower among Ward 1 residents than City Wide (12% vs. 18%).
- ❖ Also consistent with City Wide, agreement that ‘Calgary is a great place to make a living’ is down among Ward 1 residents – from 85% in 2015 to 64% in 2016.
- ❖ In keeping with this sentiment, when asked what The City could do to improve the quality of life, 17% of Ward 1 residents say “*reduce taxes*” (statistically higher than 9% City Wide, and up from 7% in 2015) and 14% say “*improve job creation/employment*” (up from 2% in 2015).

The Ward 1 issue agenda aligns closely with City Wide results.

- ❖ “*Infrastructure, traffic and roads*” (36%) holds the top position, followed by “*transit*” (19%).
- ❖ Four issues vie for third place – “*crime, safety and policing*” (13%), “*recreation*” (12%), “*taxes*” (12%) and the “*economy*” (11%).
 - It is notable that mentions of “*taxes*” are up 8 percentage points (from 4% in 2015), while mentions of the “*economy*” are up 9 points (from 2% in 2015).

Key Findings: Satisfaction with City and Programs and Services

Overall satisfaction with the level and quality of City services remains high and mirrors City Wide results.

- ❖ Eight-in-ten (80%) Ward 1 residents say they are satisfied with the overall level and quality of services and programs provided by The City.
- ❖ Among Ward 1 residents, satisfaction with a number of programs and services has increased from 2015 levels and/or is statistically higher than City Wide.
 - The quality of drinking water (99% satisfied vs. 95% City Wide);
 - Calgary's pathway system (65% 'very satisfied' vs. 53% City Wide, and up from 51% in 2015);
 - Disaster planning and response (58% 'very satisfied' vs. 49% City Wide);
 - Residential Blue Cart recycling (71% 'very satisfied' vs. 63% City Wide);
 - Community services (96% satisfied vs. 92% City Wide);
 - Bylaw services (38% 'very satisfied,' up from 25% in 2015);
 - Calgary Transit (31% 'very satisfied,' up from 20% in 2015); snow removal (36% 'very satisfied,' up from 23% in 2015); and,
 - Road maintenance (38% 'very satisfied,' up from 25% in 2015, and 86% satisfied vs. 78% City Wide, and up from 75% in 2015).
- ❖ Also noteworthy is that in the importance versus satisfaction grid analysis, City operated roads and infrastructure emerges as a Primary Strength for Ward 1 residents, while it is a Primary Weakness City Wide.
- ❖ As with City Wide results, satisfaction with property tax assessment sees a marked drop from 82% in 2015 to 69% in 2016.

Key Findings: Investment in City Services and Programs, and Taxation

Consistent with City Wide findings, affordable housing and transportation continue to surface as desired areas for increased investment among Ward 1 residents, though ‘invest more’ ratings for several transportation related services and programs are down.

❖ Particularly notable are:

- Calgary Transit (59% ‘invest more,’ down from 72% in 2015);
- Transportation planning (48% ‘invest more,’ down from 69% in 2015);
- Road maintenance (39% ‘invest more’ vs. 52% City Wide, and down from 58% in 2015);
- Snow removal (38% ‘invest more’ vs. 49% City Wide, and down from 50% in 2015); and,
- Protection from river flooding (29% ‘invest more’ vs. 38% City Wide, and down from 46% in 2015).

As with the broader Calgary public, the perceived value of property tax dollars remains steady while the tolerance for tax increases is down markedly among Ward 1 residents.

- ❖ In 2016, more than six-in-ten (62%) Ward 1 residents give The City a ‘good value’ rating for the value of their property tax dollars.
- ❖ However, just under one-half (47%) support tax increases to maintain or expand services – a 17 percentage point drop from 64% in 2015 – while an equal proportion (47%) support cutting services to maintain or reduce taxes (a 14 point increase from 33% in 2015).

Key Findings: The Environment

Ward 1 residents' perceptions of The City's performance on the environmental front closely align with City Wide findings.

- ❖ Perceptions about the overall state of the environment in Calgary today are extremely positive with 98% of Ward 1 residents saying it is 'good or very good' and more than one-half (56%, up significantly from 39% in 2015) offering a 'very good' rating.
- ❖ With regard to The City's environmental programs and services aimed at helping Calgarians reduce their environmental impact, 'not very satisfied' ratings are down 12 percentage points among Ward 1 residents, from 22% in 2015 to 10% in 2016.

There are no noteworthy differences between Ward 1 residents and the broader Calgary public – or notable changes from 2015 – with regard to contact with The City or City communications.

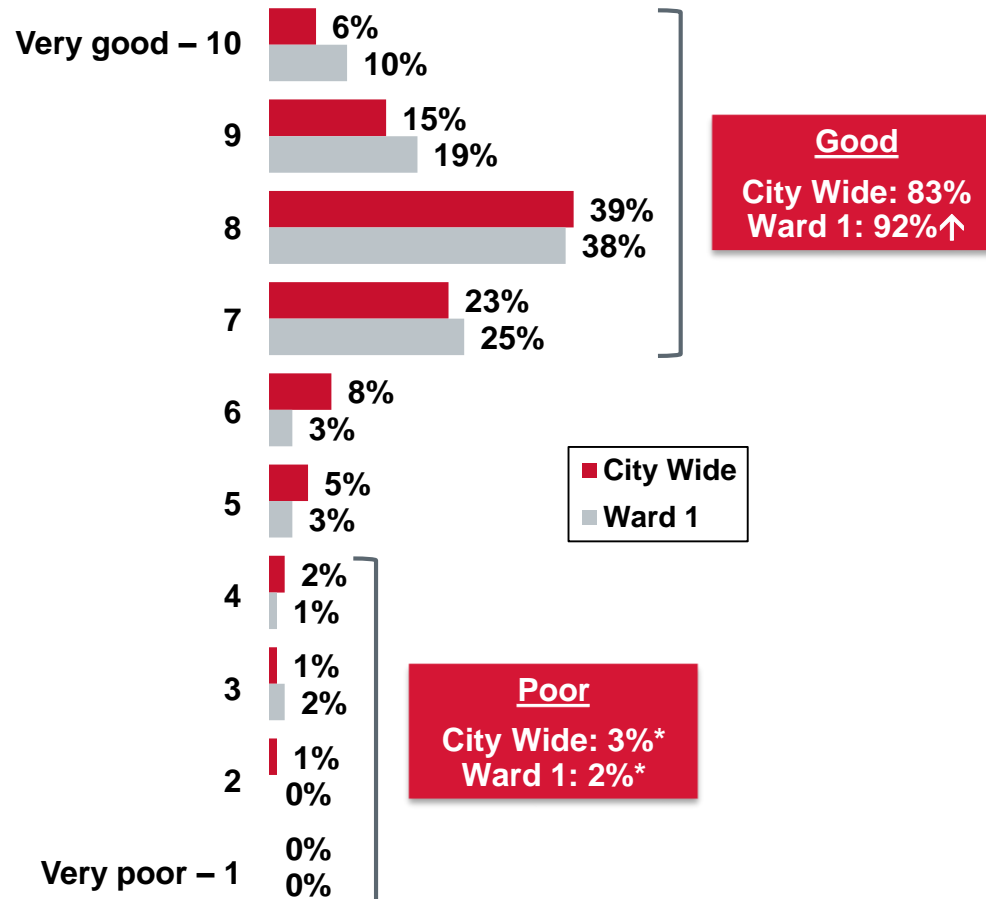

Overall Quality of Life in Calgary

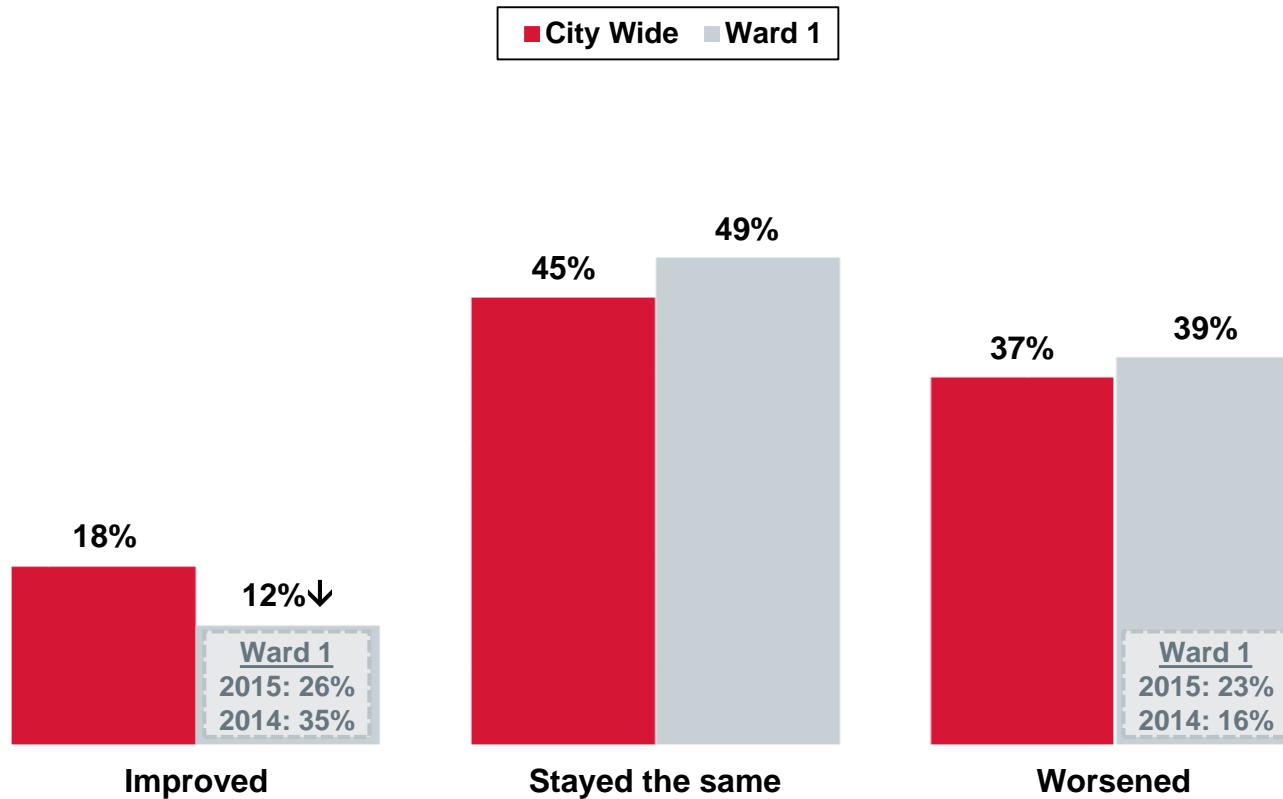

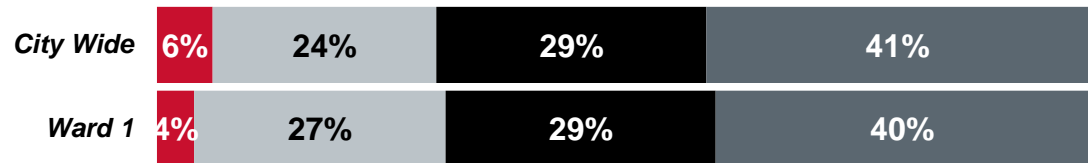

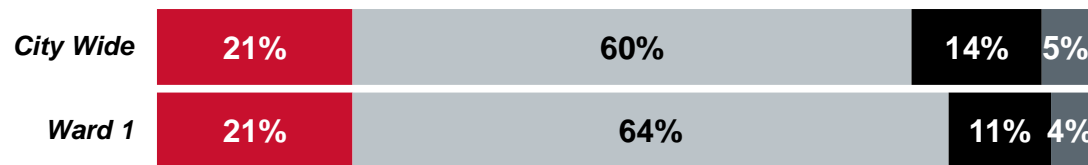

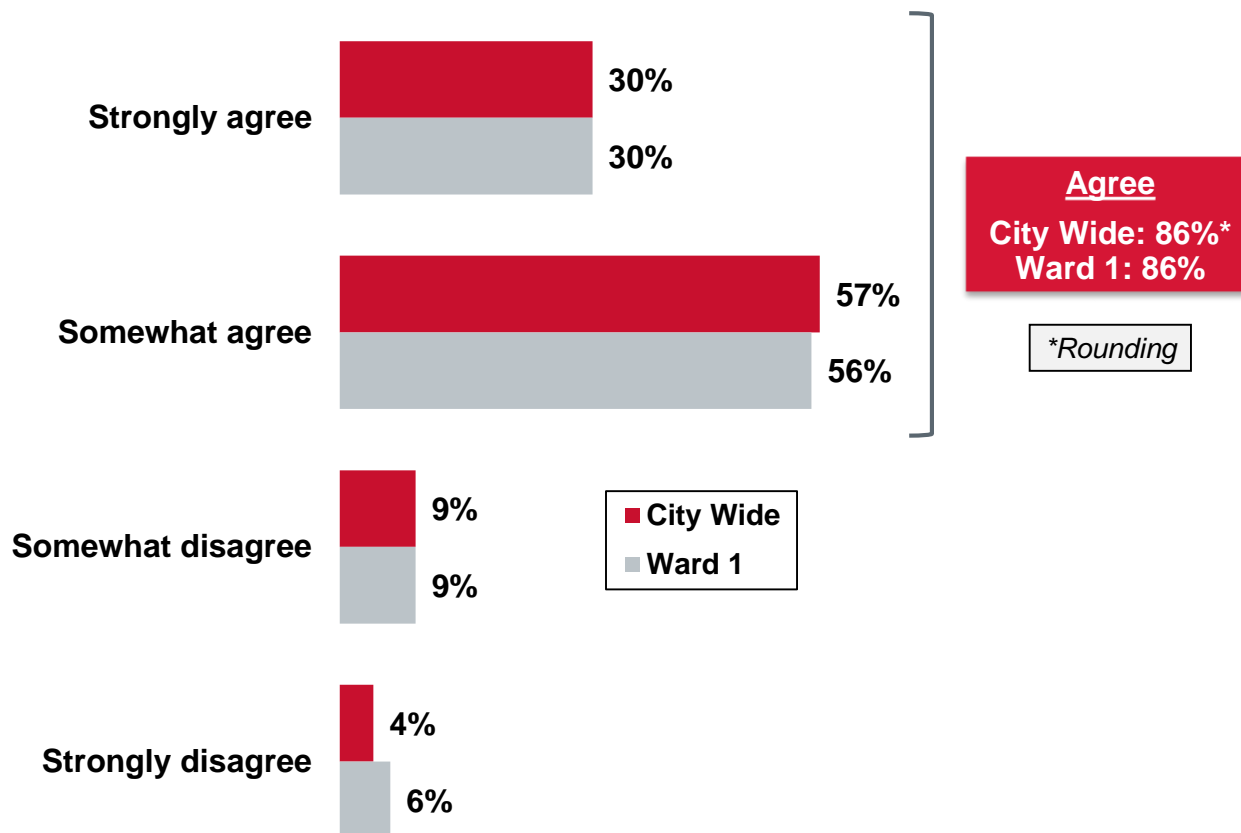

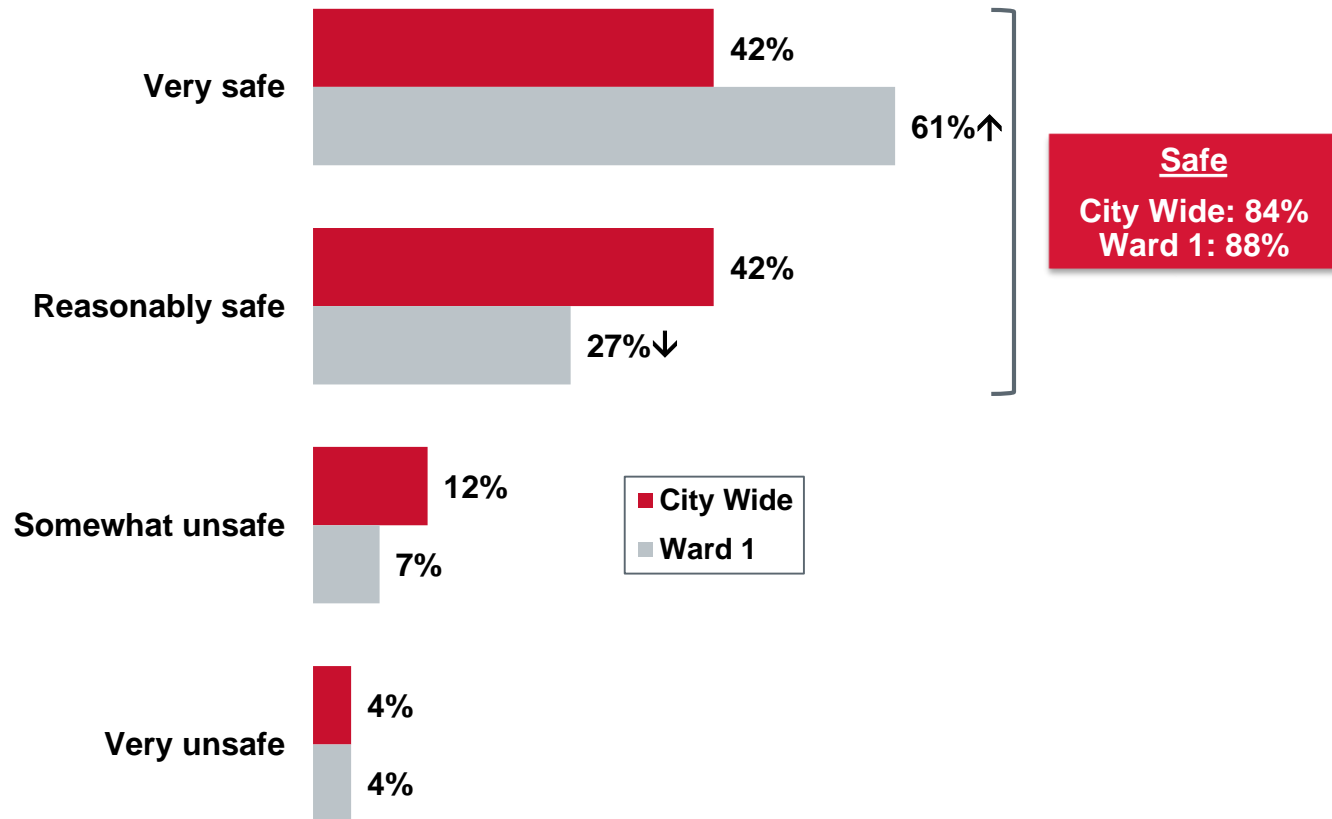

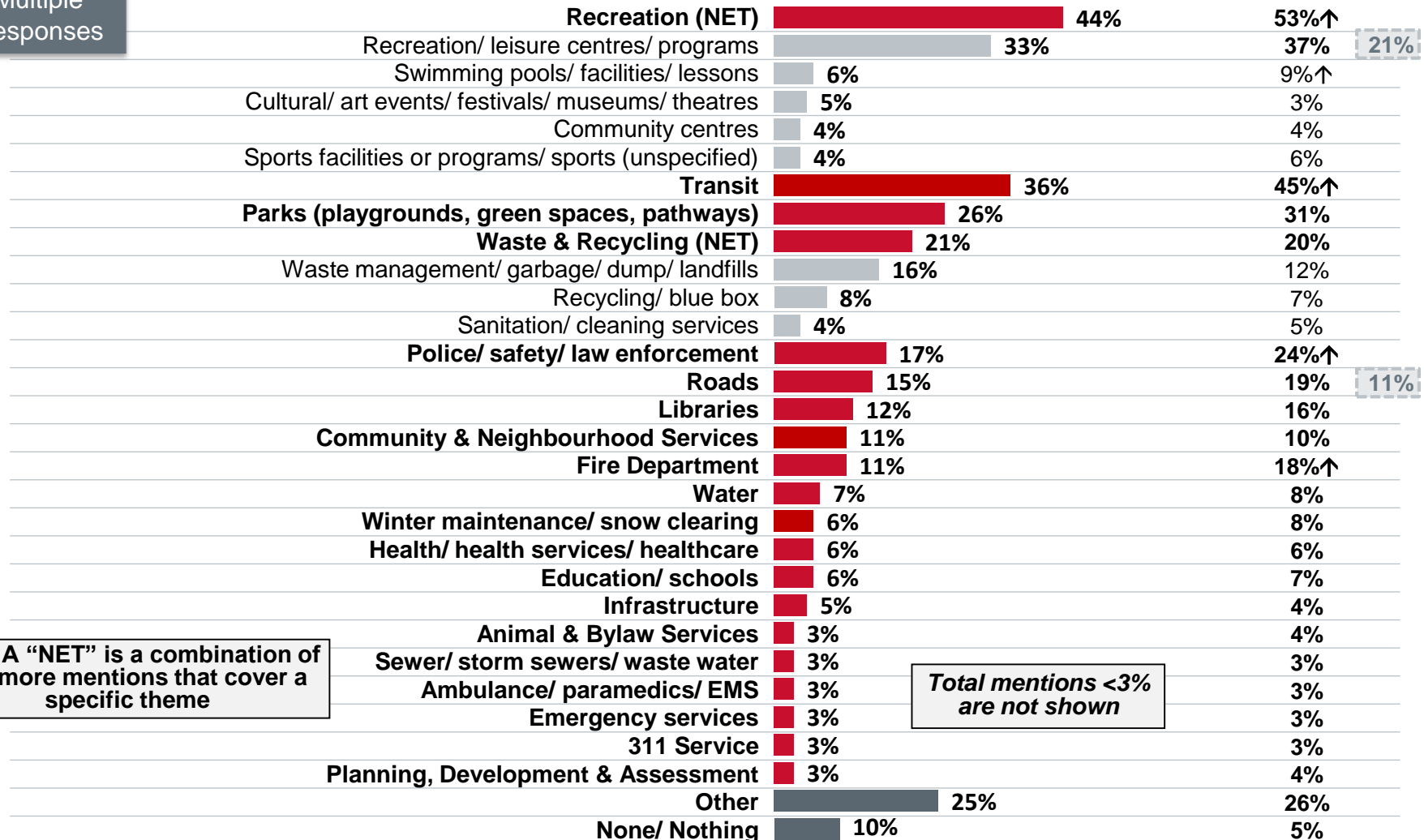

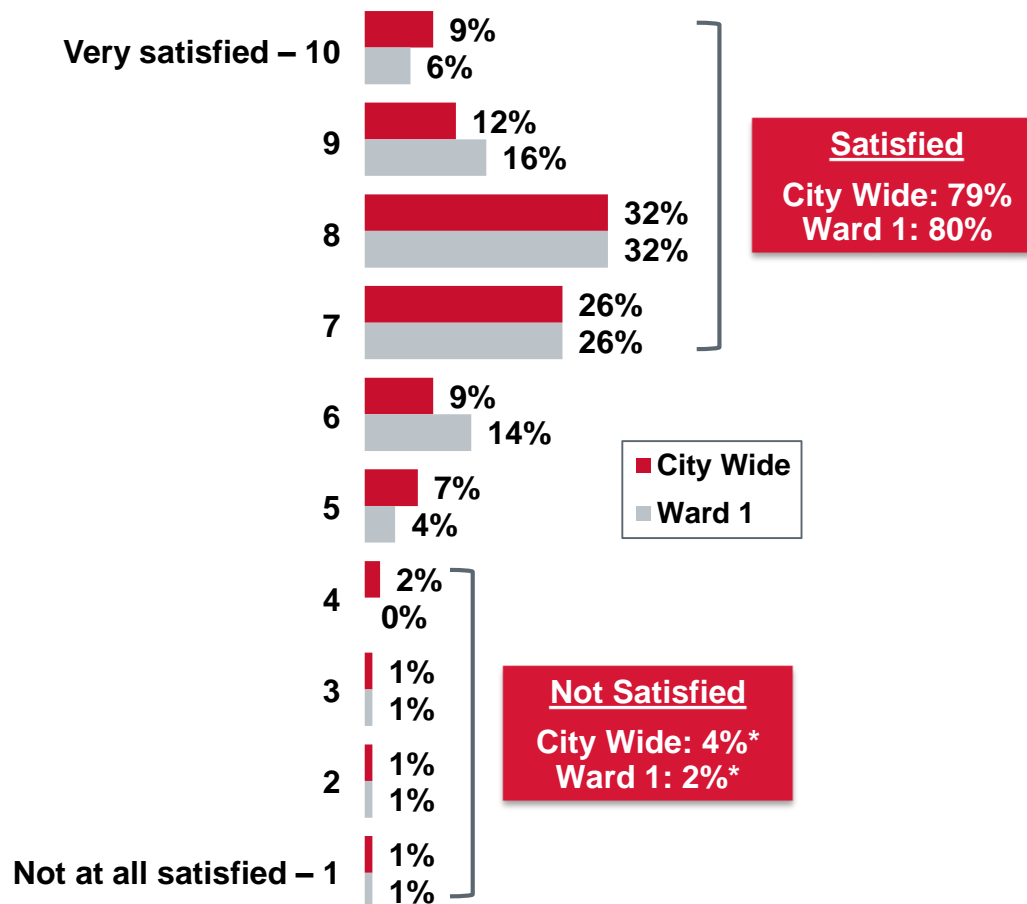

Overall Satisfaction with the Level and Quality of City Services and Programs

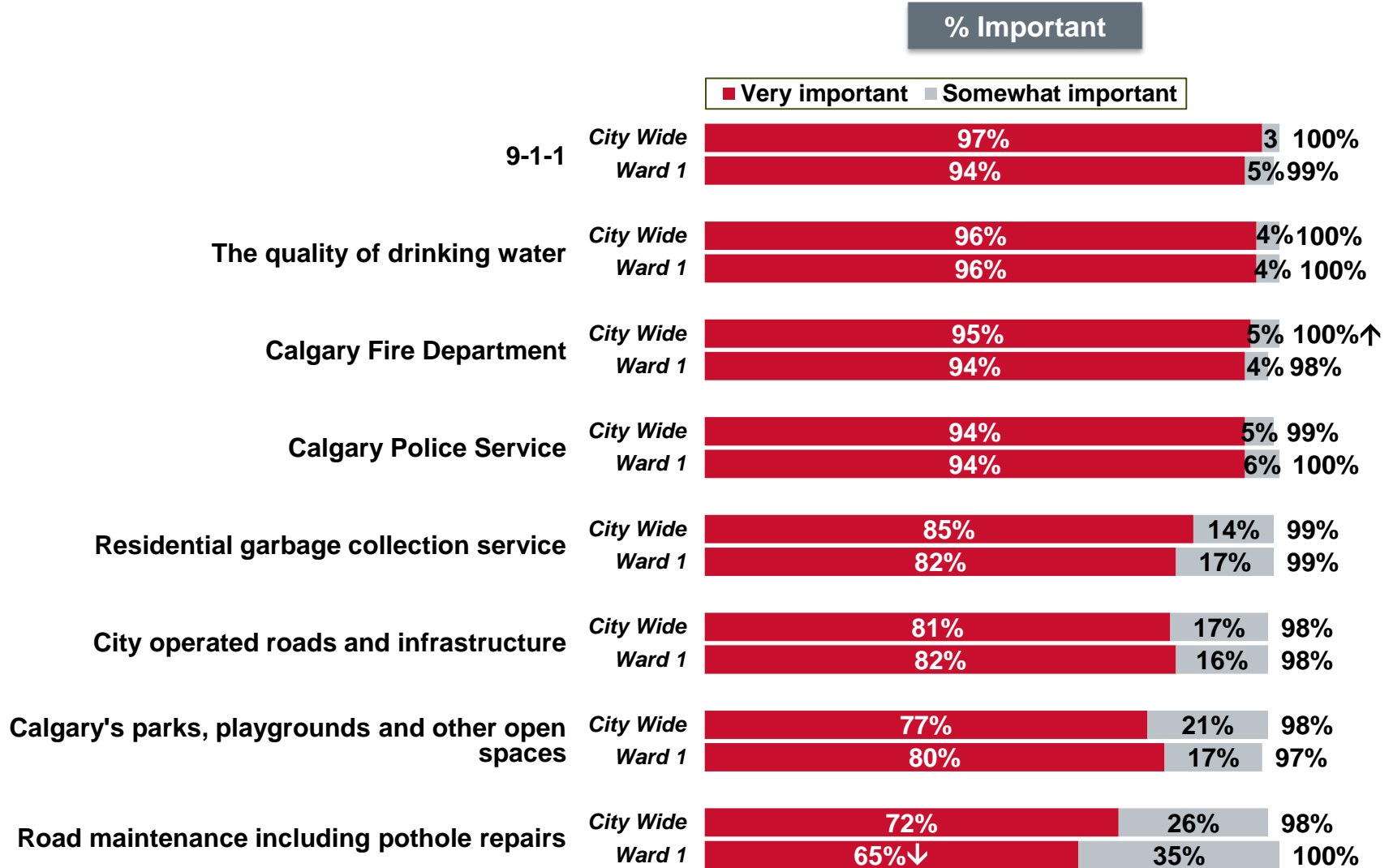

Importance of City Programs and Services



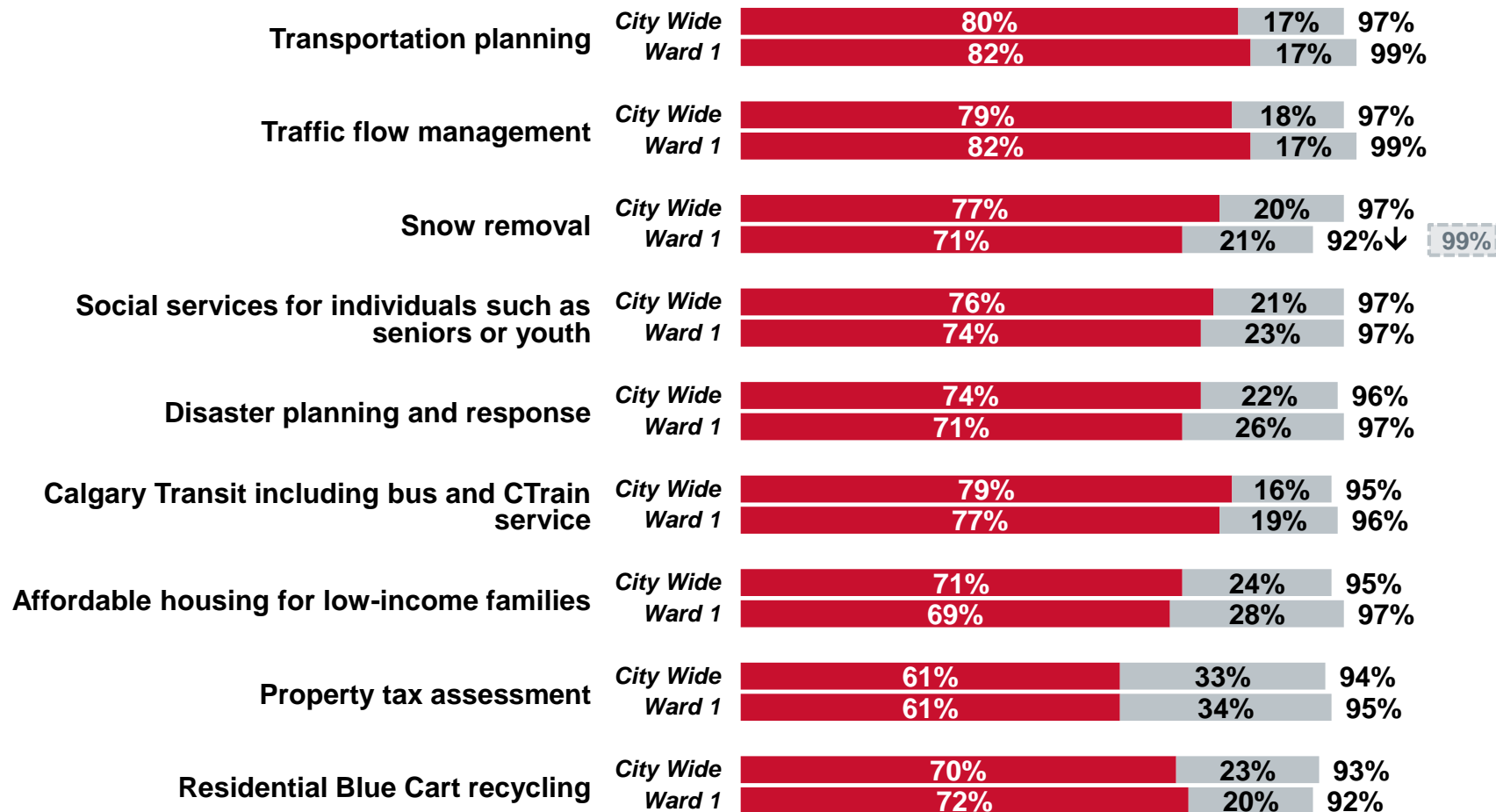

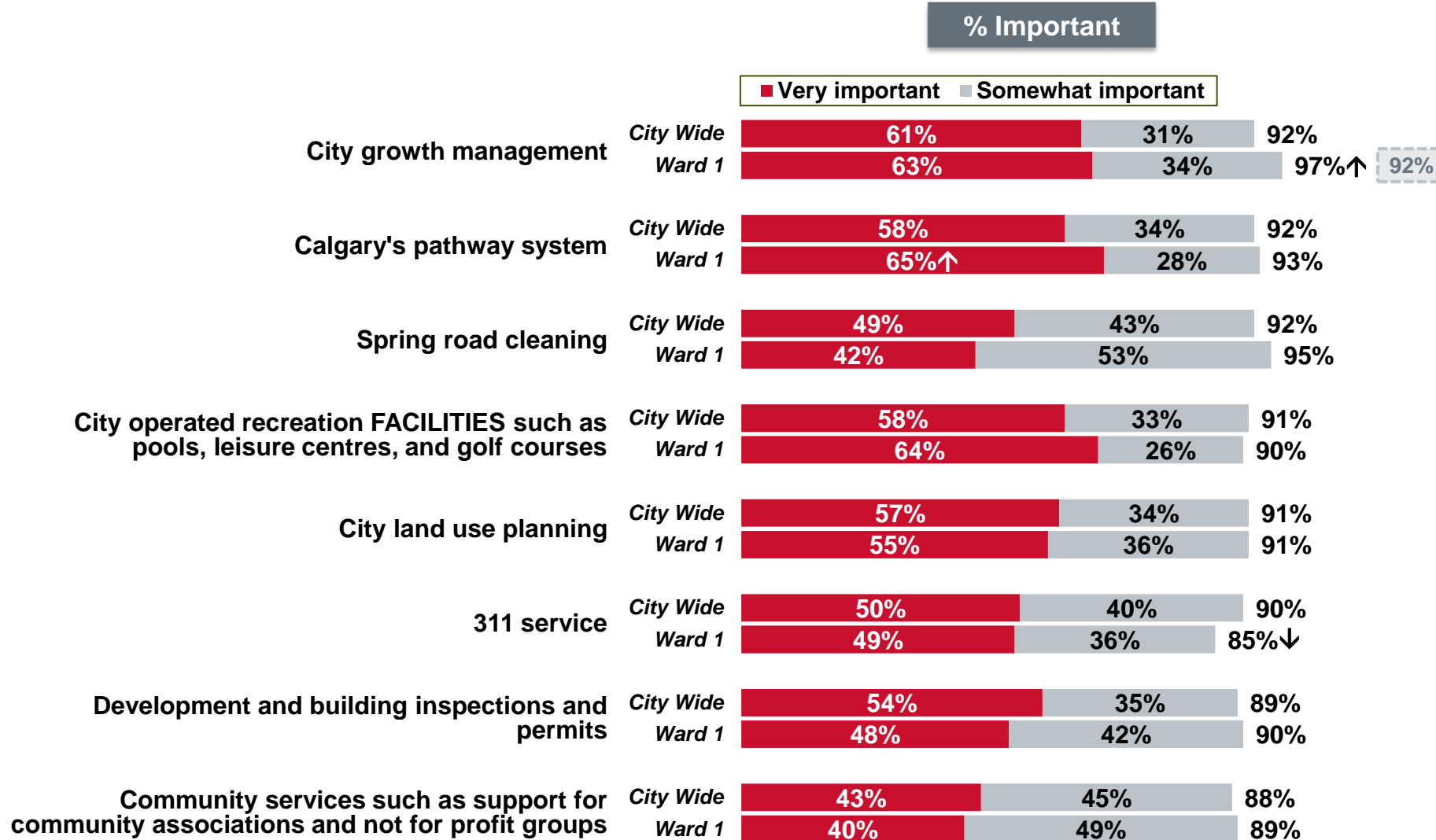

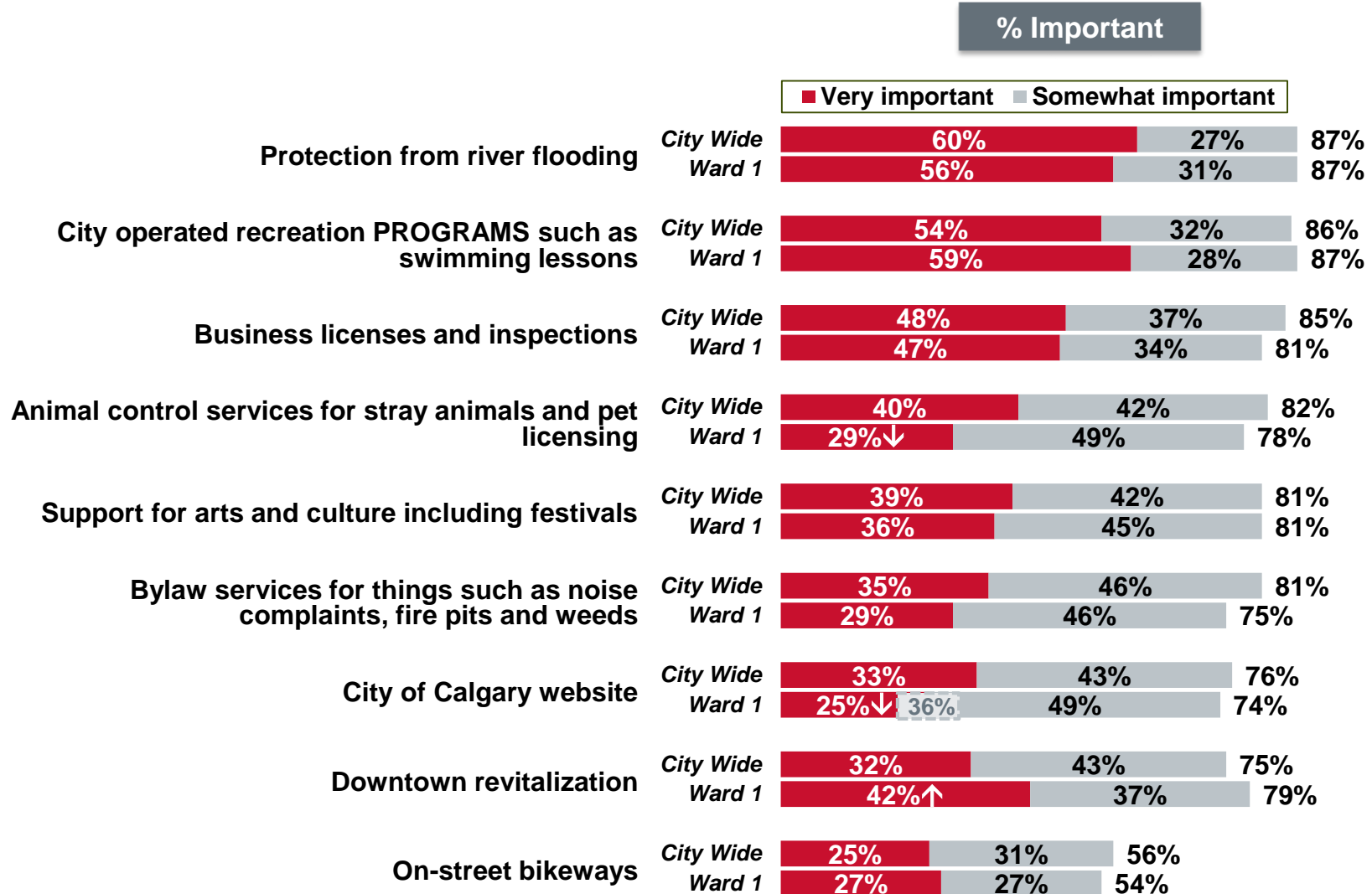

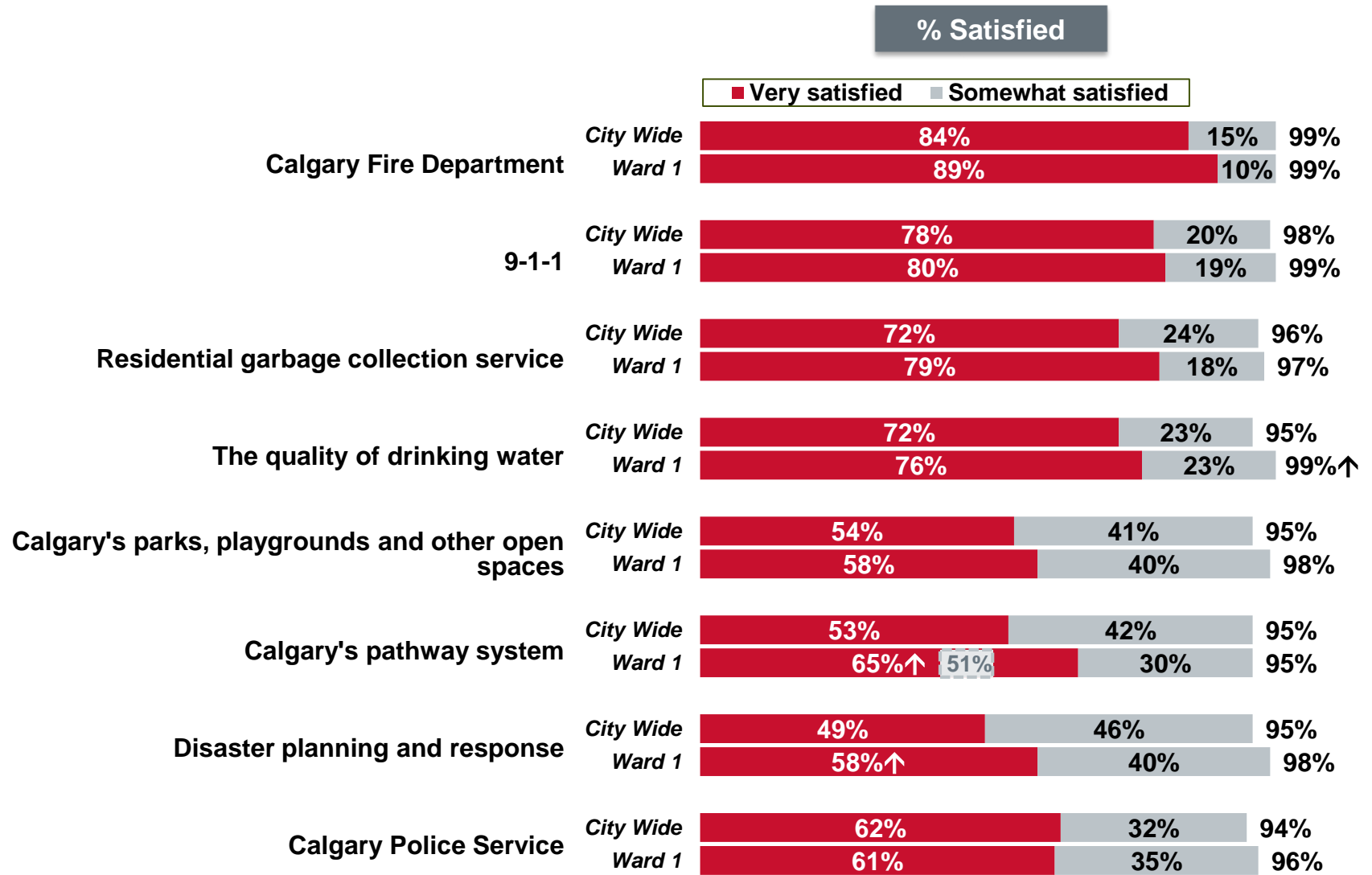

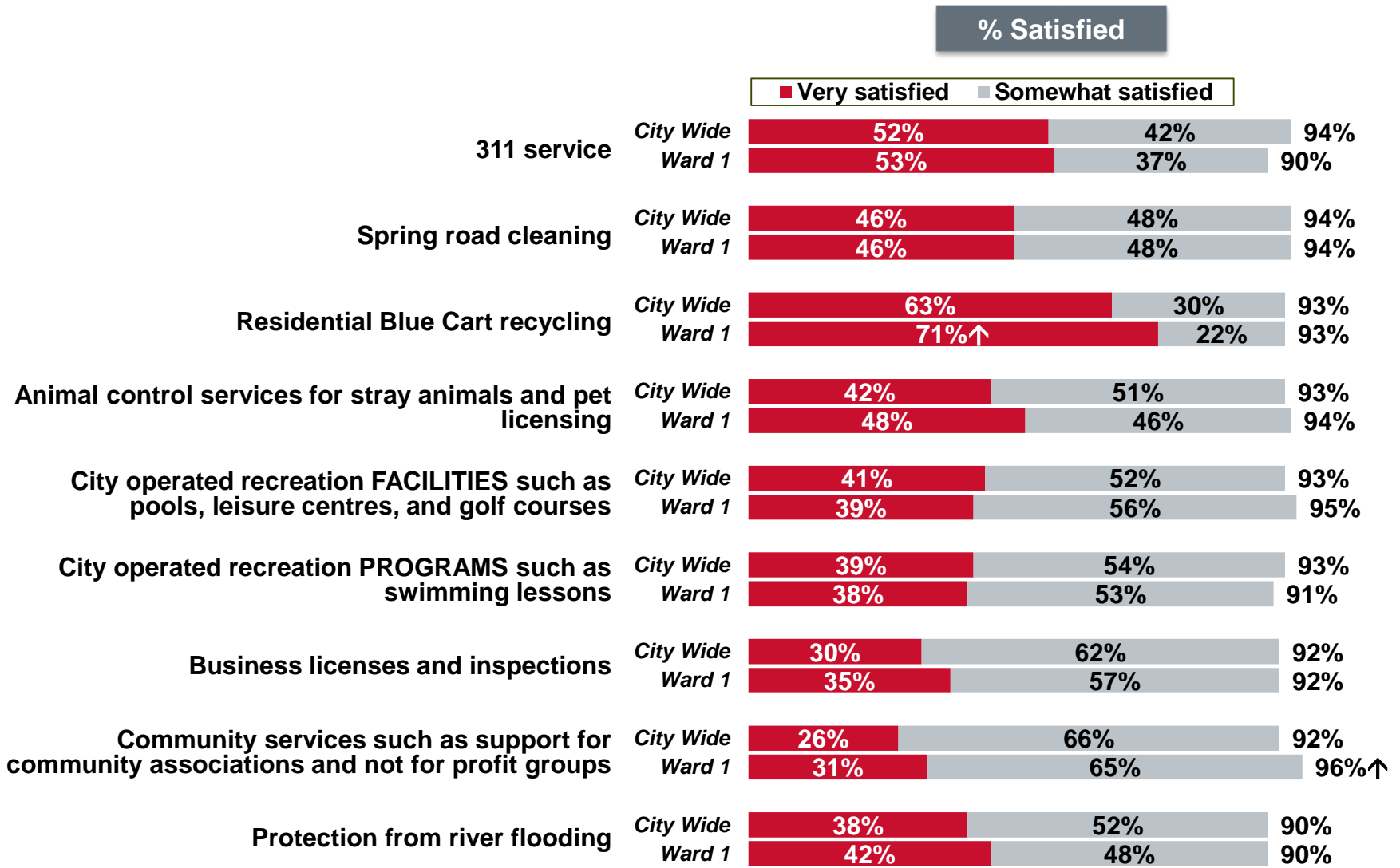
Satisfaction with City Programs and Services

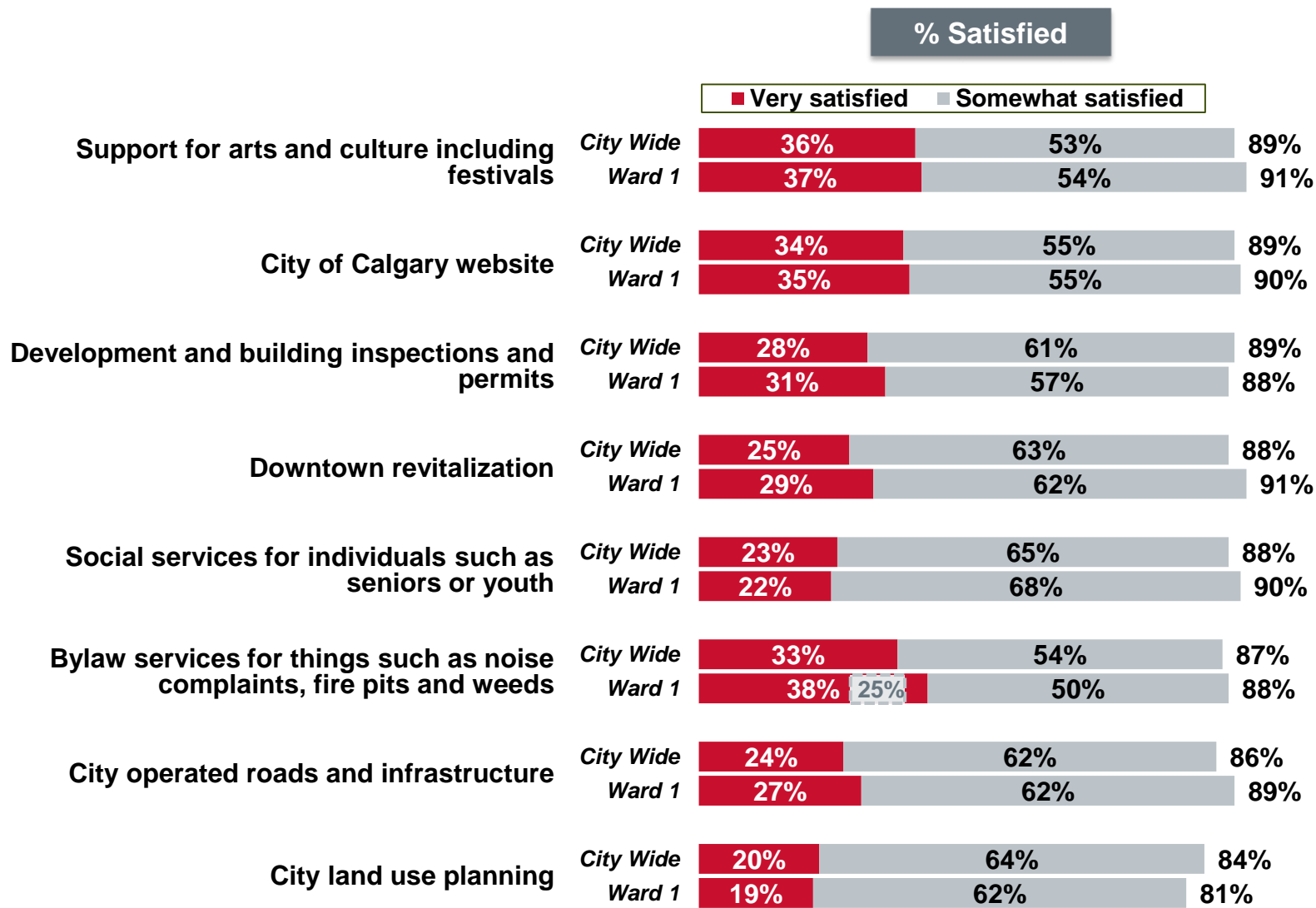

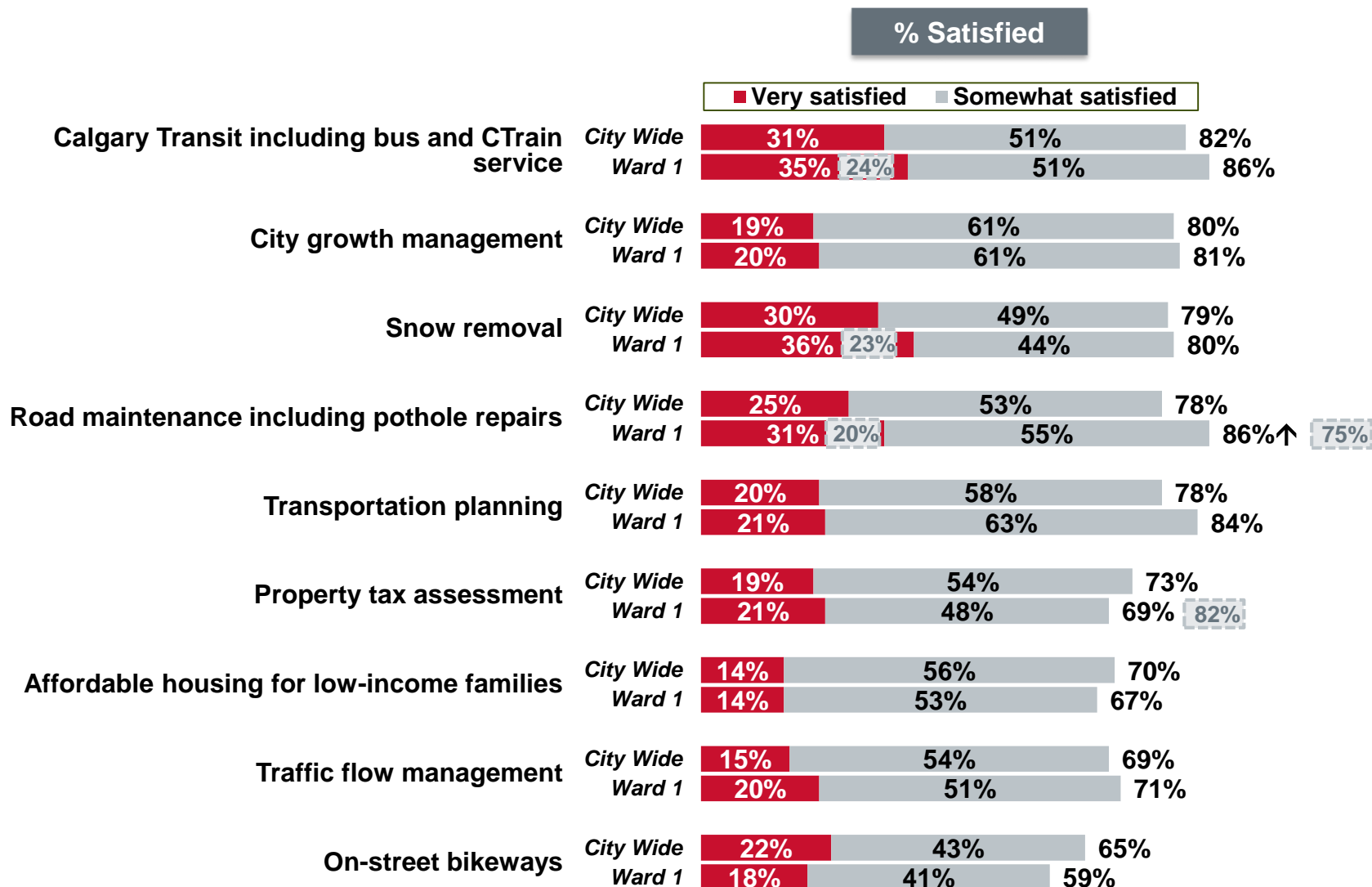

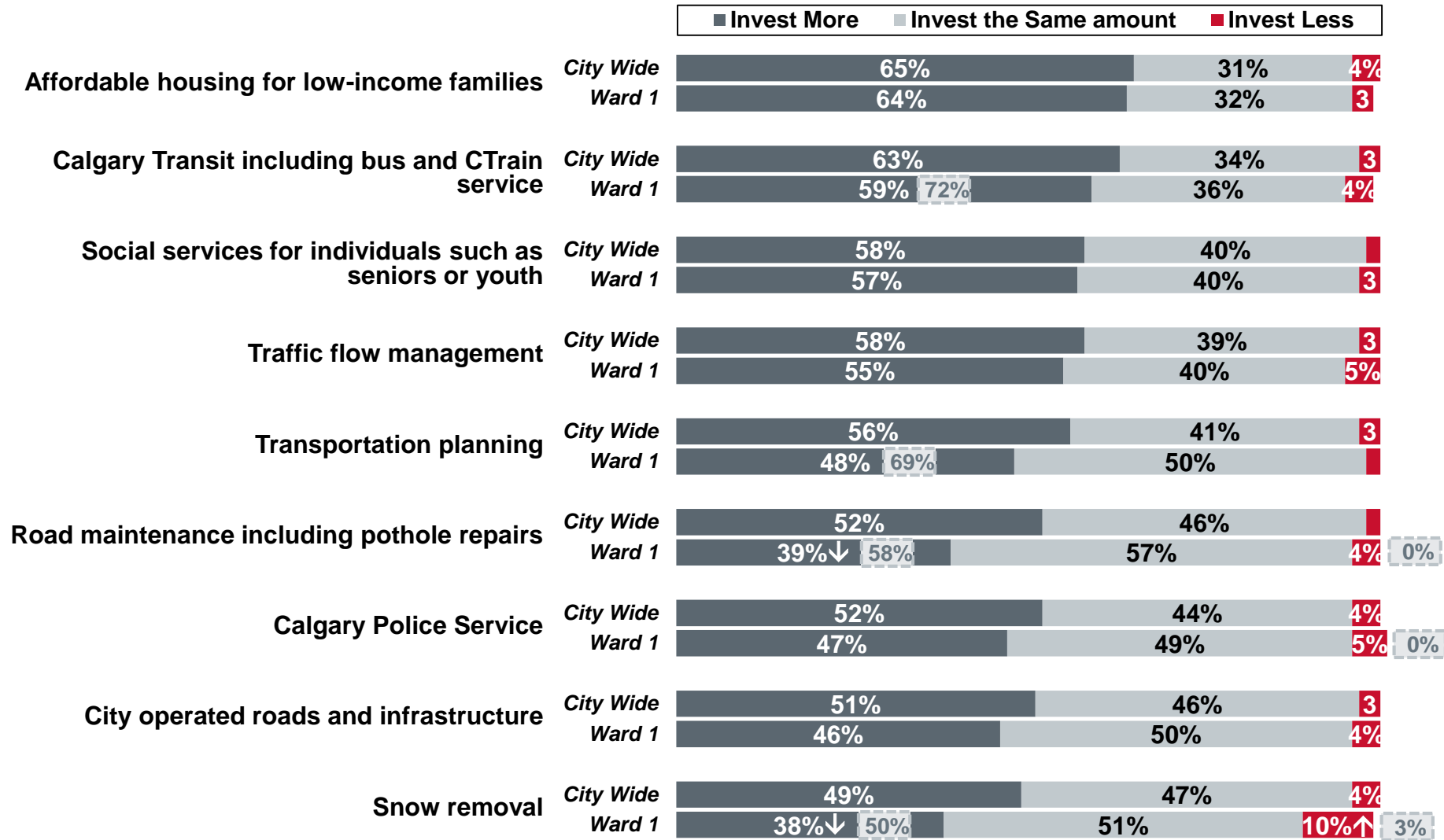

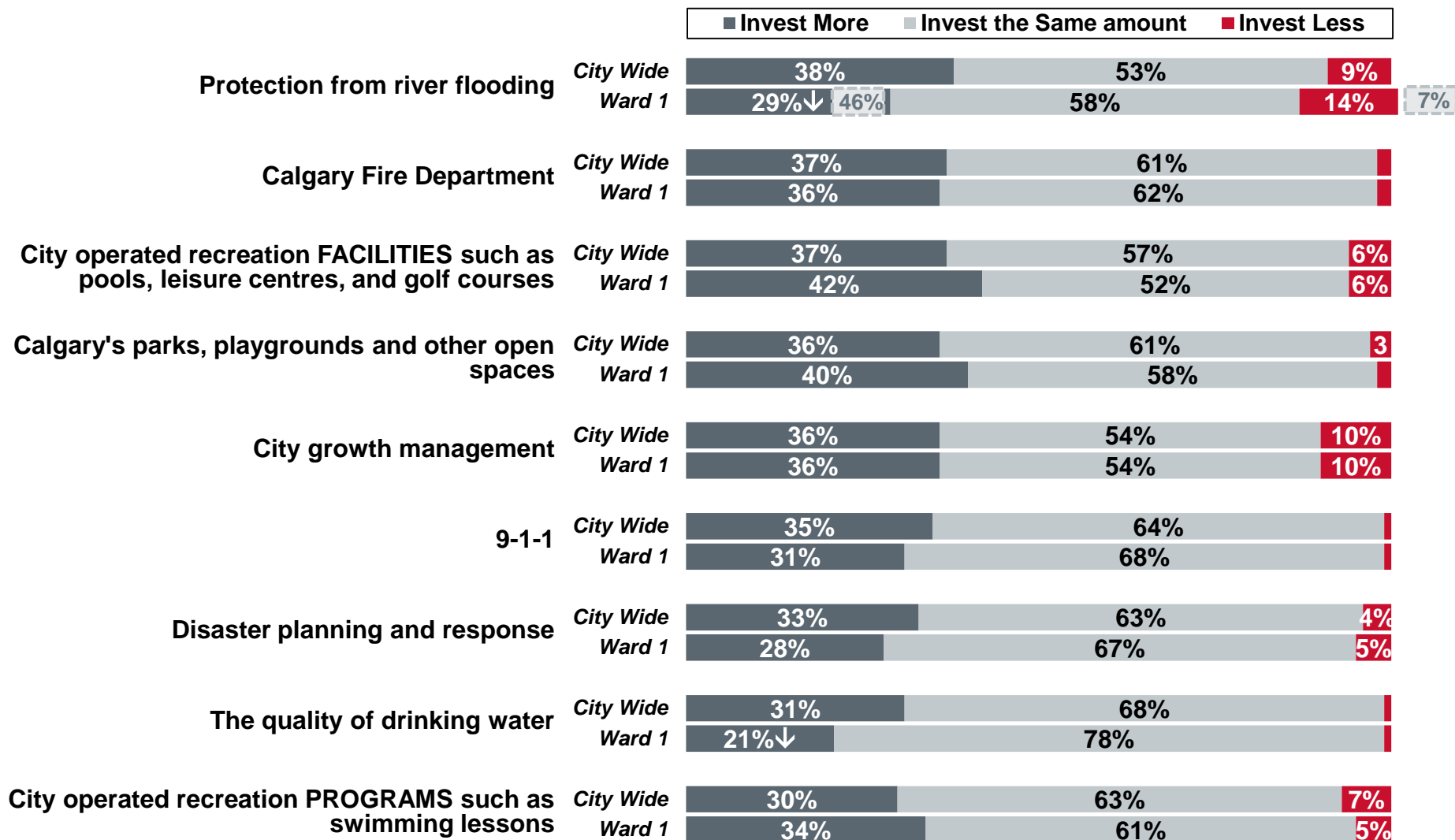

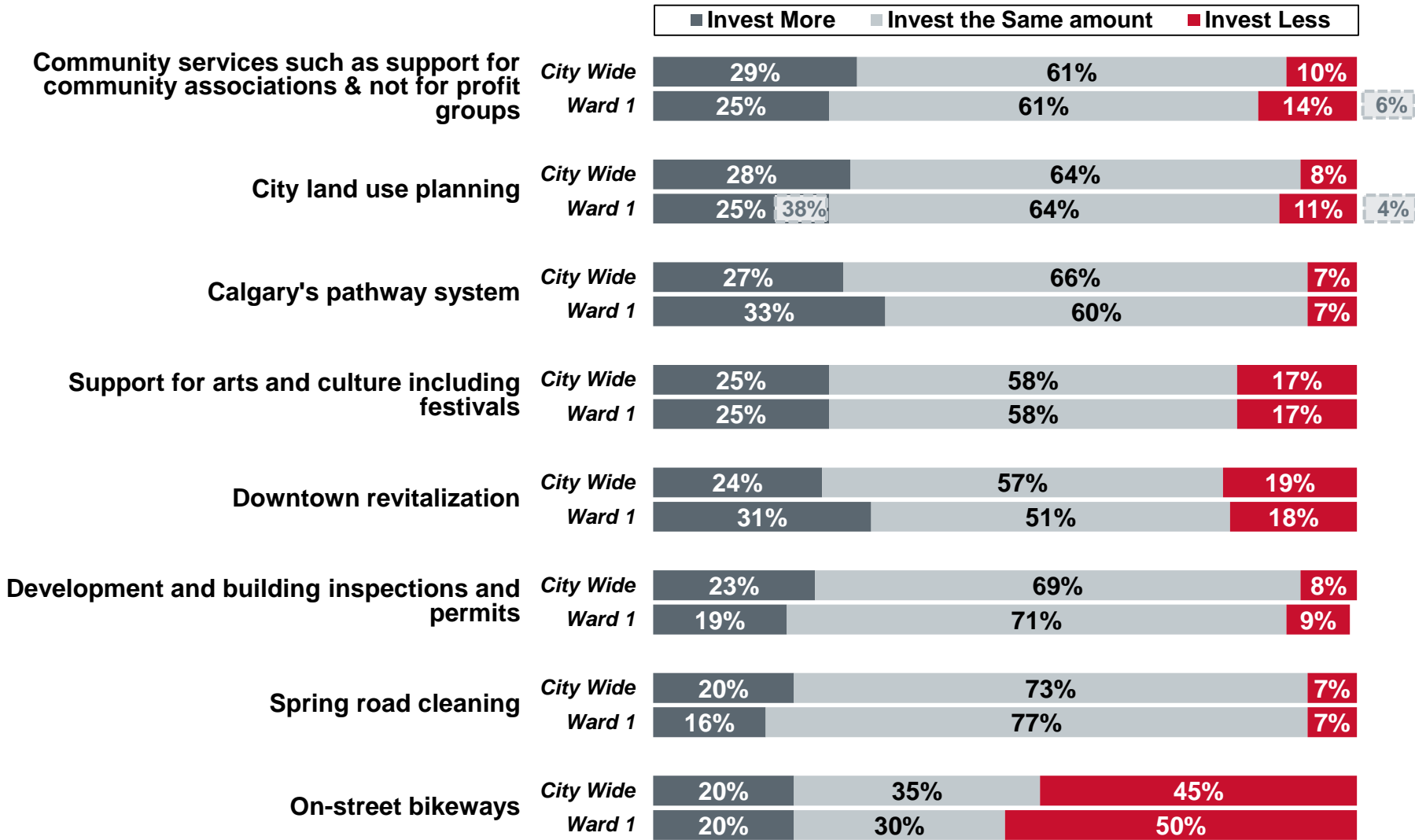

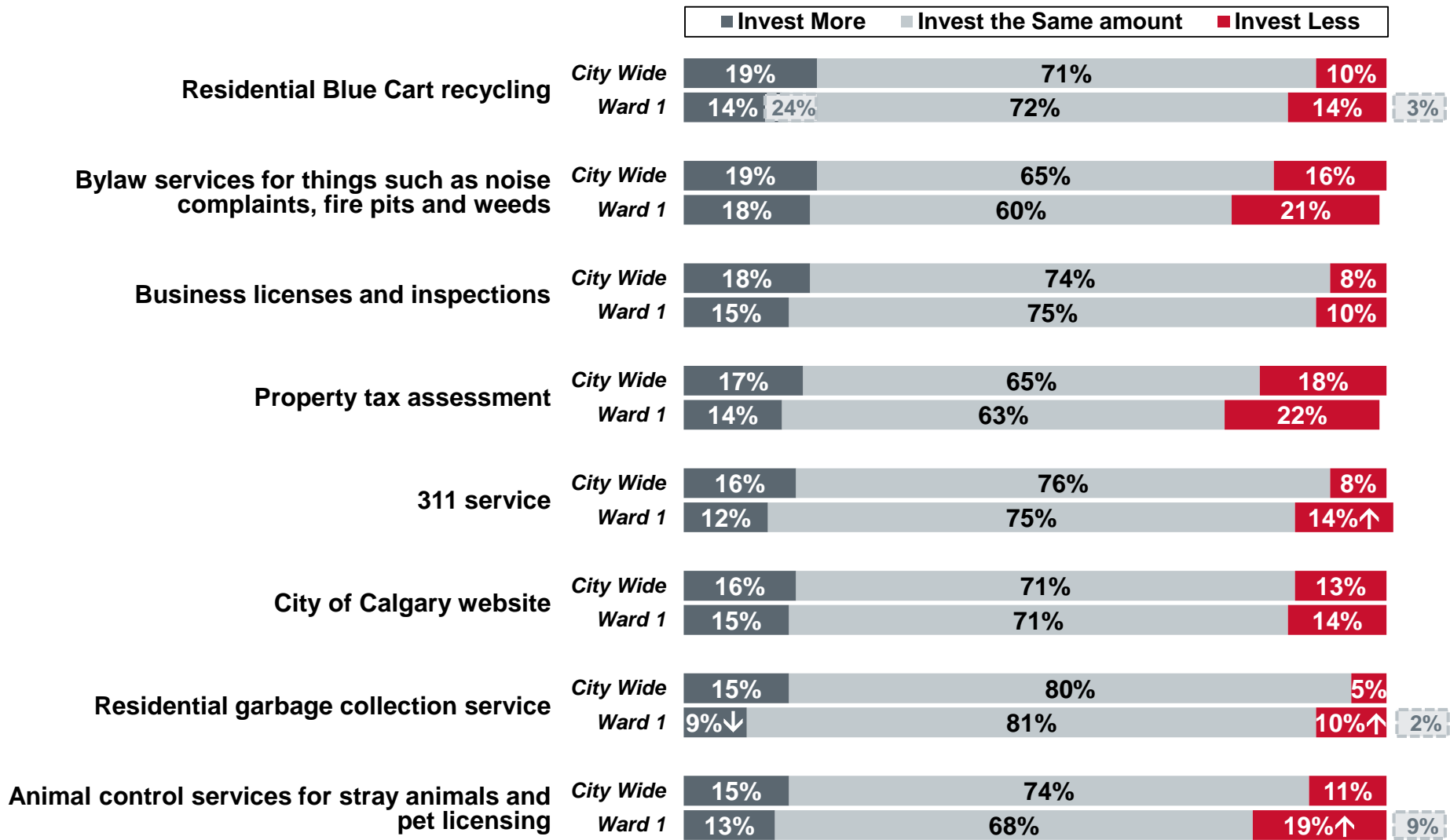

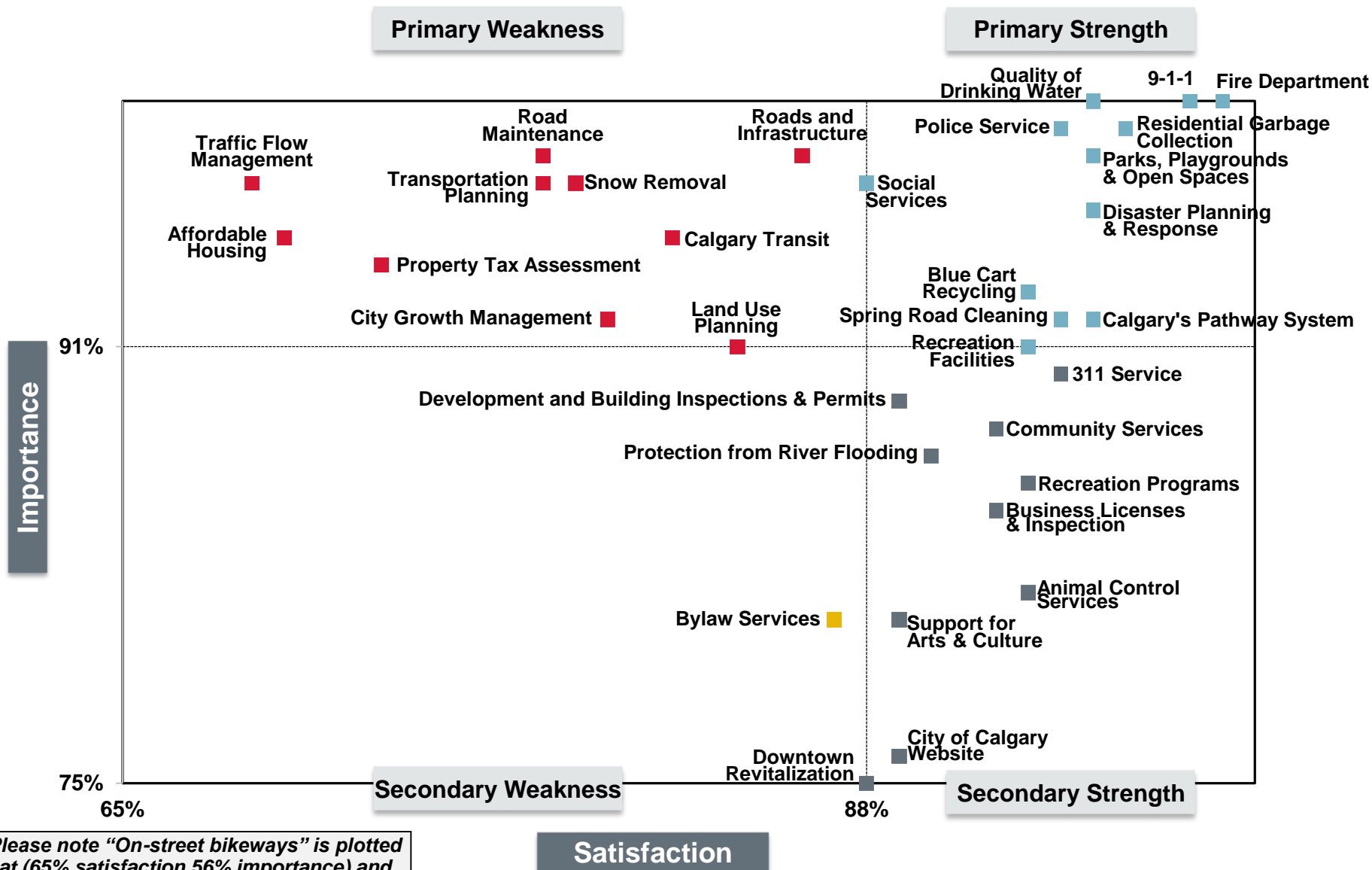

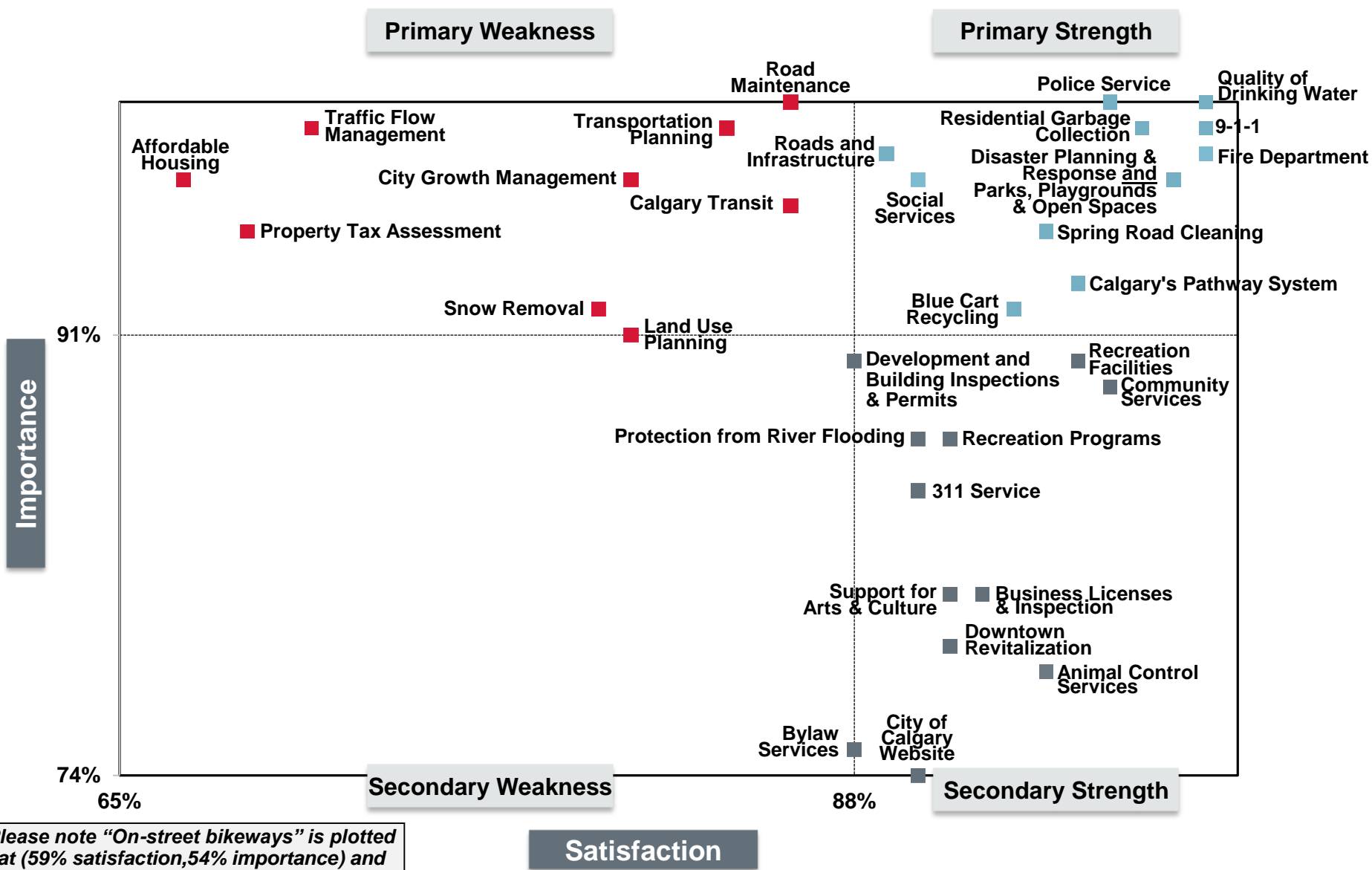

Perceptions About Overall State of Calgary's Environment

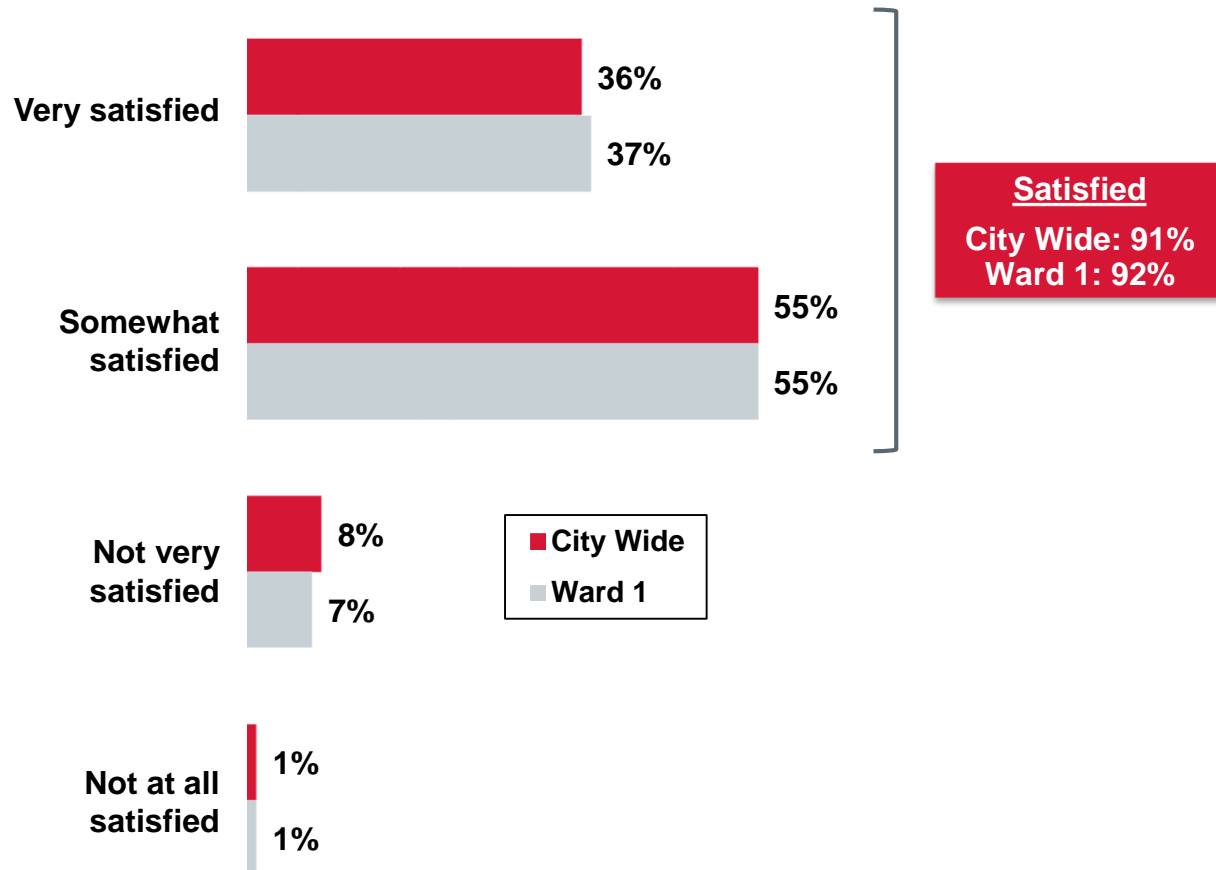

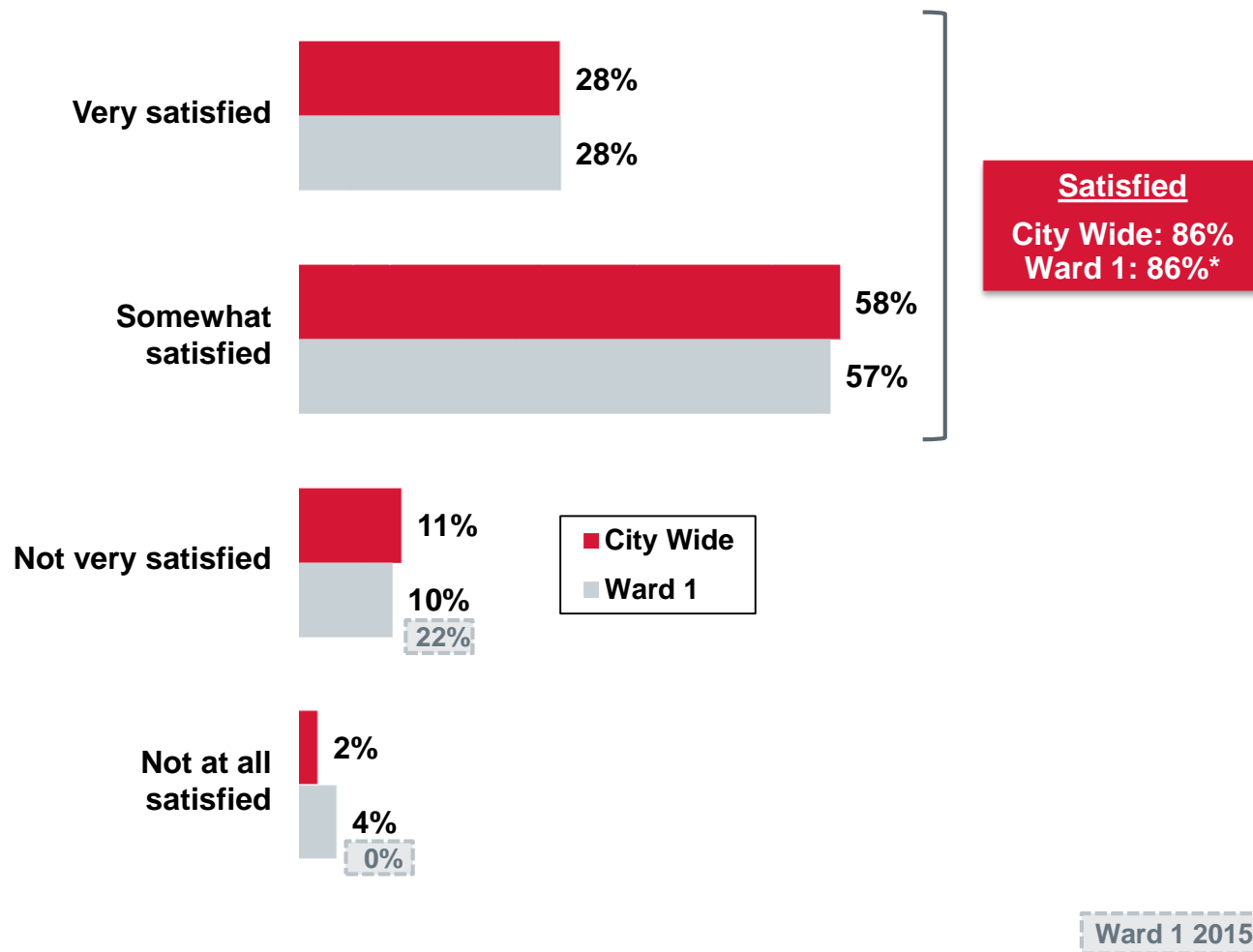
Satisfaction with The City's Environmental Performance

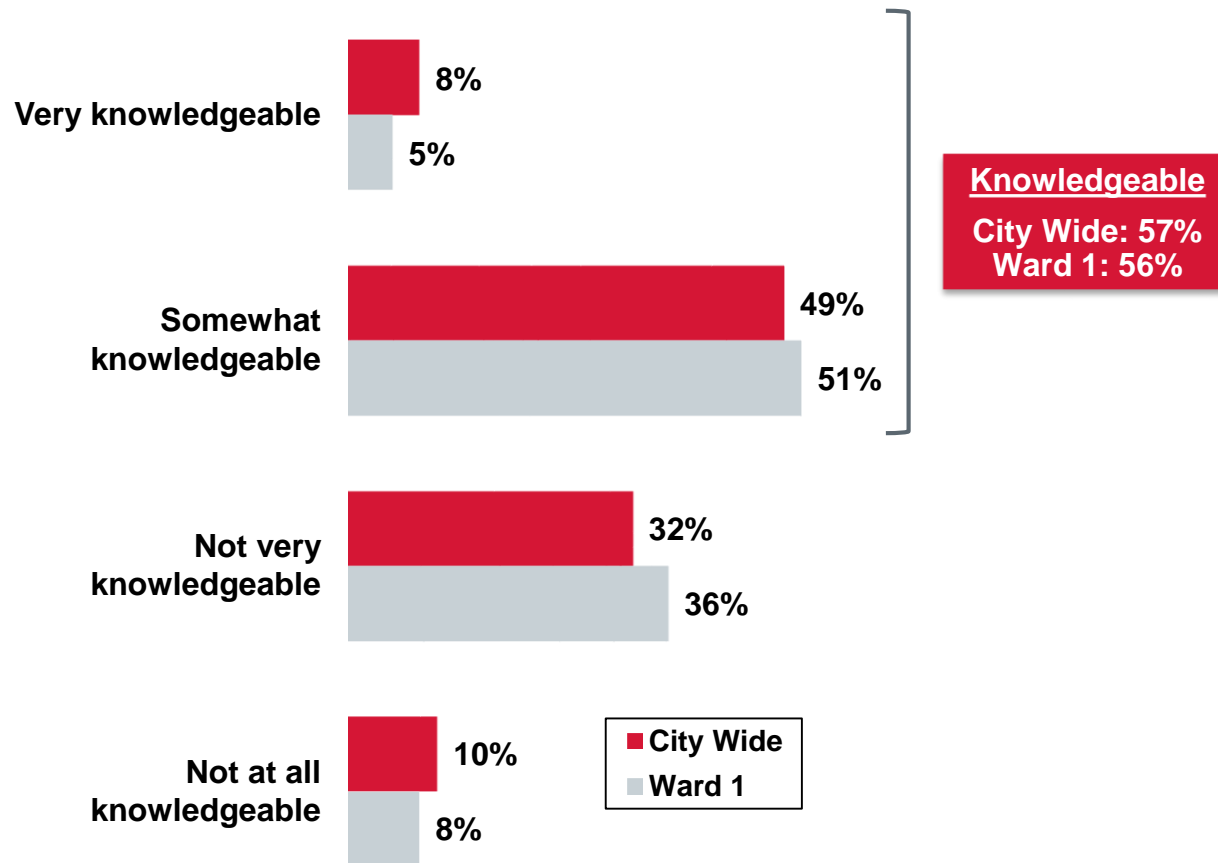
How satisfied are you with The City of Calgary's programs and services aimed at helping Calgarians reduce their environmental impact?

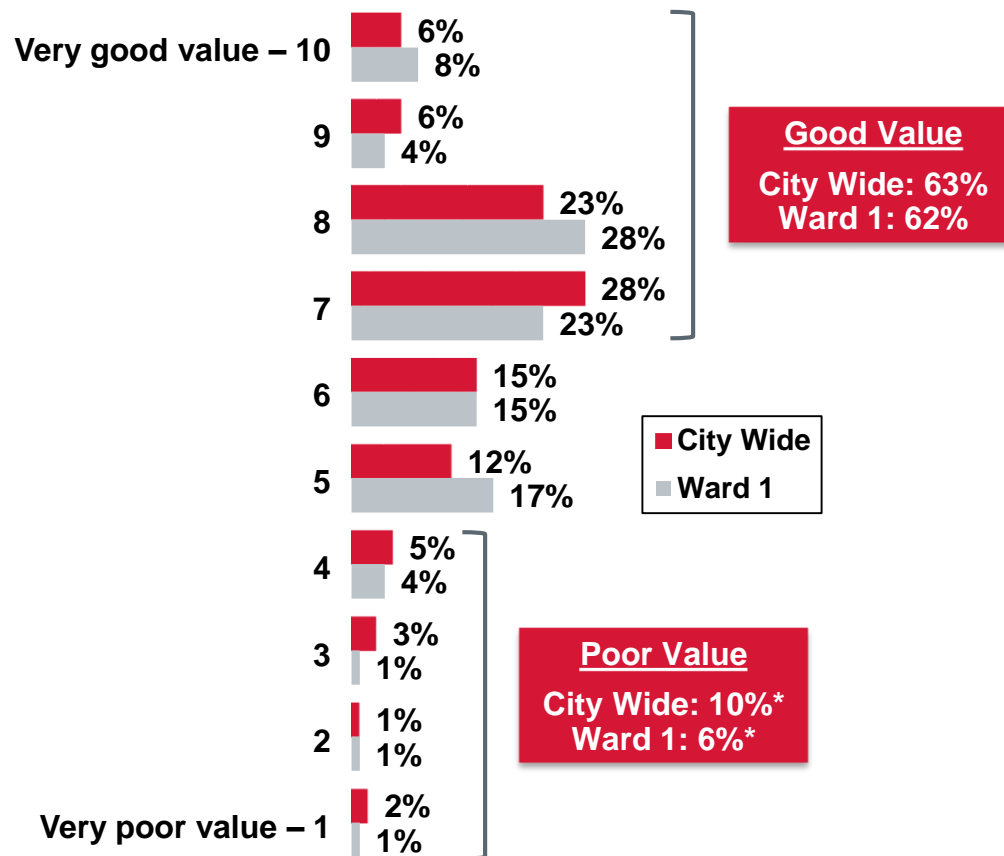
Knowledge Levels of Tax Dollar Spending

Perceived Value of Property Taxes

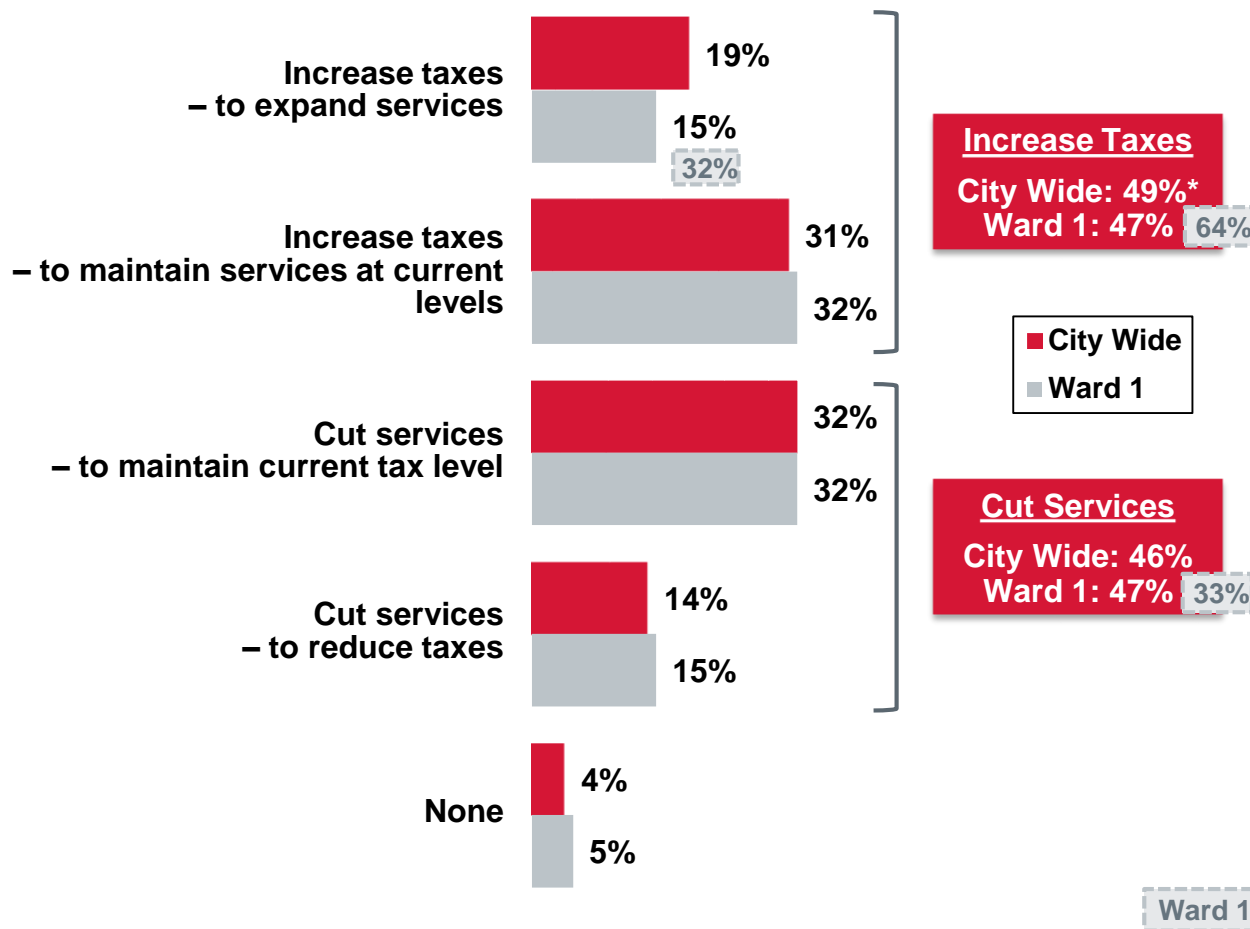

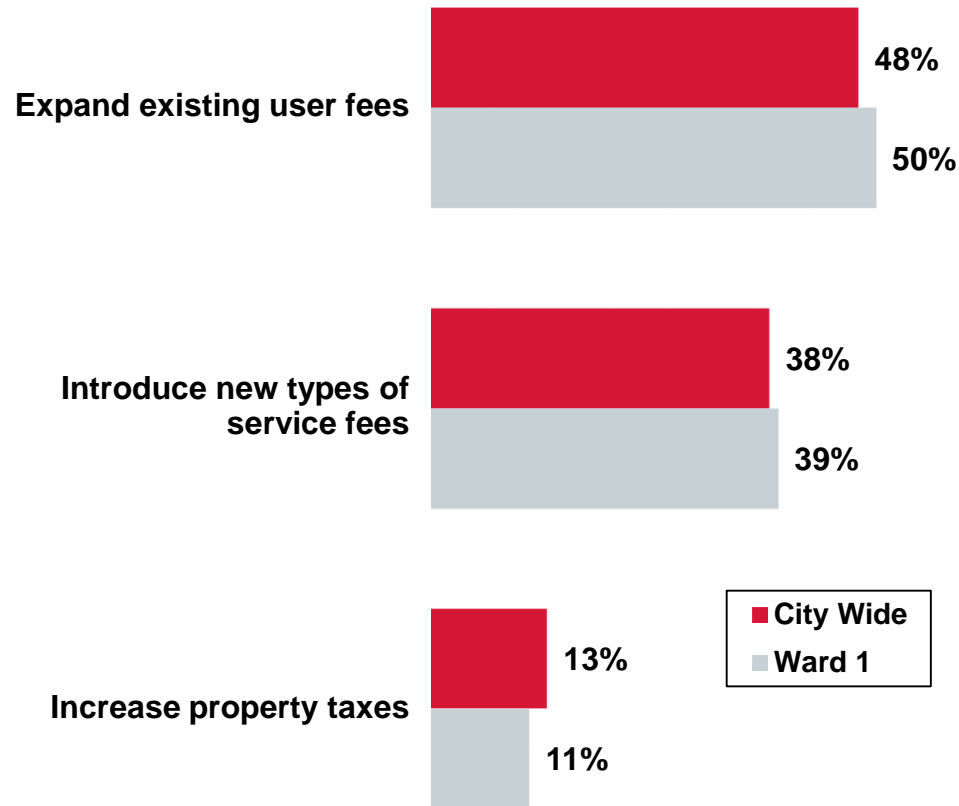
Balancing Taxation and Service Delivery Levels

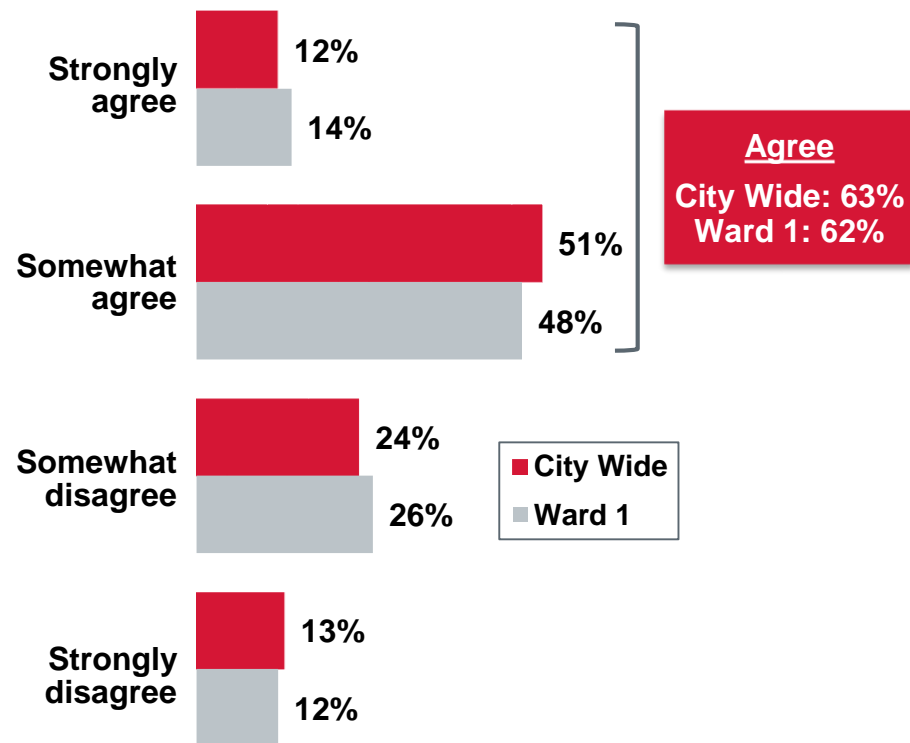
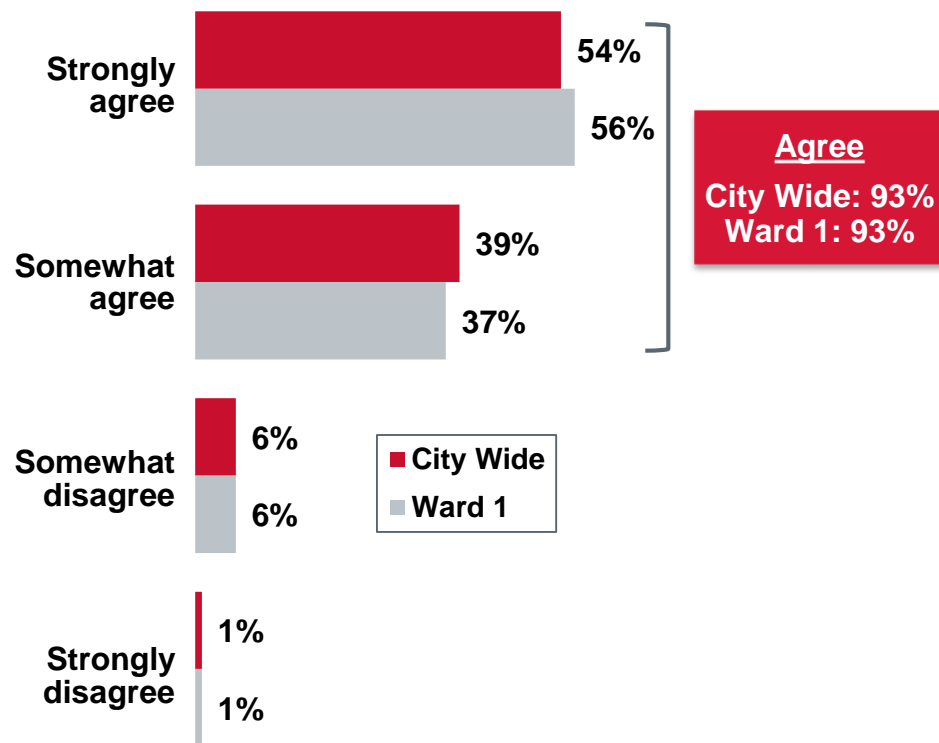
Should The City need to increase the amount of revenue it collects from citizens for new or emerging services, would you prefer The City to ...?

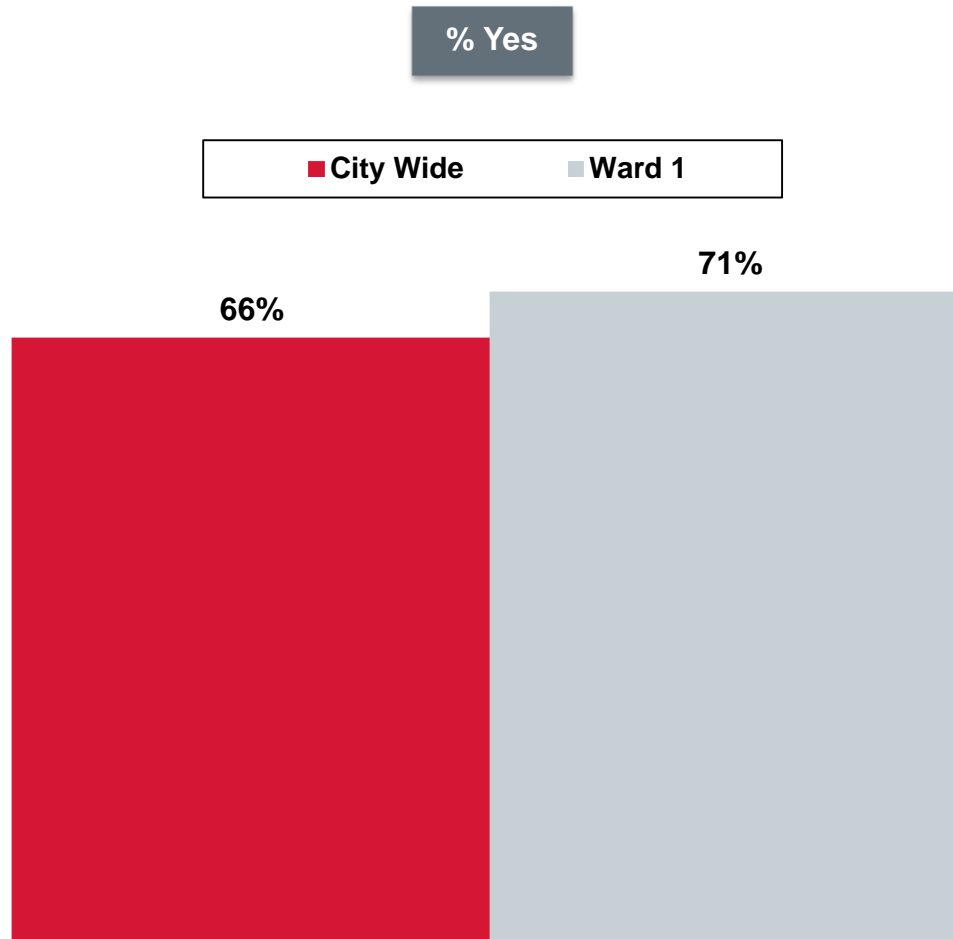

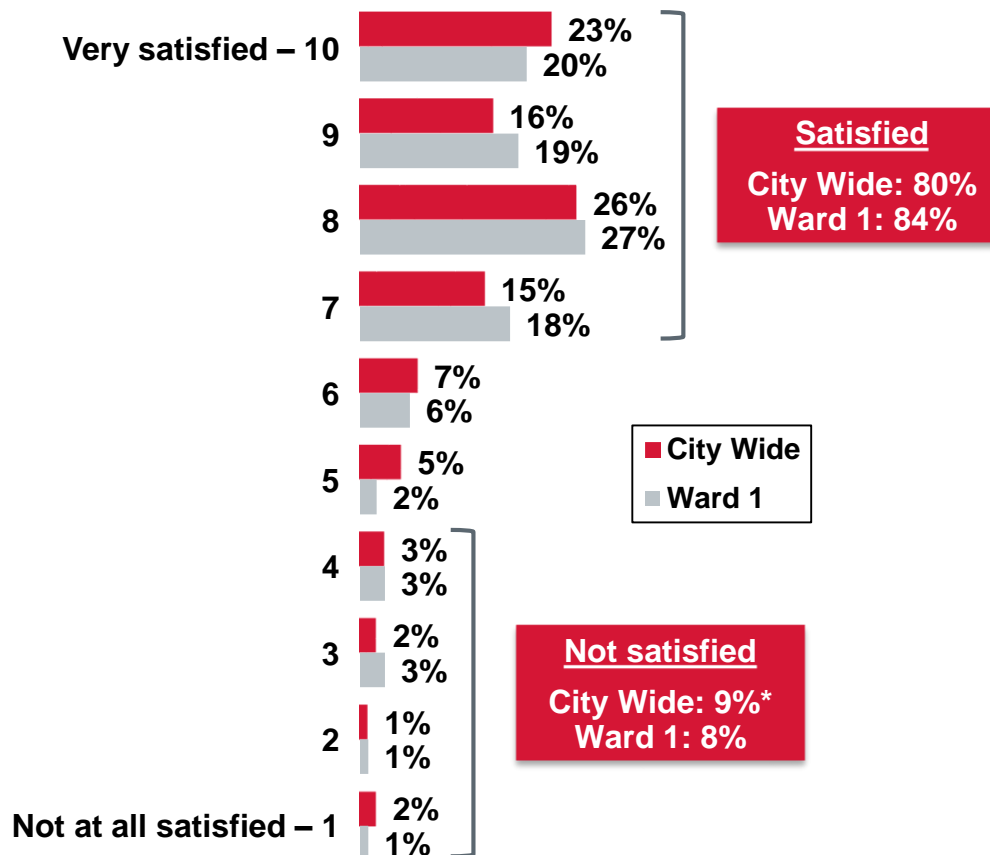
Past 12 Months Contact with The City of Calgary

Satisfaction with the Overall Level and Quality of Customer Service

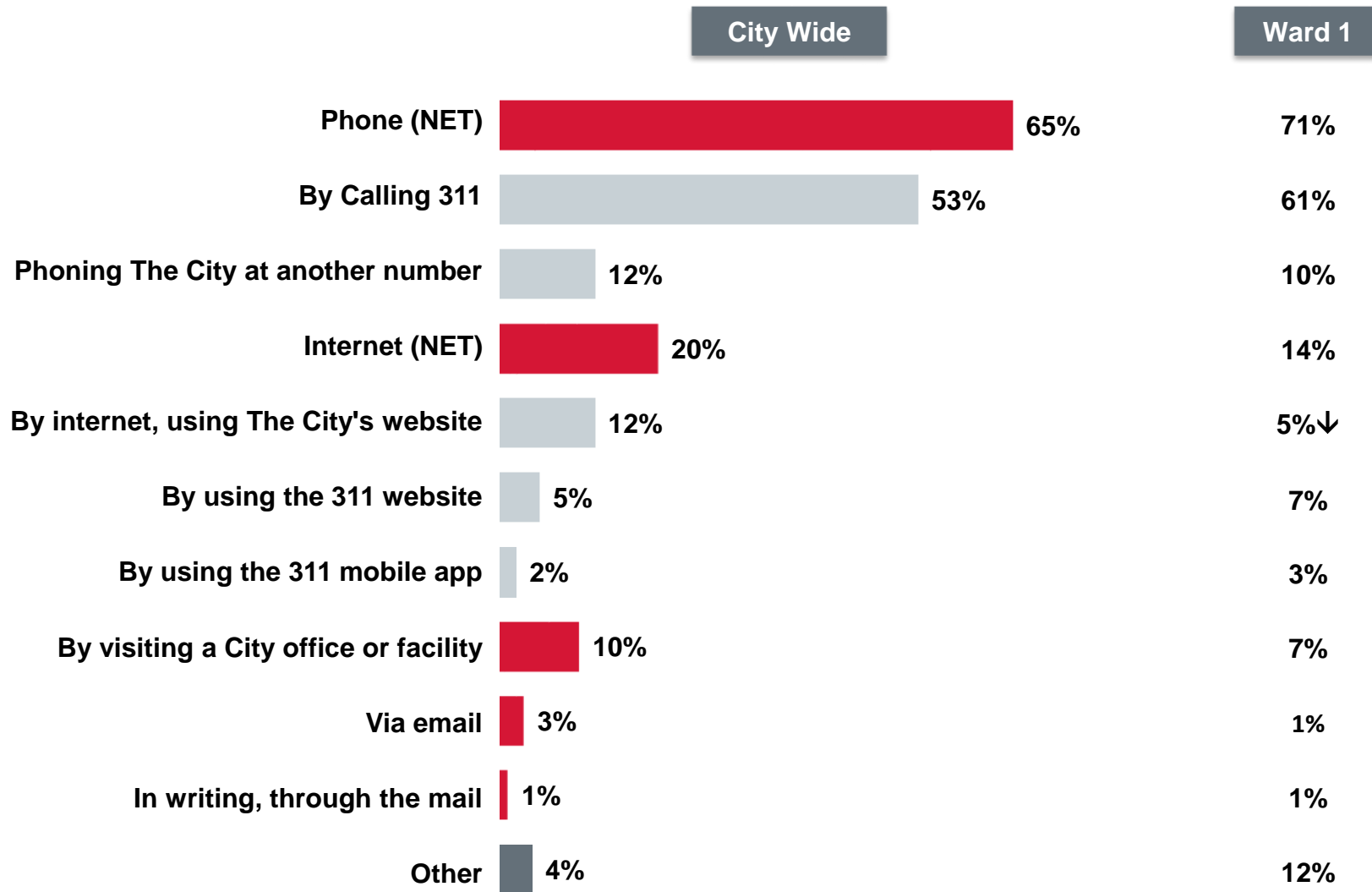

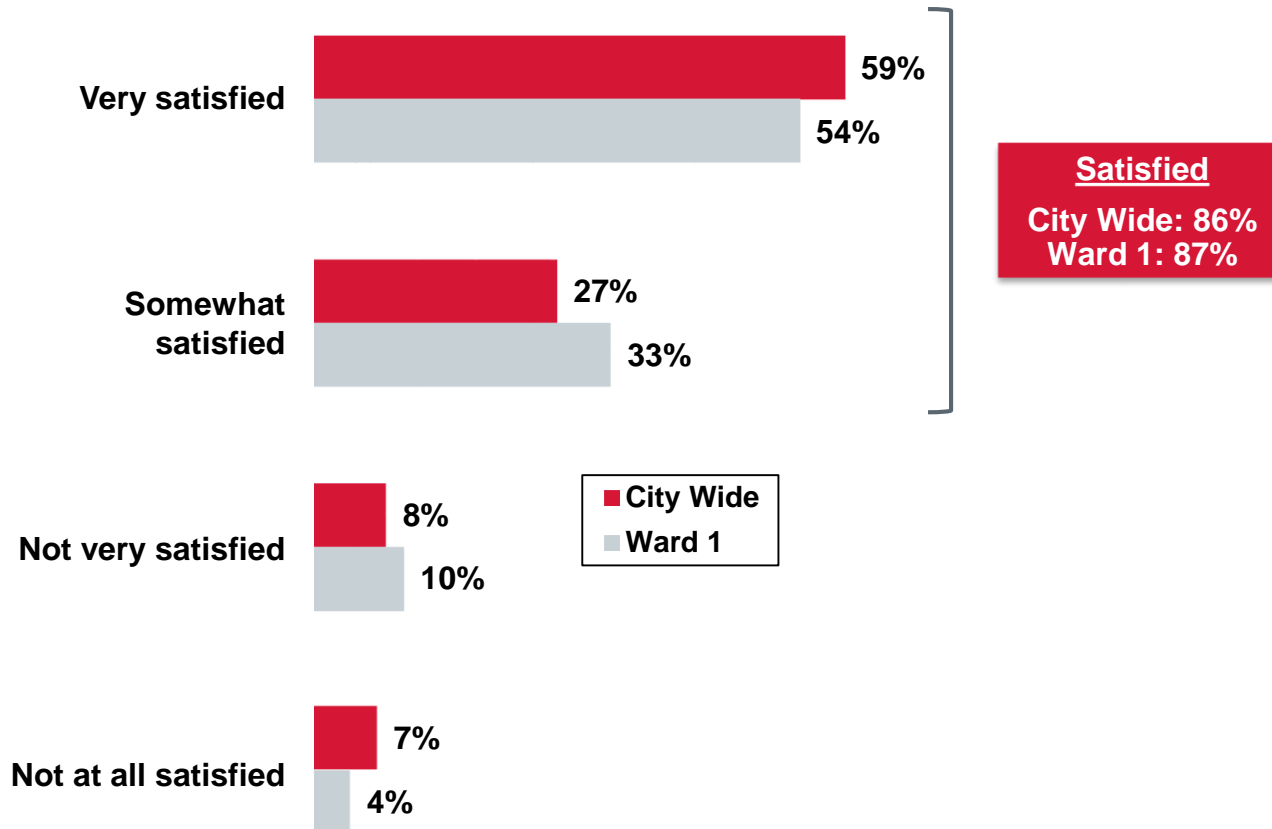
Type of Contact

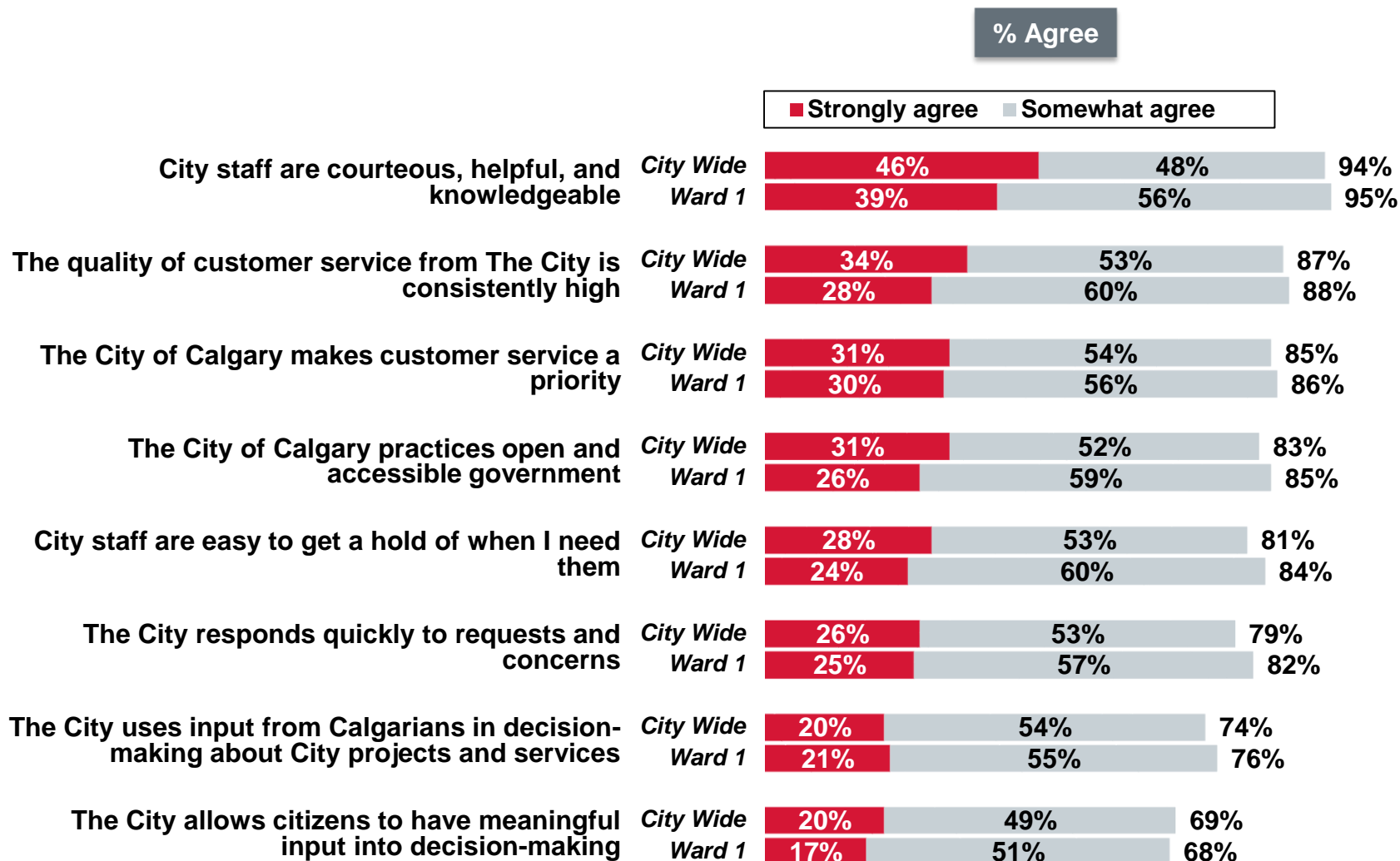
Satisfaction with Most Recent City Contact

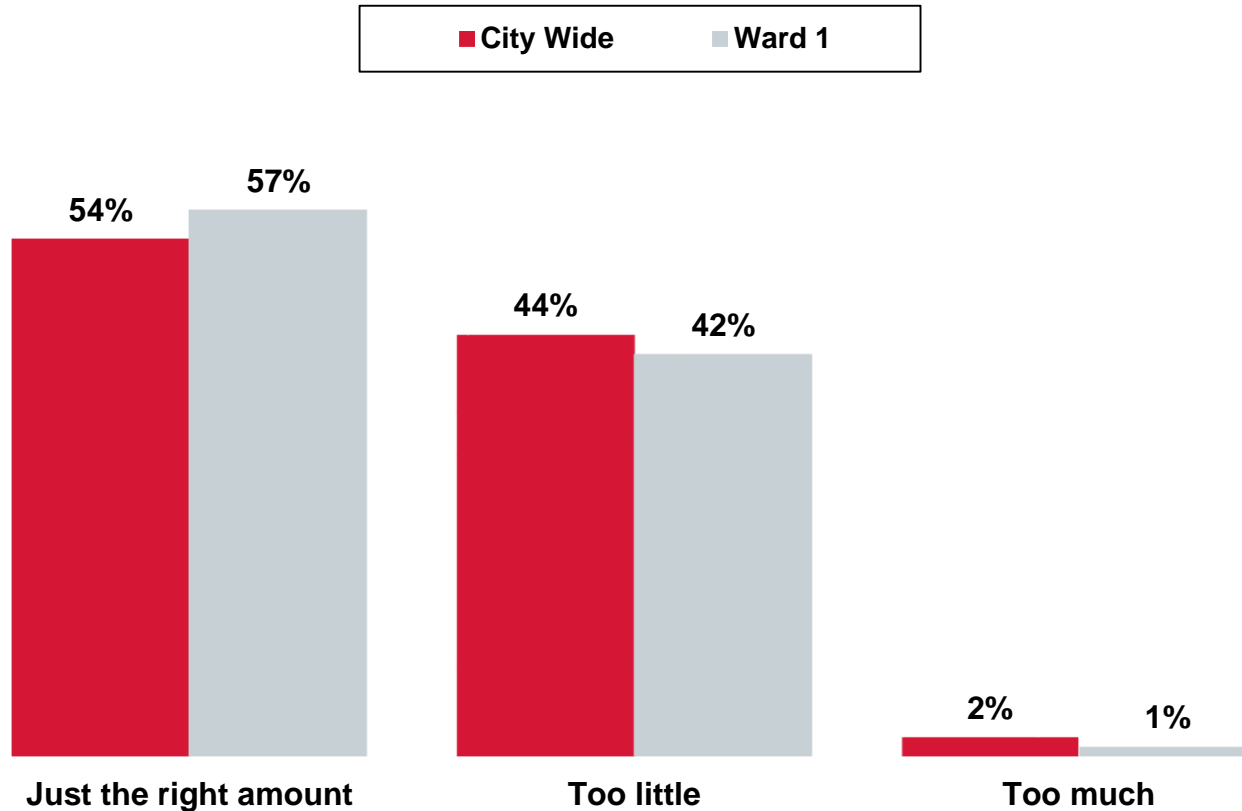

In your opinion, do you currently receive too much, too little, or just the right amount of information from The City?

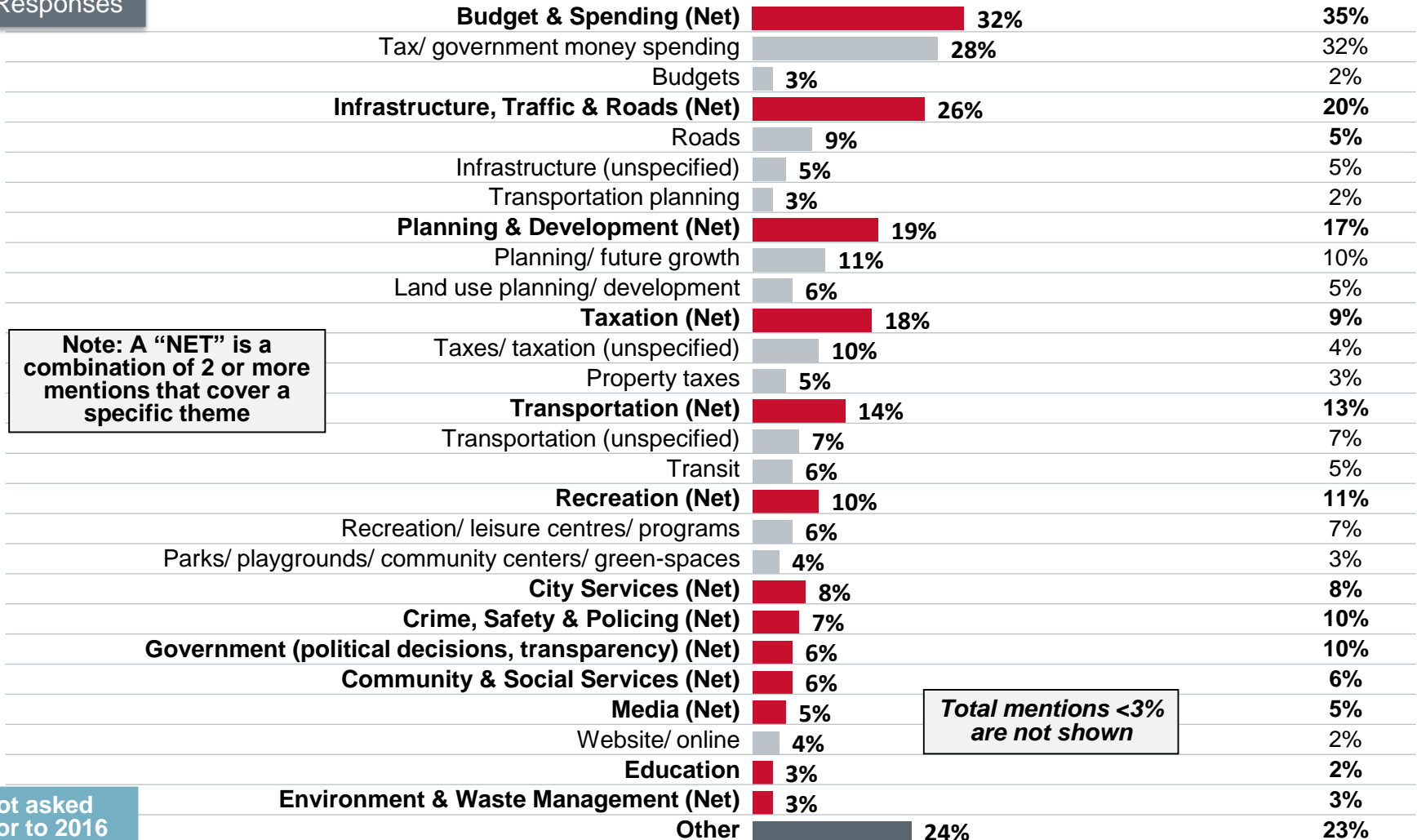

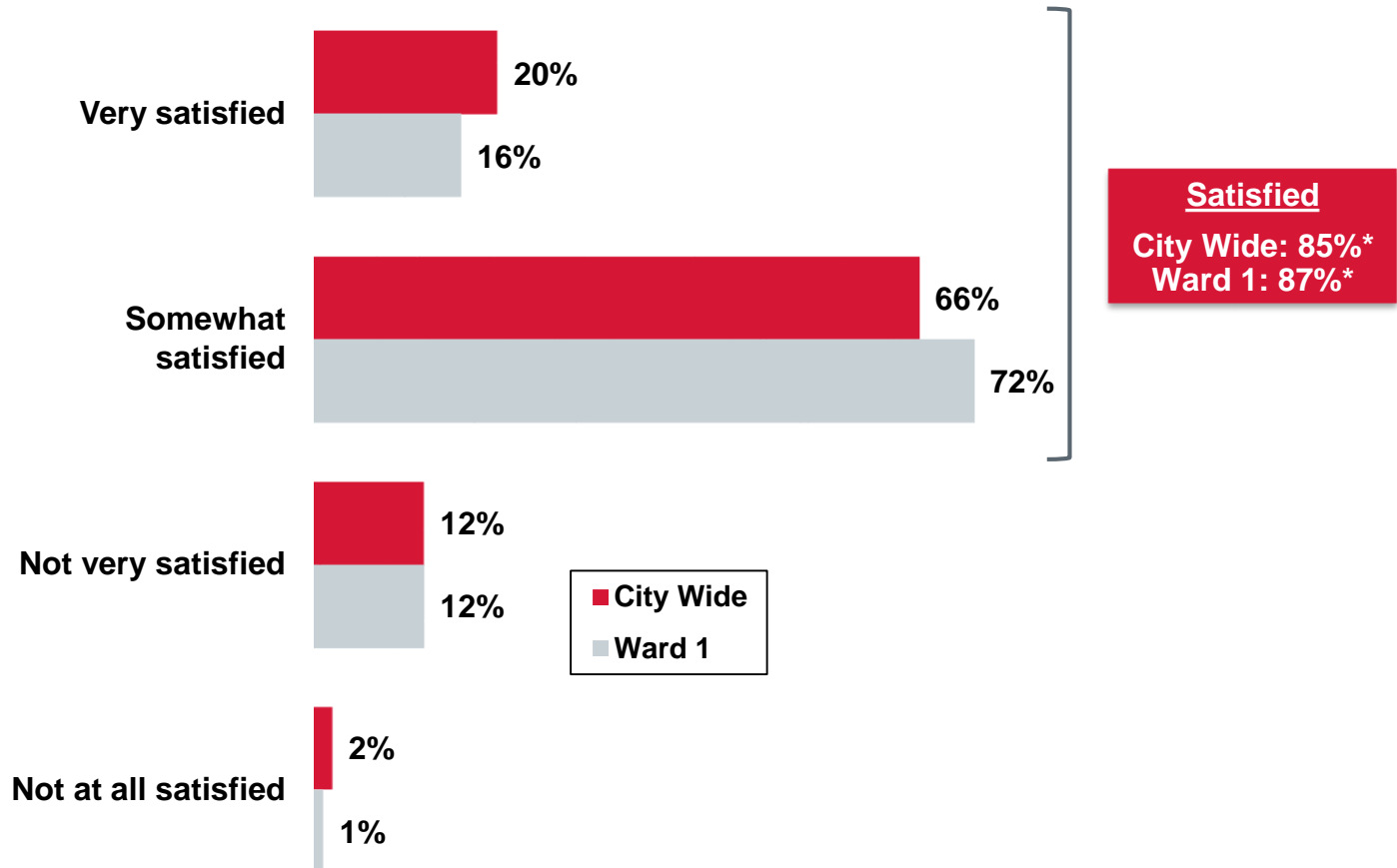
