# Background and methodology

Telephone survey conducted with a randomly-selected sample of 2,502 Calgarians aged 18 years and older between March 2 and March 26, 2023.

- Both cell phone (60%) and landline (40%) samples were used.
  - The average interview length was 29 minutes.
- 

Final data were weighted to ensure the overall sample's quadrant, ward, and age/gender composition reflects that of the actual Calgary population aged 18 or older according to 2019 Municipal and 2021 Federal Census data.

---

The margin of error (MOE) for the total sample of 2,502 is  $\pm 2.0$  percentage points, 19 times out of 20. The margin of error for the disability in household sub-group of 500 is  $\pm 4.38$  percentage points, 19 times out of 20, and the margin of error for the no disability in household sub-group of 1,979 is  $\pm 2.20$  percentage points, 19 times out of 20. The margin of error of each question will vary slightly depending on the total number of respondents who answered the question.

Not all questions asked within the Spring Survey of Calgarians are represented within this report. Results are compared between the disability in household and no disability in household subgroups. Statistically significant differences are noted throughout the report:

- $\uparrow$  indicates number is significantly higher than the other group.
- $\downarrow$  indicates number is significantly lower than the other group.
- \* Some results in this report are subject to rounding adjustments.

Significant differences are an indication that a difference is not due to chance. A mathematical formula is used to calculate each difference independently. Whether or not a difference is considered significant depends on a few factors including the total sample size and the variability of responses. Larger sample sizes mean that smaller differences are significant. Additionally, variability of responses means that the more alike the responses are the more significant a change will be.



# Equity-deserving communities

Calgary’s Equity-Deserving Communities (EDCs) are defined as groups of people who generally have less access to opportunities, resources, and systems of power because of their actual or perceived identity or identities. EDCs often experience social and financial disadvantages because of systems of oppression, which takes many forms including, but not limited to, racism, sexism, and ableism. The City would like to better understand the perspective of equity-deserving communities through the lens of the annual Spring and Fall Surveys of Calgarians. The data in this report are from the most recent (2023) Spring Survey of Calgarians, focusing on demographics of interest, specifically those that differentiate equity-deserving communities. Both seasonal surveys are conducted in English to manage time and cost restraints. The City acknowledges the ability to speak English may be a barrier for potential participants. Inclusion in all EDC groups is based on self-reported demographic data captured within the general population survey.

This is one report in an overall set of nine reports on Equity-Deserving Communities. Each report focuses on a different EDC. The EDCs, and the demographic variables used to categorize EDCs, are as follows, with the EDC category noted in bold text:

# Key Findings

## Quality of life

**Calgarians who have a disability or live in the same household as someone with a disability are less likely to indicate Calgary has a good quality of life.**

- Calgarians who have a disability or live in the same household as someone with a disability, are significantly less likely than households without a disability to rate the overall quality of life in Calgary as 'good' (67% vs. 81%) and more likely to rate it as 'poor' (11% vs. 5%).

## Inclusivity

**When compared to households without a disability present, Calgarians with a disability in the household are less likely to perceive The City as inclusive.**

- Across all questions, households with at least one person in the household with a disability are less likely to agree than households without a disability that The City fosters a city that is inclusive and accepting of all (20% vs. 10%), that The City delivers programs and services that reduce barriers to participation for Calgarians who need it most (41% vs. 56%), and that The City of Calgary municipal government strives to create a city that is equally accessible for all Calgarians, no matter their physical ability (48% vs. 63%).

## Green Line LRT

**Both households with and without a disability present view the Green Line LRT as an important part of Calgary's future.**

- Regardless of disability in the household or not, both households indicate identical ratings for the importance of the Green Line LRT to the future of Calgary (92% vs. 92%).
- Similarly, both households with a disability and without agree that the Green Line LRT will be an important addition to Calgary's transportation network (89% vs. 91%) and enable Calgarians to better connect with people, places and services (92% vs. 91%)



# Key Findings

## The environment

**Calgarians with a disability in the household tend to hold more negative views when it comes to the environment, compared to those without a disability in the household.**

- Calgarians that have a disability in the household are more than twice as likely to rate the state of Calgary's environment as 'poor' than those with no disability in the household (11% vs. 5%). They are also less satisfied (79% vs. 85%) and more dissatisfied (21% vs. 15%) with the job The City is doing to protect the environment than households with no disabilities.
- There are no differences in how satisfied Calgarians with a disability in the household versus without are with City programs and services aimed at helping Calgarians reduce their environmental impact (76% vs. 78%).

## Service equity

**Overall, satisfaction with the level and quality of services and programs provided by The City of Calgary is lower amongst Calgarians with a disability in the household compared to those without a disability in the household.**

- Calgarians with a disability in the household are less satisfied (63% vs. 69%) and more dissatisfied (13% vs. 9%) with the overall level of services and programs provide by The City of Calgary than those without a disability in the household.
- In general, Calgarians with a disability in the household are less satisfied than those without a disability in the household with the following services and programs: pet ownership and licensing (82% vs. 90%), specialized transit services (78% vs. 88%), environmental management services (75% vs. 87%), community strategies (76% vs. 85%), social services for individuals such as seniors or youth (72% vs. 86%), land development and sales (75% vs. 83%), and affordable housing for low-income families (38% vs. 56%).



# Key Findings

## Service equity (continued)

- Calgarians with a disability or living in the same household as someone with a disability would like to see more investment in social services for individuals such as seniors or youth as compared to those without a disability (68% vs. 55%).
- Those with a disability in the household are more likely than those without a disability in the household to indicate they want less investment in real estate (16% vs. 9%), development approvals (14% vs. 8%) and affordable housing for low-income families (8% vs. 4%).

## Taxation

**Calgarians from households with a disability present are more likely to have a negative perception surrounding the value of municipal taxes in comparison to households without a disability, however there is no indication that households with a disability are against increasing taxes to maintain services.**

- Those with a disability in the household are also more likely to rate the value as 'poor' than those without (23% vs. 18%).
- Calgarian households that have a disability present endorse an increase in taxes to maintain or expand services at nearly the same amount as those without a disability present (53% vs. 55%), and in line with all Calgarians (55%)



# Key Findings

## Customer service

**There is general agreement that the quality of customer service from the City is high among both households with and without a disability. However, satisfaction with and perceptions of customer service are lower among Calgarians with a disability in the household compared to those without, in nearly all domains.**

- Calgarians with a disability in the household and without a disability in the household both agree that the quality of customer service is consistently high (69% vs. 73%).
- Calgarians from households with a disability present are less likely to agree than Calgarians from households without no disability present that The City responds quickly to requests and concerns (60% vs. 67%), makes customer service a priority (66% vs. 73%), and meets their customer service expectations (74% vs. 79%).
- Households with a disability present are also more likely to hold a poor perception of City communication in the past six months in comparison to those without a disability in the household (34% vs. 27%).

## Input from Calgarians

**Opinions surrounding the input from Calgarians are similar and mostly positive for both Calgarians with a disability in the household and those without, except for two areas where Calgarians with a disability in the household show more disagreement.**

- Both Calgarians in households with a disability and without generally agree that The City allows Calgarians to have meaningful input into decision making (60% vs. 63%), and Calgarians have enough opportunities to provide input into decision making about City projects and services (59% vs. 64%).



# Key Findings

## Input from Calgarians (continued)

- Households that have at least one person with a disability are more likely to disagree than households without a disability that The City uses the input from Calgarians in decision making about City projects and services (39% vs. 34%) and that they are confident that The City is working to improve how it includes Calgarians' input into decision making (39% vs. 30%).


## Reputation and performance

**Across all areas of reputation and performance, Calgarians with a disability in the household give consistently lower ratings than Calgarians without a disability in the household.**

- Those with a disability in the household are less likely to trust The City of Calgary than those without a disability in the household (27% vs. 21%).
- Both households with and without a disability agree that The City of Calgary practices open and accessible government (68% vs. 71%).
- Calgarians with a disability in the household are less satisfied than Calgarians without a disability in the household with The City as a whole (64% vs. 72%), City Council (53% vs. 62%), and City Administration (68% vs. 79%).
- Agreement is lower for Calgarians with a disability in the household compared to those without that the City Council and City Administration work collaboratively to make the best possible decisions for the future of Calgary (64% vs. 70%) and that The City of Calgary manages its spending in a responsible way that reflects the needs and priorities of Calgarians (52% vs. 60%).





# Quality of life

# Overall quality of life in Calgary – Disability in household

Calgarians who have a disability or live in the same household as someone with a disability, are significantly less likely than households without a disability to rate the overall quality of life in Calgary as ‘good’ (67% vs. 81%) and more likely to rate it as ‘poor’ (11% vs. 5%).




# Perceived change in quality of life – Disability in household

Calgarians who have a disability or live in the same household as someone with a disability are significantly more likely to indicate that the quality of life has worsened in the past three years than households without a disability (56% vs. 47%).




# Moving in the right direction – Disability in household

Calgarians with a disability or who live in the same household as someone with a disability are less likely than households without a disability to agree that Calgary is moving in the right direction to ensure a high quality of life for future generations (45% vs. 53%), and more likely to disagree (29% vs. 19%).



# Great place to make a living – Disability in household

While many Calgarians agree that Calgary is a great place to make a living (73%), those with a disability or living in the same household as someone with a disability are significantly less likely to agree than those without a disability (62% vs. 75%). Calgarians with a disability in the household are also more likely to disagree with the statement than those without a disability in the household (15% vs. 8%).




# Great place to make a life – Disability in household

Similarly, while many Calgarians agree that Calgary is a great place to make a life (78%), those with a disability or living in the same household as someone with a disability are significantly less likely to agree than those without a disability (71% vs. 80%). Calgarians with a disability in the household are also more likely to disagree with the statement than those without a disability in the household (11% vs. 6%).



# On track to be a better city – Disability in household

Though a majority (77%) of Calgarians agree that Calgary is on the right track to be a better city 10 years from now, those with a disability in the household are less likely to agree than those without (70% vs. 79%). Calgarians with a disability in the household are also more likely to disagree with this statement than those without a disability in the household (30% vs. 21%).



# Perceptions of inclusion – Disability in household

Compared to households without a disability (71%), those with at least one person in the household with a disability are less likely to agree (60%) that The City fosters a city that is inclusive and accepting of all. Calgarians with a disability in the household are also twice as likely to disagree than those households without a disability (20% vs. 10%).



# Removes barriers to participation – Disability in household

Those households with a disability present are also almost twice as likely than households without a disability to disagree (20% vs. 11%) that the City delivers programs and services that remove barriers to participation for Calgarians who need it most. They are also less likely to agree than those without a disability in the household (41% vs. 56%).



# Equally accessible for all physical abilities – Disability in household

Calgarians with a disability or living in the same household as someone with a disability are less likely than Calgarians in a household without a disability present to agree that the City of Calgary strives to create a city that is equally accessible for all Calgarians, no matter their physical ability (48% vs. 63%).





# Importance to Calgary's future – Disability in household

Nearly all Calgarians, regardless of disability status within the household indicate that the Green Line LRT is important to the future of Calgary (92% vs. 92%).




# Important addition to transportation network – Disability in household

About nine-in-ten (91%) Calgarians agree that the Green Line LRT will be an important addition to Calgary’s transportation network. Both Calgarians with a disability or living in the same household as a person with a disability and Calgarians in households without a disability present agree similarly (89% vs. 91%).



# Better connecting people – Disability in household

The vast majority (92%) of Calgarians agree that the Green Line LRT will enable Calgarians to better connect with people, places and services. There are no significant differences between Calgarians with a disability or living in the same household as someone with a disability than those without a disability in the household (92% vs. 91%).



# Overall state of environment – Disability in household

Calgarians that have a disability in the household are less likely to rate the state of Calgary’s environment as ‘good’ than those with no disability in the household (89% vs. 95%), and more than twice as likely to rate it as ‘poor’ (11% vs. 5%).



# Protection of the environment – Disability in household

Calgarians with a disability in the household are less likely to be satisfied (22% vs. 28%) and more likely to be dissatisfied (21% vs. 15%) with the job The City is doing to protect the environment than Calgarians without a disability in the household.




# Programs and services to reduce environmental impact – Disability in household

A majority (78%) of Calgarians are satisfied with City programs and services aimed at helping Calgarians reduce their environmental impact. There are no significant differences between Calgarians with a disability or living in the same household as someone with a disability and Calgarians with no disability in the household (76% vs. 78%).



# Overall satisfaction with programs and services – Disability in household

Calgarians with a disability in the household are less satisfied (63% vs. 69%) and more dissatisfied (13% vs. 9%) with the overall level of services and programs provide by The City of Calgary than those without a disability in the household.

# Satisfaction with programs and services (2 of 4) – Disability in household

Calgarians with a disability in the household are less likely to be satisfied with pet ownership and licensing, specialized transit services and environmental management services compared to those with no household disability. Those with disabilities in the household are more likely to be satisfied with 311 and web compared to those without (93% vs. 86%)

# Satisfaction with programs and services (3 of 4) – Disability in household

Households with a disability are less satisfied with social services (72% vs. 86%), community strategy services (76% vs. 85%), and land development and sales (75% vs. 83%) than are households without a disability in Calgary.

# Satisfaction with programs and services (4 of 4) – Disability in household

Calgarian households with a disability are significantly less satisfied with affordable housing for low income families compared to households without a disability (38% vs. 56%).

# Invest more in programs and services (1 of 4) – Disability in household






# Increase taxes or cut services – Disability in household

























# Satisfaction with The City as a whole – Disability in household






Q. Thinking about Calgary’s City Council, EXCLUDING City Administration, how satisfied or dissatisfied are you with the way City Council is going about running our City?






