## Methodology

- ❖ Telephone survey conducted with a randomly selected sample of 2,501 Calgarians aged 18 years and older between February 22nd and March 16th, 2017.
  - Both landline (70%) and cell phone (30%) sample were used.
  - The average interview length was 31 minutes.
- ❖ Final data were weighted to ensure the overall sample's quadrant, ward and age/gender composition reflects that of the actual Calgary population aged 18 or older according to 2011 Federal Census data.
- ❖ The margin of error (MOE) for the total sample of 2,501 is  $\pm 2.0$  percentage points, 19 times out of 20.
- ❖ A total of 180 interviews were conducted with residents of Ward 7 (MOE  $\pm 7.3$ ).
- ❖ Throughout, City Wide results are compared to Ward results.
  - $\uparrow$  indicates number is significantly higher than City Wide.
  - $\downarrow$  indicates number is significantly lower than City Wide.

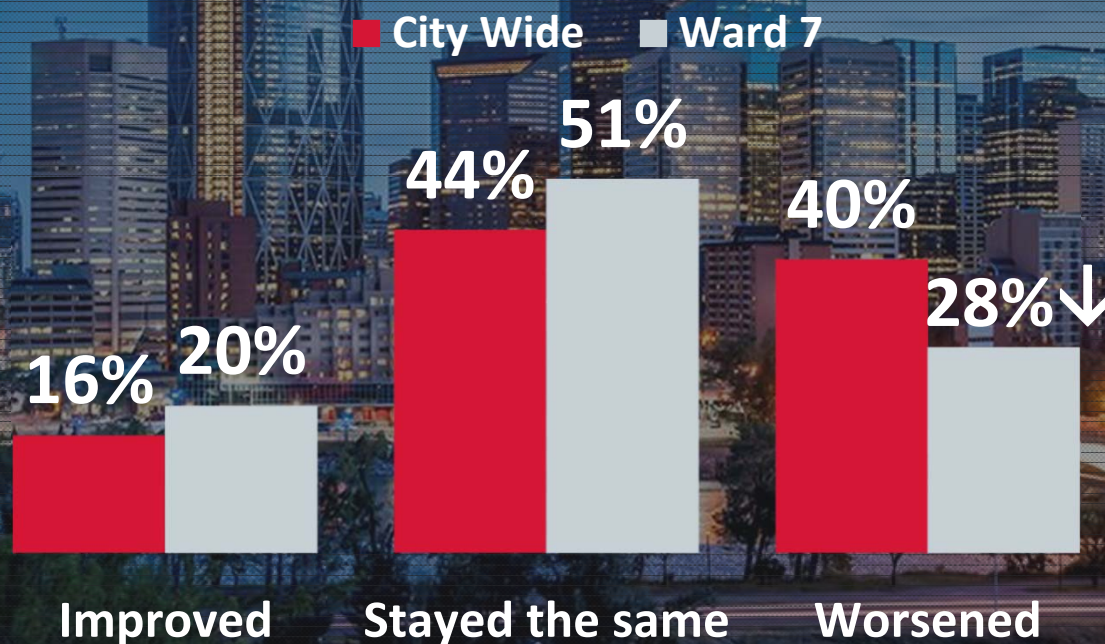
