### Background

#### Project Background

(What is happening and why is it being done?)

The Confederation Park Management Plan was created in 2011 to direct future work within the park. The plan contains information about the park's history, features and amenities. It guides the development of The City's annual work plans for the management and maintenance of the park.

In Spring 2016, Parks will begin implementing improvements to Confederation Park to honour Canada's 150<sup>th</sup> anniversary in 2017, when commemorative celebrations will be held in the park. The work aligns with the Confederation Park Management Plan.

#### Engagement Goals & Objectives

To incorporate citizen input, where possible, into selected improvement projects within the park.

These opportunities to participate will be coordinated with other proposed touchpoints (e.g. volunteer opportunities, memory/historical story collection) to the project.

In order to increase stakeholder and public accessibility to information and engagement opportunities, three in-person sessions are planned:

- February 2016: Information session informing citizens of work that will be completed in the spring 2016
- June 2016: Public engagement and information session that will be supplemented by an online suite of tools
- June 2016: Rosemont School engagement session that will be supplemented by an online suite of tools

Targeted stakeholders who may have unique considerations will be met with on an individual basis by Parks in advance of the public sessions.
